NOTICE OF AGREED WITHDRAWAL OF FORMAL PROCEEDINGS

TO THE HONORABLE THOMAS G. JONES, JUSTICE OF THE PEACE,
PRECINCT 1, PLACE 1, IN DALLAS, DALLAS COUNTY, TEXAS:

Pursuant to Tex. R. Civ. P. 162, this NOTICE OF AGREED WITHDRAWAL is hereby given to Thomas G. Jones, Justice of the Peace, Precinct 1, Place 1 in Dallas County, Texas, that formal proceedings against him have been withdrawn.

The parties have agreed to dismiss the Formal Proceeding without prejudice and return these matters for further proceedings before the Commission. The Commission approved this agreement by affirmative vote.

Accordingly, the Examiner hereby files this Agreed Notice, and withdraws these Formal Proceedings without prejudice. The Charges described in the Notice of Formal Proceedings are not being dismissed or otherwise closed, but are being referred back to the Commission for further review and possible action pursuant to Art. V., § 1-a(8) of the Texas Constitution, Tex. Gov't Code § 33.022(c), and Rule 6 of the Procedural Rules for the Removal or Retirement of Judges.




