#### **HOUSE VERSION**

SECTION 1. Subchapter A, Chapter 38, Education Code, is amended by adding Section 38.0041, POLICIES ADDRESSING SEXUAL ABUSE OF CHILDREN. Among other provisions, requires each school district to adopt and implement a policy addressing sexual abuse of children to be included in the district improvement plan.

No equivalent provision.

#### SENATE VERSION

SECTION 1. This Act shall be known as Jenna's Law.

SECTION 2. Same as Same as House version except requires each school district to include the policy in any informational handbook provided to students and parents, as well as in the district improvement plan.

SECTION \_\_. Establishes a task force to establish a strategy for reducing child abuse and neglect and improving child welfare in Texas. Sets forth the composition of the 15 member task force as follows: five members appointed by the governor, five members appointed by the lieutenant governor, and five members appointed by the speaker of the house of representatives.

Requires the members to be actively involved in the fields of the prevention of child abuse and neglect and child welfare, provides for the election of a presiding officer and for meetings, and exempts the task force from provisions regarding state agency advisory committees.

Sets forth the responsibilities of the task force in establishing its strategy, including gathering information concerning child safety, child abuse and neglect, and child welfare throughout Texas; reviewing the exemptions from criminal liability provided under the

Penal Code to a mother who injures her unborn child by using certain controlled substances during her pregnancy and examining the effect that repealing the exemptions will have on reducing the number of babies who are born addicted to a controlled substance; receiving reports and testimony from certain individuals and public and private agencies and entities; creating goals for state policy that would improve child safety, prevent child abuse and neglect, and improve child welfare; and submitting a strategic plan to accomplish those goals to the governor, lieutenant governor, and the speaker of the house of representatives.

Requires the task force to consult with employees of the Department of Family and Protective Services, the Department of State Health Services, and the Texas Department of Criminal Justice as necessary to accomplish the task force's responsibilities and authorizes the task force to cooperate as necessary with any other appropriate state agency.

Abolishes the task force and provides for the expiration of related provisions on September 1, 2011.

IN RE: HB1041 by Parker (relating to school district policies addressing sexual abuse of children and establishment of a state strategy to reduce child abuse and neglect and improve child welfare.), Conference Committee Report

#### No significant fiscal implication to the State is anticipated.

The bill would create a 9-member task force to establish a strategy for reducing child abuse and neglect and improving child welfare. The provisions relating to the task force would take effect on September 1, 2009 and would expire on September 1, 2011. It is assumed that any costs associated with the bill would be minimal and could be absorbed within available resources.

#### **Local Government Impact**

No significant fiscal implication to units of local government is anticipated.

Costs for school districts, in implementing the bill's requirement to develop and implement a policy addressing sexual abuse of children, are not expected to be significant.
