#### A BILL TO BE ENTITLED

SECTION 1. Section 42.002, Health and Safety Code, is amended by adding Subdivisions (3) and (4).

SECTION 2. Chapter 42, Health and Safety Code, is amended by adding Section 42.0047 to require a laboratory that performs a serum creatinine test on a sample from a person 18 years of age or older to also calculate and include in the reported results the person's estimated glomerular filtration rate.

Similar to House version, except (a) establishes that the laboratory's calculation and inclusion in the reported results of the person's estimated glomerular filtration rate is performed at the discretion of the physician and subject to the laboratory receiving along with the sample all relevant clinical information about the person necessary to calculate that estimated rate.

Same as House version, except adds as alternatives to calculating and including the person's estimated glomerular filtration rate in the reported results including the results of an alternative equivalent calculation measuring kidney function or performing an alternative equivalent calculation, and makes a conforming change. Adds a provision requiring a physician requesting a serum creatinine test to provide to the laboratory all relevant clinical information about the person necessary to calculate the person's estimated glomerular filtration rate or perform an alternative equivalent calculation unless the physician determines that the calculation is unnecessary. (The conference committee may have exceeded the limitations imposed on its jurisdiction, but only the presiding officer can make the final determination on this issue.)

No equivalent provision.

(b) Adds a provision exempting from the requirements of the section a laboratory that uses equipment to perform serum creatinine tests that cannot be reprogrammed to calculate the estimated glomerular filtration rate or a laboratory performing a serum creatinine test on a sample taken from a patient who is being treated in a hospital. Same as Senate version, except makes a change to conform to the performance of an alternative equivalent calculation measuring kidney function.
