## **№ New Board Members Appointed; Aikman and Fisher Depart**

In April, Governor Rick Perry appointed two new members to the Board. Joseph James Spano, PT (Wharton) replaces Cynthia Fisher, PT (El Paso). Joe Spano is Director of Comprehensive Therapy Services at Gulf Coast Medical Center, and holds a physical therapy degree from UTMB in Galveston. Joe was one of the first PTs licensed in Texas, already in practice in Texas when the Board was created in 1972. The Governor also appointed Patrice Dyson Jones of Grand Prairie to replace Harvey Aikman of Mission. Patrice, who graduated from Texas Women's University, has recently moved into the field of home health. The Board and staff welcome the new appointees and look forward to working with them.

Leaving the Board after more than seven years of service are Harvey Aikman and Cynthia Fisher. Both Harvey and Cynthia served terms as Board Chair during those years, and were actively involved with the Board's relationship with the Federation of State Boards of Physical Therapy. Board and staff will miss the energy and focus they both brought to their work with the Board, and wish them well in future endeavors.

### **№ Board Makes Changes to Committees**

At the July meeting, the Board abolished one committee and established another. The tasks of the Applications Review Committee, created originally to handle unusual license application issues, have been absorbed into other committees. Most of its work will now be done by the *Education Committee* (for any issues involving applicant education), with non-education issues going to the *Rules and Practice Committee*. The *Vision Committee* was created to lead the Board in its relationships with national entities (such as the Federation of State Boards of Physical Therapy), to monitor national practice and administrative issues, and to assist the agency's Executive Director with such efforts as the agency's Strategic Plan and Legislative Appropriations Request (LAR). (In addition to these changes, the Board changed the name of the Rules Committee to the Rules and Practice Committee, and also decided to appoint one public member to each committee whenever feasible.) The *Investigation Committee* continues unchanged.

### **№ Board Elections and Committee Appointments**

- (18) Kyle Griffin, PTA #2038800 (Midland) failed to cooperate with the board during audit of his CE taken to renew his license. Violation of §453.351 of the Act and Chapter 322 of the Board Rules. Board Order suspended his license indefinitely until he provides proof and it is verified that he completed the required CE to renew.

#### WHO'S IN CHARGE?

Are you a contract or traveling PT? Does your employer send you to different facilities to provide physical therapy services for limited periods of time? If you are working in a registered facility\*, there must be a "PT in Charge" of that facility – regardless of who actually employs the PT. The PT in Charge does not have to be present physically at the facility while you are providing services, but there must be a licensed PT on record with the Board\*\* as having "authority and responsibility for the facility's compliance with the Act and rules". Make sure your employer is aware of this, and works with you to determine who will act as the PT in Charge of the facilities you work in. If it is not you, who is it?

- \*\*Go to <a href="www.ecptote.state.tx.us/facility/forms">www.ecptote.state.tx.us/facility/forms</a> to download a copy of the Therapist in Charge Affidavit. To be on record with the Board as the Therapist in Charge, the PT must complete the form and have it notarized. All forms that require affidavits must be mailed to the Board, and cannot be faxed or emailed. The Board's address is on the first page of this newsletter.

- Q: Do I have to take 2 hours of <u>ethics/professional responsibility</u> EVERY time I renew? Can I take an approved course more than once?
- **A.** YES and YES. The Board's rule says that you must take an approved course on ethics/professional responsibility every two years. You can take any ethics course more than once, but you must take 2 hours of ethics during each renewal cycle. If you are audited for CE compliance, the Board will look at the date the course was taken, as well as the approval number. The course must be taken during the 2 year renewal period, or it will not satisfy the renewal requirements.
- Q: I work in more than one facility. Can I display a <u>duplicate of my license</u> in each facility?
- **A:** NO. The PT rules (§337.1) forbid hanging a second license or copy of a license, so you can't display a duplicate or a photocopy. Whether you work in two places or 20, here are the requirements: Hang your license (and the renewal certificate if you have one) in the facility where you work most often. Make photocopies of your license to keep on file in the other facilities. Carry your wallet-sized license or renewal certificate with you to provide identification if asked.
- Q: Can a PTA do <u>sharp debridement</u>?
- **A:** The Texas PT rules do not prohibit a PTA from doing sharp debridement. It is up to the supervising PT to make sure that a PTA has the competencies required to perform any treatment or modality, including sharp debridement. Remember, if you are the PT, the Board will hold you responsible for what your Plan of Care tells that PTA to do. If you are the PTA and you do not feel that you have been adequately trained to carry out a procedure, do not agree to perform it!
