# Texas Board of Nursing Bulletin

The mission of the Board of Nurse Examiners for the State of Texas is to protect and promote the welfare of the people of Texas by ensuring that each person holding a license as a nurse in the State of Texas is competent to practice safely. The Board fulfills its mission through the regulation of the practice of nursing and the approval of nursing education programs. This mission, derived from the Nursing Practice Act, supersedes the interest of any individual, the nursing profession, or any special interest group.



## Criminal History Record Checks Proceed for All Texas Nurses

During the 79th Regular Texas Legislative Session (2005), the approved legislative appropriations for the Board of Nurse Examiners added funding for conducting criminal background checks for criminal history audits of all licensed nurses over a 10 year period. House Bill 2208, passed during the 78th Regular Texas Legislative Session (2003), amended the Nursing Practice Act to include Sec. 301.3011, authorizing checks on all nurses. This means that every nurse will have a criminal history check at least once during the license renewal process between September 2005 and September 2015. The legislature has required that all individuals seeking to obtain or retain a Texas nursing license possess "good professional character"; therefore, the criminal conduct of nurses and those applying to be licensed must be reviewed.

Sec. 301.3011 of the Nurse Practice Act states:

- (a) The board may require that an applicant for renewal of an unexpired license submit to the board, in addition to satisfying any other requirements for license renewal, a complete and legible set of fingerprints, on a form prescribed by the board, for the purpose of obtaining criminal history record information from the Department of Public Safety and the Federal Bureau of Investigation.
- (b) The board may refuse to renew the license of a person who does not comply with the requirement of Subsection (a). Renewal of a license by the board is conditioned on the board obtaining the person's criminal history record information under this section.

Each month, a random selection of nurses who have recently renewed their license will be sent a notification of audit with a set of fingerprint cards. Each individual is responsible for returning the cards to the Board in a timely fashion as indicated in the notification instructions. Those reports indicating a criminal history will be referred to the Board's Enforcement Department for investigation.

At the regular meeting of the Board of Nurse Examiners (BNE) held October 20-21, 2005, Richard Gibbs, LVN, was elected Vice-President of the BNE. Richard Gibbs was appointed to the Board on March 22, 2004 by Governor Perry to represent LVN Practice for the Board. Mr. Gibbs lives and works in Mesquite as a staff nurse at Mesquite Community Hospital. He serves as an advocate for TPAPN and serves on numerous committees at his hospital. Mr. Gibbs' term on the BNE expires January 31, 2007.

Governor Rick Perry announced the appointment of Frank Sandoval, Jr., JD, to the Texas Board of Nurse Examiners (BNE) on March 22, 2004, together with eleven other appointees from the Board of Nurse Examiners (BNE) and the Board of Vocational Nurse Examiners (BVNE), which ceased to exist on February 1, 2004 (See Texas Board of Nursing Bulletin, April 2004). The twelve appointees, along with the thirteenth appointee to be named later, became the new combined Board of Nurse Examiners. Creation of the combined Board came about pursuant to passage of House Bill 1483, enacted during the 78th Regular Texas Legislative Session (2003). Mr. Sandoval joined the BNE after serving on the BVNE. He was appointed to the BVNE on January 8, 1999, reappointed on March 6, 2002 and served on the Board until February 2004.

## Summary of Actions

A Regular meeting of the Board of Nurse Examiners was held October 20-21, 2005 in Austin. The following is a summary of Board actions taken during this meeting.



vember 11, 2005 issue of the Texas Register with the comment period ending December 12, 2005:

Proposed 22 TAC § 213.30 relating to Declaratory Order of Eligibility for Licensure addressed requirements for initial licensure and the eligibility process. Proposed rule language addressed agency decisions made to deny eligibility for licensure in Texas. Comments were received and the Board will consider staff response to the comments during the January 2006 Board Meeting.

Amendments were proposed to 22 TAC § 216.3(7) Continuing Education, § 217.9 Inactive Status, and § 223.1 Fees. HB 2680, enacted during the 79th Regular Texas Legislative Session, requires adoption of rules providing for reduced fees and continuing education requirements for retired health care practitioners whose only practice is voluntary charity care. No comments were received for §§ 217.9 and 223.1, and the rules were published as adopted in the December 30, 2005 Texas Register. Comments were received on § 216.3(7) and staff response to the comments will be considered during the January 2006 Board Meeting.

Amendments were proposed to 22 TAC § 216.3(6) Continuing Education relating to forensic evidence collection by nurses in emergency departments. New language was proposed in response to passage of SB 39, enacted during the 79th Regular Texas Legislative Session. Comments were received during the comment period and the Board will consider staff response to the comments during the January 2006 Board Meeting. See articles on page six for further information.

Amendments were proposed to 22 TAC § 217.18, concerning Registered Nurse First Assistants, in the November 11, 2005 issue

The following proposed amendments were published in the No- of the Texas Register. Comments were received and the Board will consider response to comments during the January 2006 Board Meeting.

> The Board of Nurse Examiners proposed amendments to 22 TAC §221.3, concerning Advanced Practice Nurses. The amendments to §221.3 were adopted with changes to the proposed text as published in the November 11, 2005 issue of the Texas Register (30 TexReg 7354). Section 221.3 addresses the educational requirements for authorization to practice as an advanced practice nurse (APN) in the State of Texas. The amendments to Chapter 221 address many of the issues raised by past petitioners and are consistent with the decisions made by the Board relating to APN petitions. No comments were received to § 221.3 and the rules were adopted and published in the December 30, 2005 Texas Register.

> Amendments were proposed to 22 TAC §221.12, concerning APN Scope of Practice in the November 11, 2005 issue of the Texas Register. Comments were received and the Board will consider response to comments during the January Board Meeting.

> The Board of Nurse Examiners adopted amendments to §223.2, concerning Charges for Public Records. The amendments were adopted without changes as published in the November 11, 2005, issue of the Texas Register (30 TexReg 7356). The amendment to §223.2 was adopted due to the change in law by Senate Bill 727, enacted during the 79th Regular Texas Legislative Session. The authority for setting the fees for public records was transferred from the Texas Building and Procurement Commission to the Office of the Attorney General.

## NCSBN CONVENES PANELS OF EXPERTS TO STUDY CONTINUED COMPETENCE IN NURSING

The National Council of State Boards of Nursing (NCSBN) recently initiated practice analysis studies: one for post entrylevel registered nurses (RNs) and one for post entry-level licensed practical and vocational nurses (LPN/VNs). Designed to describe post entry-level nursing practice and delineate the interface between entry-level practice and continued competence in practice, NCSBN convened panels of experts, two for RNs and another for LPN/VNs, to develop nursing activity statements that will be used in the practice analysis questionnaires.

Throughout its 27-year history NCSBN has advanced the position that nurses must remain competent throughout their professional careers. To assist boards of nursing in addressing continued competence, NCSBN is spearheading an initiative to develop an assessment instrument to measure continued competence of RNs and LPN/VNs. This past summer NCSBN convened the panels of RN and LPN/VN subject matter experts who were drawn from a wide spectrum of nursing organizations representing major practice and specialty settings, education programs as well as geographic locations and major employing facilities. The panel members used their expertise to create a list of nursing activity statements that could be used to describe post entry-level practice.

Commenting on the importance of the task assigned to them, Panelist Candace Melancon, a LPN from Louisiana, remarked that "developing structured, consistent competencies (nursing activity statements) is crucial for the successful future of nurses."

Each of the panels worked to refine a list of nursing activities until they had developed a comprehensive list of nursing competencies that reflected post-entry level practice throughout the country. Shirley Fields-McCoy, MSN, RN, noted that "continued competency must be addressed to ensure that each nurse maintains and augments the necessary knowledge and skills to be current in practice. Representing my colleagues in the American Nurses Association has been an honor. Continued competence is a professional responsibility for all nurses who maintain their licensure."

The nursing professionals who will respond to the surveys will be asked to determine the importance of each of the activities listed in the post entry-level nursing activity statements. Data collection for the LPN/VN survey began in October 2005 with the collection process for RNs anticipated to begin in January 2006. All nurses receiving the survey are strongly encouraged to complete and return it as their participation in this study offers a unique opportunity to contribute to the nursing profession.

The National Council of State Boards of Nursing (NCSBN) is responsible for developing the NCLEX-RN<sup>®</sup> and NCLEX-PN<sup>®</sup> licensing examinations by utilizing contributions from nurse clinicians and educators. NCSBN encourages all nurses to become involved in the development of the exams by participating in the item (question) development program. Qualifications for participation are listed below.

Serving on an NCLEX<sup>®</sup> item writing or review panel is an excellent opportunity to network with nurses from across the country, contribute to continuing excellence in nursing practice, and build new skills that are useful for professional growth.

Item development sessions are held throughout the year and include the item writing and item review panels. Item writing panelists are responsible for creating new test items that may later appear on one of the exams. Item review panelists examine both newly created and older items to help decide if the items are current and relevant to entry-level nursing practice.

All item development panels are held in Chicago, Illinois, and generally last 3-4 consecutive days. Panelists stay downtown in a deluxe hotel surrounded by the shopping and theater districts. Most travel and food expenses are covered and new panelists receive more than 30 CEUs for their participation.

#### Did You Know...

House Bill (HB) 984, enacted during the 79<sup>th</sup> Regular Texas Legislative Session, amended the Health & Safety Code adding Chapter 168, mandating that public schools provide and train unlicensed diabetes care assistants (UDCAs). To assist school nurses in determining their role in the implementation of this bill, HB 984 *"Frequently Asked Questions"* and *"Quick Cards Review"* are now located on the BNE website, www.bne.state.tx.us, under *"Nursing Practice Information,"* and *"Practice Setting/Specialty Area Specific."* 

### Safety in Practice: Focus on Insulin

Insulin leads the list for both the most common medication reported in errors, as well as the medication most often linked to errors that resulted in patient harm. It is no surprise that Insulin is included on the list of "High Alert Medications"<sup>1</sup> as well as on the list of "Error-Prone Abbreviations"<sup>2</sup> by the Institute of Safe Medication Practices (ISMP). Maintaining client safety, knowing the rationale for and correctly administering medications, maintaining current knowledge relevant to a nurse's individual practice setting, and clarifying orders the nurse believes are inaccurate are a few of the basic standards of nursing practice applicable to all nurses in relation to Insulin [Rule 217.11(1)(B), (C), (N), and (R)].

Because the nurse in any setting typically interfaces with multiple aspects related to medication ordering and administration, the nurse may be in a unique position to not only prevent errors, but to recognize problems within the medication order-to-patientadministration cycle that may involve other departments and healthcare professionals. Thus, knowing where to look for bestpractice recommendations can be another crucial role for the nurse in any practice setting. Much of the evidence-based practice to date has been generated from the acute-care (hospital) arena; however, the lessons learned may be applicable regardless of practice setting.

As one example of evidence-based research available, the United States Pharmacopoeia recently released their 5<sup>th</sup> Anniversary Data Report tracking medication error findings and trends collected through MEDMARX (an internet-accessible, medication error reporting program). Published findings include a report called "Safe Use of Insulin in Hospitals" released by the American Society of Health-System Pharmacists and the Hospital and Health-System Association of Pennsylvania (http://www.ashp.org/emplibrary/Safe\_Use\_of\_Insulin.pdf).

### Nursing Practice Advisory Committee Examines Minor Incidents

In October 2005, the Board charged the Nursing Practice Advisory Committee (NPAC) to review and recommend revisions to 22 TAC § 217.16 concerning <u>Minor Incidents</u>. The purpose of this rule review was to clarify what constitutes a minor incident and when a minor incident need not be reported to the Board.

NPAC members met on November 18, 2005, to discuss possible revisions to the current rule. Proposed rule language will be submitted to the Board when it meets in January. If approved by the Board, the proposed rule changes will be published in the *Texas Register* within a few weeks following the Board meeting for a 30-day public comment period. # Board Considers Rule Changes Relating to Voluntary Charity Care and Forensic Evidence Collection

### Volunteer Retired Nurse Authorization Rules Enacted

House Bill 2680 (HB2680) (2005) amended Texas Occupations Code §112.051 establishing a requirement for regulatory agencies that license healthcare practitioners (including the BNE) to "adopt rules providing for reduced fees and continuing education requirements for retired health care practitioners whose only practice is voluntary charity care." As a result of this new statute, the Board proposed rule amendments to the following rules in the November 11, 2005, issue of the *Texas Register*:

§ 216.3(7) Continuing Education Requirements for Retired Nurses Providing Only Voluntary Charity Care

- § 217.9 Inactive Status. New subsection (d) Volunteer Retired Nurse Authorization
- § 223.1 Fees. Amendments to subsection (17) Licensed Vocational Nurse, Retired; Registered Nurse, Retired; Volunteer Retired Vocational Nurse (VR-VN); Volunteer Retired Registered Nurse (VR-RN); Volunteer Retired Registered Nurse with qualifications in a given advanced practice nurse role and specialty (e.g., VR-RN, FNP)

No comments were received to §§ 217.9 and 223.1. These rule amendments became effective January 2, 2006.

A nurse who meets the requirements under the Nursing Practice Act (NPA) (§301.261) of being at least 65 years old and wishes to place his/her nursing license on "inactive status" may request this new *authorization* to function as a "volunteer retired nurse"

for the purposes of providing voluntary charity nursing care in collaboration with a charitable organization. A "charitable organization" is defined in Section 84.003 of the Texas Civil Practice and Remedies Code *and in 22TAC* 217.9(d)(5).

Key points of the new rule amendments pertaining to volunteer retired nurse authorization include:

- 1. The LVN, RN, or RN with Advance Practice Nurse (APN) authorization in an advanced practice role and specialty holds an "authorization" to function as a volunteer retired nurse only-an authorization is <u>not</u> a nursing "license."
- 2. The nurse must provide only voluntary charity care as defined in the rule.
- 3. LVNs and RNs need only obtain 10 hours of Continuing Education (versus 20) every biennium; RNs who are advanced practice nurses need to obtain 20 hours of continuing education (targeted to their advanced practice role and specialty)(this is the same as for licensed RNs w/active APN status). The volunteer retired APN, however, does not need to have 400 hours of advanced practice each biennium nor is it necessary for the APN to retain national certification in his/her educated APN role and specialty.
- 4. The volunteer retired nurse authorization must be renewed every two years. Renewal dates are based on the nurse's birth month and year, the same as licensure renewal dates. The fee for renewal is ten (\$10) dollars.

#### **Proposed Forensic Evidence Collection Rule Receives Comments**

The proposed amendment to Rule 216.3(6) relating to continuing education requirements for nurses whose practice settings include the emergency department (ED) was published in the *Texas Register* on November 11, 2005 for a 30-day comment period.

This rule amendment was proposed to establish requirements for compliance with Senate Bill 39 (SB39)(2005) that added Nursing Practice Act (NPA) Section 301.306, *Forensic Evidence Collection in Continuing Education*.

A comment was received to § 216.3 (6), so this amendment will be considered at the January Board Meeting. The earliest date for auditing a nurse's license for compliance with this CE requirement will be September 2008. Responses to comments received along with adopted rule language may be viewed in its entirety in the *Texas Register* at http:// www.sos.state.tx.us/texreg/index.shtml after the January Board Meeting. Current and proposed Board rules are also accessible on the BNE web page.

Though the original bill introduced to the Texas Legislature focused on the forensic area of sexual assaults, the final bill language and subsequent statute address "forensic evidence collection" broadly. Nurses whose practice settings include the ED are encouraged to seek forensic CE offerings that are most relative to the types of patients seen in the nurse's clinical practice.

Additional information on SB39 is located in the *Texas Nursing Bulletin* (October 2005; page 3). Archived issues are accessible on the BNE web page. "Frequently Asked Questions" (FAQs) on this new CE requirement will be listed on the Board's web page under "Nursing Practice Information" and then under "Continuing Education" once the Board has adopted this rule amendment.

### Fitness to Practice: Impact of Mental Health Conditions and Criminal Background on Nurse Licensure

A nurse's ethical conduct as well as mental and physical fitness to practice continue to draw the attention and concern of our state legislators. The 79<sup>th</sup> Texas Legislature (2005) passed a number of bills strengthening current and/or adding new laws relating to fitness to practice requirements, including broader criminal background checks on nurses and nursing candidates for licensure. The October 2005 *Texas Nursing Bulletin* as well as the article on page one of this edition lists some of the new laws\* impacting the ability to obtain or retain a nursing license based on a person's criminal background. Though not a focus of the most recent legislative session, statutes involving licensure of persons with certain mental health issues and/or chemical dependency have been part of the Nursing Practice Act (NPA) and Board of Nurse Examiners' (BNE) rules for a number of years.

A person's past and ongoing history regarding certain mental and physical health conditions, chemical dependency, and/or criminal background are all relevant to the practice of nursing because a nurse must be able to demonstrate both "good professional character" as well as "current sobriety and fitness to practice." Why are good professional character and mental/physical fitness to practice so important for a nurse? The practice of nursing involves clients, their families, significant others and the public in diverse settings. Registered and vocational nurses may practice in autonomous roles with individuals who are physically, emotionally, and financially vulnerable. The nurse has access to personal information about all aspects of a person's life, resources, and relationships. The nurse's ability to discern changes in client status and take appropriate and timely action may alter client outcomes between life or death. In light of these factors, a person who lacks the qualities necessary to consistently act in the best interest of clients, and/or whose judgment may be impaired because of mental or physical illness or intemperate use of alcohol or other substances, may not be capable of being a safe practitioner.

As the Board's mission is to protect the health and welfare of the public through the regulation of nursing in Texas, the Board has a duty to obtain and review information relevant to good professional character and fitness to practice for each licensed nurse or candidate. This process begins with eligibility questions that help identify whether or not a person possesses the characteristics necessary to meet these requirements. The same eligibility questions are found on all BNE applications for persons seeking to obtain/retain licensure by examination, endorsement, or renewal as either a LVN or RN (including RNs with APN authorization) in the State of Texas. To view the eligibility questions in their entirety, go to the "Forms" section of the BNE web page and click on the licensure application you would like to view or print.

As noted at the beginning of this article, the Texas Legislature is responsible for revising statutes that make up the NPA on a biennial basis. Both the NPA (Chapters 301, 303, and 304 of the Texas Occupations Code [TOC]) and various other Texas statutes give the Board its authority to require disclosure of certain health conditions and criminal background checks for persons seeking to obtain or retain a nursing license. For example, Section 411.125 of the Texas Government Code (Department of Public Safety) provides the Board of Nurse Examiners with authority to access criminal history record information. The Board also has the authority to deny licensure to candidates or nurses who refuse to fully disclose conditions that might impact the Board's decision to license any person as a nurse.

TOC Chapter 301 (NPA) contains most of the relevant statutes relating to eligibility and disciplinary matters. Some NPA sections of interest in relation to mental health, chemical dependency and/or criminal background checks include:

- §301.1615 Obtaining Criminal History Record Information; Hearing\*
- §301.252 License Application
- §301.257 Declaratory Order
- §301.3011 Criminal History Record Information Requirement for Renewal [see article on front page]\*
- §301.452 Grounds for Disciplinary Action
- §301.4535 Required Suspension, Revocation or Refusal of License for Certain Offenses\*

The Board is required to develop or amend rules to implement requirements established by the Legislature in the NPA. The main rules that set forth the Board's requirements for ethical conduct as well as mental and physical fitness to practice nursing include:

- §213.27 Good Professional Character
- §213.28 Licensure of Persons with Criminal Convictions
- §213.29 Criteria and Procedure Regarding Intemperate Use and Lack of Fitness in Eligibility and Disciplinary Matters
- §213.30 Declaratory Order of Eligibility for Licensure
- §213.31 Cross-reference of Rights and Options Available to Licensees and Petitioners

Additional rules applicable to licensed nurses only include 22 Texas Administrative Code (TAC) §217.11, Standards of Nursing Practice, and §217.12, Unprofessional Conduct.

<u>Mental Health Conditions/Chemical Dependency</u>: With regard to mental health conditions, a person seeking a nursing license must disclose if s/he has been diagnosed with, treated, or hospitalized within the previous five years for schizophrenia and/or psychotic bipolar disorder, paranoid personality disorder, antisocial personality disorder, or borderline personality disorder. In addition, if a person seeking licensure has been addicted to and/or treated for the use of alcohol or any other drugs within the previous five years, this must also be disclosed to the Board. A nurse holding a valid current Texas nursing license must verify that they have not been diagnosed with and/or been treated for these disorders in the past two years "since the last renewal period." A licensed nurse who has completed or is in compliance with requirements of the Texas Peer Assistance Program for Nurses (TPAPN) at the time of licensure renewal may answer "no" to this eligibility question.

Given the Board's mandatory reporting requirements [\$217.11(1)(K)], staff is often asked if this applies when a nurse who is "under the influence" is admitted to a hospital or treatment facility as a patient. If the nurse is a patient, confidentiality of treatment laws apply, and the nurse is not Board reportable. (See "Drug Use by Nurses" under the "Nursing Practice Information" section of the BNE web page for

#### **Guidelines Adopted to Assist Advanced Practice Nurses with Scope of Practice Issues**

nurses are frequently complex. Board staff receives a large number of inquiries regarding scope of practice for advanced practice nurses from a variety of entities, including but not limited to employers, other health care providers, third party payers, and the public. Additionally, staff fields a number of questions from advanced practice nurses who desire to expand their scopes of practice into other areas. An example of this type of situation is the advanced practice nurse prepared in a primary care specialty who wishes to provide services in an acute care setting.

Rule 221.12 of the Board of Nurse Examiners' Rules and Regulations Relating to Nurse Education, Licensure and Practice, addresses the advanced practice nurse's scope of practice. The rule indicates that the Board recognizes the statements relating to professional scope of practice and standard of care for a particular role and specialty that are developed by professional specialty organizations at the national level. Advanced practice nurses may provide those services and perform only those functions that are within that scope of practice and that are consistent with the Nursing Practice Act, Board rules, and other laws and regulations of the State of Texas. Board staff continually refers individuals to these statements for information regarding the scope of practice of a particular category of advanced practice nurses. Despite the statement in the rule and staff's referrals to professional organizations, board staff receives numerous requests for scope of practice statements from the Board.

The Board charged the Advanced Practice Nursing Advisory Committee (APNAC) with researching scope of practice for advanced practice nurses and reporting back to the Board. At its October 2005 meeting, the Board reviewed the work of the APNAC and adopted guidelines that address both the advanced practice nurse's scope of practice as defined by the profession as well as his/ her individual scope of practice. The Board recognizes that although

The scope of practice issues encountered by advanced practice advanced practice nurses are educated in the full scope of a particular advanced practice role and specialty, they may elect not to practice the full scope of that role and specialty. For example, a family nurse practitioner (FNP) is educated to provide advanced practice nursing care to patients across the lifespan; however, an individual FNP may choose to limit the services he provides to adult patients only. Although he is educated in the full scope of his role and specialty, he has chosen not to practice the full scope of the FNP. The guidelines address how situations such as this are factors in determining an individual advanced practice nurse's scope of practice.

> The Board also recognizes that nursing practice at any level of licensure is dynamic in nature and changes. New medications, new technology, and new procedures continuously impact the standard of care. Like all nurses, advanced practice nurses must have mechanisms to incorporate new procedures and patient care activities into their scopes of practice; therefore, the statement also addresses limited expansion of scope of practice to include such activities. It is important to note, however, that there are finite limits to expansion of scope of practice without completing additional formal education. Advanced practice nurses cannot change their legally recognized titles or designations through experience or continuing education; these changes may only be achieved through additional formal educational preparation and meeting all legal requirements to use that title and practice in that specialty set forth by the BNE.

> In addition to the guidelines, the APNAC also developed a set of frequently asked questions (FAQs). The FAQs are intended to provide examples to help the reader apply the concepts discussed in the guidelines. The FAQs are based on scope of practice inquiries received by board staff. Both the guidelines and FAOs are available on the advanced practice information page of the BNE web site www.bne.state.tx.us/gen-apn.htm.

Criminal Background: As with mental health and chemical dependency issues, the Board considers criminal actions, whether violent or non-violent, directed against persons, property or public order and decency as highly relevant to an individual's fitness to practice nursing. The types of crimes and criminal dispositions are explained in both Board Rules and application instructions. Some of the most frequent issues that arise in relation to criminal background checks are as follows:

• DUIs, DWIs, and PIs must be reported and are not considered "minor traffic violations";

• Criminal actions are not limited to "convictions." Deferred adjudications with or without prejudice of guilt and expunged cases, for example, must also be revealed. Though the court's final action may not viewed by the court as a "conviction," the Board's concern in such cases is the underlying conduct to an unadjudicated or probated sentence. Review of Rules §213.27 and §213.28 relate to Board actions concerning persons with positive criminal backgrounds. TOC Chapter 53, "Consequences of Criminal Conviction," also relates to licensure of nurses and/or candidates for nurse licensure. (A link to this statute is located on the BNE web page with the NPA and Rules.)

• A person's criminal background can be a bar to licensure; however, each case must be investigated and an eligibility determination made on a case-by-case basis, utilizing the requirements set forth in the NPA and Rules. It is unlikely a candidate will be deemed eligible for a license if they are currently on probation or community supervision for a felony crime.

The NPA and Board rules require that all criminal conduct beyond a minor traffic violation be disclosed to the Board. For more information on licensure eligibility issues, refer to the Board's Disciplinary Sanction Policies (4 total) on Fraud, Theft and Deception, Lying & Falsification, Sexual Misconduct, and Chemical Dependency. ## **TAWHNEE MONDY** a.k.a. Tawhnee Lee Pruzzo Mondy a.k.a. Tawhnee Lee Pruzzo

Tawhnee Lee Mondy secured employment as a licensed vocational nurse (LVN) with a physician's group in Dallas, Texas, on April 5, 2005. Ms. Mondy accepted the position of LVN and wore a badge which identified her as a LVN. The employer requested a copy of Ms. Mondy's license and Ms. Mondy made several excuses why it was not available. The employer attempted to verify the license on the Board's web site and found no record of Ms. Mondy having a license to practice vocational nursing in the State of Texas. Ms. Mondy was told that she could not return to work until she brought a copy of her license for verification. Ms. Mondy was terminated from employment on June 15, 2005, and reported to the Board. The case was referred to the Dallas County District Attorney's Office, Dallas, Texas.



# CHRISTINA ARMSTRONG

#### a.k.a. Tina Armstrong

Christina Armstrong secured employment as a registered nurse with a third-party pharmaceutical company in Dallas, Texas, on December 29, 2004. Ms. Armstrong identified herself as Christina "Tina" Armstrong and transferred to a telephone position with the company on March 30, 2005. On April 15, 2005, the supervisor gave Ms. Armstrong a written warning for deficient documentation and at the same time the facility received the Board's Newsletter in which Ms. Armstrong was listed in the Imposter Warning. The employer attempted to verify the license number, which Ms. Armstrong provided on the Board's web site and it came back with another individual's name. Ms. Armstrong was immediately suspended while the investigation was under way. Ms. Armstrong denied any violation and stated that there was some misunderstanding. She told them that she had sent an overnight delivery to the Board for a name change and the Board was sending her a clear license within thirty (30) days. The employer terminated Ms. Armstrong's employment. The facility verified that Ms. Armstrong did not have any hands-on interaction with patients, other than telephone contact, and there was no injury to any patient. The Dallas County



District Attorney's office is already working on a case involving previous practice as a RN by Ms. Armstrong, including a felony offense for tampering with a RN License. The Board has referred this case to the Dallas County District Attorney's Office, Dallas, Texas.

# LUCINDA LEE LIDDY

#### a.k.a. Cindy Liddy

Lucinda Lee Liddy secured employment as a Registered Nurse/Risk Management Specialist with an insurance services company in Austin, Texas on October 15, 2003. Ms. Liddy used business cards that identified her as a RN/Risk Management Specialist and sent out letters with RN after her name. Ms. Liddy represented herself to her employer and clients as a RN. During preparation for an audit, the employer was unable to verify Ms. Liddy's RN license on the Board's web site. The employer confronted Ms. Liddy and requested that she present a copy of her Texas RN license. Ms. Liddy admitted that she was not licensed in Texas and stated that she was previously licensed in Oklahoma. Verification attempts with the Oklahoma Board of Nursing revealed that Ms. Liddy resigned her position on August 24, 2004. When asked why she did it, Ms. Liddy replied: "I really wanted the job. I lied and I got caught." The Board referred this case to the Travis County District Attorney's Office, Austin, Texas.

## **IMPOSTER WARNING**

#### NANCY TERINA HILL a.k.a. Nancy Terina Gutierrez

Nancy Terina Hill secured employment as the Director of Nursing with a long term care facility in Mesquite, Texas, on May 25, 2004. Ms. Hill presented a registered nurse license at the time of hire; however, the copy disappeared from her personnel file. The employer found out that law enforcement was looking for Ms. Hill for the offense of "Theft of Funds" involving social security checks. The employer helped set up Ms. Hill's arrest at the facility in September 2004. The employer verified that Ms. Hill was convicted and sentenced to six (6) years in the Federal Prison in Carswell. In June, 2005, the Board also received information from a licensee stating that she believed someone in the Dallas area was using her license number and social security number. The licensee was getting collection requests for bills she had not incurred. The licensee reported that she has never worked in the Dallas area and for the past two years she has lived and worked in Austin, Texas. Ms. Hill used the licensee's information to purchase a vehicle and the licensee found out that this imposter had worked for one year at a nursing home using her information and license number. The licensee contacted the police and reported the identity theft. The Board has referred this case to the Dallas County District Attorney's Office, Dallas Texas.

The citations in effect at the time the violation(s) occurred are the citations listed in the column. If a citation referenced does not appear in the current Nursing Practice Act or Rules and Regulations, it may be a citation that was repealed and recodified by the Legislature or a BVNE rule that was repealed and adopted in the current BNE rules after the violation occurred. # **Practice Question and Answer**



## GNs, GVNs, and Newly Licensed Nurses Practicing in Independent Settings

Q: I will be graduating from a vocational nurse training program in a few months, and am beginning to scope out my employment options once I graduate. I am attracted to the area of home health nursing, and I wondered if LVNs can work in home health settings? (Note: The same answer applies to graduates of registered nurse training programs).

First, when you graduate from your vocational training program, you will likely be eligible for a temporary permit to practice as a Graduate Vocational Nurse (GVN). Board Rule §217.3 prohibits GVNs (as well as Graduate Nurses [GNs] who complete registered nurse training) from working in "independent practice settings," which includes home health settings, regardless of if the GN or GVN is under direct supervision.

Once you receive confirmation from the BNE that you have passed your NCLEX-PN<sup>®</sup> (or NCLEX-RN<sup>®</sup>) licensure exam, you will be entitled to hold yourself out as a Licensed Vocational Nurse (LVN) or Licensed Registered Nurse (RN) as applicable, with all of the privileges and responsibilities that go along with each license. Though the Board cannot prevent a newly licensed LVN or RN from practicing in a home health environment, the Board strongly discourages newly licensed nurses from accepting employment in any independent living environment setting until the new nurse achieves twelve (12) to eighteen (18) months of nursing experience in an acute health care setting (such as a hospital). The Board believes that the newly licensed nurse (LVN or RN) needs adequate time to apply newly learned nursing knowledge and clinical skills, as well as time to develop clinical judgment and decision-making skills. Further, the Board believes that this process occurs most effectively in a structured health care environment where resources and supervision are immediately available to the new nurse. Once licensed, you are required to "know and comply with" the Nursing Practice Act (NPA) and Board Rules, as the content of each has the force of law with regard to nursing practice in Texas. The NPA and rules may be viewed in their entirety on this site. The main rule applied to nursing practice is Rule 217.11 Standards of Nursing Practice. Two of the main standards that apply to practice issues require the nurse to always maintain client safety [standard (1)(B)] and to accept only those assignments that are commensurate with the nurse's education, licensure, experience, and abilities [standard (1)(T)]. If a newly-licensed nurse decides to work in home health, and is subsequently reported to the Board for possible violations of the Board Rules, the nurse would likely be asked to explain his/her rationale for accepting employment in a home health setting, particularly when the Board expressly cautions new nurses regarding doing this very thing.

## **Insufficient Funds**

As of January 2, 2006, the following nurses appear on the records of the Board of Nurse Examiners as debits for failure to respond to notices of returned checks. Should any of these nurses be employed or seeking employment with your agency/institution, please contact the Board's office. If any of these nurses are practicing in Texas as a nurse, they may be in violation of the Nursing Practice Act and may be subject to disciplinary action by the Board.

### Licensure Verification Information Available 24/7 for Nurse Administrators/Employers

All vocational nurses, registered nurses and registered nurses with advanced practice authorization shall ensure the verification of current Texas licensure or other compact state licensure privileges and credentials of personnel for whom the nurse is administratively responsible, when acting in the role of nurse administrator [22 TAC §217.11(1)(V)]. Nurse administrators/employers hiring registered nurses, licensed vocational nurses, or advanced practice nurses can check the licensure status of nurse applicants through the Board of Nurse Examiner's web site at: https://www.bne.state.tx.us/olv/olverif.htm. This service is available 24 hours a day, seven days a week.
