# Texas Board of Nursing Bulletin

The mission of the Board of Nurse Examiners for the State of Texas is to protect and promote the welfare of the people of Texas by ensuring that each person holding a license as a nurse in the State of Texas is competent to practice safely. The Board fulfills its mission through the regulation of the practice of nursing and the approval of nursing education programs. This mission, derived from the Nursing Practice Act, supersedes the interest of any individual, the nursing profession, or any special interest group.



## **BNE Implements Legislation Passed by 79th Regular Texas Legislative Session**

The 79th Regular Texas Legislative Session ended on May 30, 2005. The Board of Nurse Examiners (BNE) is currently responding to passage of bills impacting the Nursing Practice Act, Agency Rules and Regulations and agency operations. Bills of significance passed into law included:

- SB 1000, amended the definition of "vocational nursing" adding more detail (scope of practice for LVNs) and parallel format with definition of "professional nursing"; clarified that a nurse's conduct is reportable to BNE only when the conduct creates an unnecessary risk of harm to patient; clarified relationship between employer reporting and conducting of nursing peer review when a terminated nurse elects not to participate in peer review; and made the Nurse Licensure ` Compact permanent in Texas.
- HB 1366, expanded the BNE's authority to investigate criminal charges against nurses through establishment of a criminal investigations unit, allows the BNE to consider deferred adjudication when considering candidates applying for nurse licensure, and adds a list of offenses which require suspension, revocation or denial of licensure.
- HB 1718, further defines a nurse first assistant, and establishes duties and requirements of nurse first assistants.
- SB 39, adds the requirement to obtain continuing education on forensic evidence collection for nurses working in emergency room settings.
- HB 2680, calls for reduced fees and continuing education requirements for a retired health care practitioner whose only practice is voluntary charity care.
- SB 132, addresses the nursing shortage and takes steps to increase enrollments in nursing schools. The Texas Legislature has committed more than 11 million dollars over the next biennium to be used towards reducing the nursing shortage in Texas.

The BNE will take an in-depth look at all legislation passed in the 79th Session in the October edition of *The Bulletin*.

### **Notice of Public Hearing**

The Board of Nurse Examiners (BNE) is holding a public hearing on July 20, 2005 to obtain stakeholder feedback in advance of agency review by the Sunset Commission, which will take place during the 2006-2007 biennium. In advance of the review, the Board is preparing a Self-Evaluation Report (SER) to be submitted to the Commission. The SER is designed to provide the Sunset Commission members and staff with a general background description of each agency being reviewed. The SER also gives each agency an opportunity to provide the Commission with a preview of issues and suggested improvements regarding the agency and its functions.

This hearing will take place on July 20, 2005, from 2:00 p.m. to 4:00 p.m., in Tower Two, Room 225, in the William Hobby Building located at 333 Guadalupe, Austin, Texas.

The BNE will accept comments in writing in lieu of appearing at the public hearing. Comments may be submitted by e-mail, fax or mail. Written feedback will be discussed at the public hearing on July 20<sup>th</sup>. E-mail responses should go to <u>Patricia.Vianes-Cabrera@bne.state.tx.us</u>. ## **New Programs Result in Fee Increases**

Regulatory agencies in Texas are funded by fees they generate through their various licensure programs. Every two years the Legislature adopts a budget for the following biennium. Agencies are required to submit a budget request prior to the session. If adopted, those requests as well as other bills that may have fiscal impact, result in an increase in fees to raise the additional revenue needed to fund these initiatives.

During the 2005 Legislative Session, the approved budget bill added funding for conducting criminal background

checks for initial licensure of LVNs and criminal history audits of all nurses over a 10 year period. This means that every nurse will have a criminal history check at least once during the license renewal process between September 2005 and September 2015. The Board implemented criminal background checks for initial licensure of RNs in 2003 when it was authorized and received funding for this purpose. The positive criminal history rate for this group is approximately 11%. The criminal background checks are provided by the Texas Department of Public Safety (DPS) and the Federal Bureau of Investigations (FBI). The money approved for these programs will pay fees charged by these two agencies as well as fund additional employee positions in the agency to review and process this information.

The Legislature also approved additional funding of the Texas Peer Assistance Program for Nurses (TPAPN), the program which the Board contracts with to provide assistance to nurses with chemical dependency and certain mental health problems. This program has not received any additional money for the past six years. In fact, when the Board was required to reduce its budget during the last biennium, this program's funding was reduced. TPAPN provides a valuable service to the Board and the public by assisting nurses to get the help they need and to continue practicing while being monitored.

Additional funds must be raised to support the BNE state employees pay increase beginning in September. State employees have not received pay increases since 2001.

I know it is never popular to announce fee increases, but these are necessary to fund the work of licensing boards. These increases will take effect in September. The proposed fee increases are currently published in the *Texas Register* and the Board will consider action on this rule at its July 21-22, 2005 meeting.

### Summary of Actions

A Regular meeting of the Board of Nurse Examiners was held April 21-22, 2005 in Austin. The following is a summary of Board actions taken during this meeting



Rules 221.2 and 221.7, pertaining to Advanced Practice Nurse Titles, were published in the May 6, 2005 issue of the Texas Register (30 TexReg 2668) and went into effect May 15, 2005.

The following proposed rule changes were published in the May 13, 2005 issue of the Texas Register.

Proposed amendments to Sections 214.2, 214.3, and 214.9, concerning Vocational Nursing Education were published as proposed (30 TexReg 2822). No significant comments were received and the rules will be published as adopted in the July 8, 2005 edition of the Texas Register to become effective July 10, 2005.

Proposed amendments to Sections 215.6 and 215.7, Professional Nursing Education were published (30 TexReg 2823). Comments were received and are being reviewed by the Education Liaison Committee for the Board.

Proposed amendment to Section 217.6, Failure to Renew License, was published (30 TexReg 2824). No significant comments were received and the rule will be published as adopted in the July 8, 2005 issue of the Texas Register to become effective July 10, 2005. New Chapter 227, relating to Pilot Programs for Innovative Applications to Professional Nursing Education was published as proposed (30 TexReg 2825). No comments were received, and the rule was published as adopted in the July 1, 2005 issue of the Texas Register, and became effective July 5, 2005. The Request for Proposals was also published in the July 1, 2005 issue.

The proposed repeal and adoption of new § 223.1, Fees, was published in the June 17, 2005 issue of the Texas Register (30 TexReg 3509) with the comment period ending on July 18, 2005. Staff published this rule pursuant to the recently enacted State of Texas appropriations bill, Senate Bill 1. Adoption of the rule is subject to approval of the Board at the regularly scheduled meeting of the Board on July 20-21, 2005.

## Department of State Health Services (DSHS) Requests Stakeholder Input for Improving and Preparing for Expansion of Newborn Screening (NBS) in Texas

Are you involved with Texas' newborn screening program? If so, please be on the lookout for a survey. Currently, each year in Texas approximately 375,000 infants are born and a total of 750,000 screens are done within their first two weeks of life to identify potential disorders that with treatment can improve health outcomes. Every year approximately 10,000 abnormal screens are identified and require some level of follow up.

Currently, legislation as well as DSHS plans anticipate expanding the number of disorders that are screened. In anticipation of these efforts, the DSHS invited the National Newborn Screening and Genetic Resource Center (NNSGRC) to conduct a technical review of the DSHS Newborn Screening Program (NBS). The review was held from February 28<sup>th</sup> to March 2<sup>nd</sup>.

The NNSGRC provides technical reviews to states through a cooperative agreement between the federal Maternal and Child Health Bureau Genetic Services Branch of the Health Resources and Services Administration (HRSA) and the University of Texas Health Science Center at San Antonio

Department of Pediatrics. Eight professionals from across the country, including representatives from HRSA and the Centers for Disease Control and Prevention, conducted the review and held internal and external stakeholder meetings in Austin, Houston, San Antonio, and Dallas. Approximately 51 external stakeholders, representing 20 unique interest groups participated.

DSHS received the draft consultation NNSGRC report on April 20, 2005. The draft provides comments from the team and stakeholders, responses to specific questions, and recommendations for enhancing newborn screening in Texas. DSHS staff has initiated a project to review the report and make appropriate recommendations to improve services provided to infants born in Texas.

As one of the mechanisms to fulfill this project's goal, DSHS is seeking additional stakeholder input in the form of survey responses to specific considerations raised in the report. The department is attempting to contact all types of professionals who interface with NBS, whether as a specimen collector, physician or nurse following up on abnormal screens, a provider doing confirmatory testing and/or treating these infants, or someone involved in locating families and explaining the screening that is done and the importance of follow-up. ## Taxonomy of Error, Root Cause Analysis and Practice - TERCAP Board of Nurse Examiners Participates in National Initiative

The Board of Nurse Examiners (BNE), in conjunction with the National Council of State Boards of Nursing (NCSBN) is participating in the Practice Breakdown Research Advisory Panel to develop new knowledge about the causes of nursing errors or practice breakdown. Boards of Nursing possess a rich source of data that can be used to identify sources of nursing error and thus are well positioned to add to the body of knowledge surrounding this aspect of health care error.

Working with consultant Dr. Patricia Benner, NCSBN is developing an audit instrument from pilot cases taken from several state boards of nursing. This instrument is called *TERCAP - Taxonomy of Error, Root Cause Analysis and Practice Responsibility.* The goal of the project is to learn from the experiences of nurses who have had episodes of practice breakdown and to review characteristics involving the nurse, the healthcare team and the organizational system. The overall aim is to promote patient safety by better understanding nursing practice breakdown and by improving the effectiveness of nursing regulation in protecting the public.

The Practice Breakdown Research Advisory Panel's study goals are to:

- To Articulate errors by developing language to describe what boards of nursing are finding in practice breakdown cases
- Link data about errors with identified characteristics
- Link data about errors with identified patient outcomes
- Test these relationships

The Practice Breakdown Research Advisory Panel believes that utilization of TERCAP will promote the following activities for nursing regulation:

- Encourage the use of TERCAP by board investigators
- Identify risk factors for practice breakdown
- Collaborate with nursing educators to identify areas for improving education
- Collaborate with nursing service administrators to identify high risk situations and develop safeguards
- Facilitate proactive regulation before harm occurs rather than waiting for problems to be reported

A BNE staff member joined the NCSBN's Research Advisory Panel in July 2004. In early 2005, the Panel issued a call to all Boards of Nursing asking them to participate in a study to test the TERCAP tool. Results of this pilot are being compiled at NCSBN.

A related issue that has surfaced in the patient safety literature is that of nursing fatigue and the possibility of its relation to patient care errors. This issue is currently being reviewed by the Texas Nurses Association. BNE staff have begun collecting information about the number of hours worked by nurses who are under investigation for practice breakdown. This information will be compiled and reported once adequate data has been collected.

## Adoption of Revisions to Rule 221.2 and 221.7, relating to Advanced Practice Titles

At its April 2005 meeting, the Board voted to adopt amendments to Rules 221.2 and 221.7, relating to advanced practice titles. The amended rule language proposed in February 2005 includes a list of titles the Board will recognize for legal entry into advanced practice as well as a list of additional titles that may be recognized via an exemption for a limited period of time (until 2010). The new rule can be reviewed under the "Rules and Regulations" section of the bne web site: www.bne.state.tx.us.

Regulation must be able to assure the public that individuals licensed with advanced practice titles are educated broadly across patient populations and practice settings. In addition to broad-based educational preparation, examination must also test for entry-level competence at the advanced practice level across that same broad base. The new rule presumes that less specialization and broader preparation are essential for initial licensure at the advanced practice level. Specialization and sub-specialization would then be considered value-added after legal recognition for authorization to practice at the advanced practice level is granted. It is important to note that although this issue has been discussed by stakeholders at the national level, no consensus has been reached as of the writing of this update.

## FYI - Understanding the Role of a Physician's Designated Agent

In the course of discharging a patient from the hospital, can a nurse call in a prescription to a pharmacy for a medication that the physician has written orders/ prescription for the patient to take at home?

The answer is yes, provided facility policy and procedure does not prohibit it. This is not within the BNE's jurisdiction, however, the law you are looking for is in the Pharmacy Act [(Tex Occ. Code, Subtitle J, Sections 551.003(14)]. This is the law that defines who can be a "designated agent" for relaying orders from the physician in either an office or facility setting. In a facility, the designated agent definition

includes: "a licensed nurse, physician assistant, or pharmacist employed in a health care facility to whom the practitioner communicates a prescription drug order." This law also defines a designated agent in the physician's office as "an individual designated by the physician." This means the physician can assume responsibility for delegating to any employee working for the physician, including an unlicensed person such as a medical assistant, to be the physician's designated agent who relays orders from the physician. ### SHELLEY ARMSTRONG, aka Michelle O'Connor, aka Shelly Ann Rich, aka Shelly Ruddick Armstrong

Shelly Ann Armstrong, secured employment as a registered nurse with a legal resource agency in Houston, Texas. In April 2004, Ms. Armstrong was assigned as a contract nurse for a consulting firm in Houston, Texas. On June 5, 2004 the consulting firm attempted to verify Ms. Armstrong's education and licensure and found no information. Ms. Armstrong was instructed not to return to work until she brought verification of education and licensure. Ms. Armstrong brought in a copy of a diploma issued to Shelly Ruddick O'Connor from the University of Houston. The University was contacted and they verified that no degree had been issued to the individual named on the copy. The only Michelle O'Connor licensed in Texas is an Advanced Practice Nurse (APN) and Ms. Armstrong's resume did not include that information. When questioned, Ms. Armstrong told the firm



that she did not include the APN because she did not want to work in that area. The consulting firm reported their findings to Ms. Armstrong's employer. The employer was not able to verify her licensure, and Ms. Armstrong was terminated from employment. The case was referred to the Harris County District Attorney's Office, Houston, Texas.
