

### Texas Board of Nursing Bulletin

The mission of the Texas Board of Nursing is to protect and promote the welfare of the people of Texas by ensuring that each person holding a license as a nurse in the State of Texas is competent to practice safely. The Board fulfills its mission through the regulation of the practice of nursing and the approval of nursing education programs. This mission, derived from the Nursing Practice Act, supersedes the interest of any individual, the nursing profession, or any special interest group.



### **Appointments to Texas Board of Nursing Approved by Senate**

On May 27, 2009, Governor Rick Perry announced the appointment of three new members and the reappointment of two members to the Texas Board of Nursing for terms to expire Feb. 1, 2015. Board members reappointed to the Board were Sheri Crosby and Mary Jane Salgado.

**Sheri Crosby** of Mesquite is an attorney at Taber, Estes, Thorne, and Carr, PLLC. She is a member of the American Bar Association, State Bar of Texas, Texas Association of Young Lawyers, JL Turner Legal Association, and Corporate Counsel Women of Color. She is also chair of the Dallas Bar Association's Labor and Employment Section Speakers' Committee, co-chair of the Attorneys Serving the Community Membership Committee, and a volunteer with Big Brothers Big Sisters of North Texas, Dallas Volunteer Attorney Program, and E-Mentoring Esq. Ms. Crosby received a bachelor's degree from Emory University and a law degree from the University at Buffalo School of Law.

Mary Jane Salgado of Eagle Pass is a realtor, business woman and economic developer for the Kickapoo Traditional Tribe of Texas. She is a past member of the Eagle Pass City Council, National Hispanic Association of Real Estate Professionals, and National and Texas Associations of Realtors. She is also a member of the State Board of Texas Rural Leadership and Candles for Life Non-Profit. Ms. Salgado received a bachelor's degree and master's degree in education from Sul Ross State University.

Ms. Crosby and Ms. Salgado were first appointed to the Board on January 25, 2008 and represent consumers on the Board. Governor Perry also appointed three new nurses to the Board.

**Tamara Cowen** of Harlingen is assistant vice president of patient safety solutions for the Valley Baptist Health System. She is a member of the Texas Nurses Association and the American College of Healthcare Executives, past secretary of the Texas Border Health Foundation, and past chairperson of the American Red Cross Audit Committee. Ms. Leader-Horn received a vocational nurse certificate from the John P. Smith School of Nursing. She replaces Rachel Gomez of Harlingen to represent LVN practice.

Josefina Lujan of El Paso is regional dean of the Texas Tech University Health Sciences Center Anita Thigpen Perry School of Nursing. She is a member of the National Association of Hispanic Nurses, the Southern Nursing Research Society, Sigma Theta Tau International Honor Society of Nursing, and US-Mexico Border Health Association. The Honorable Susan King, BSN, RN, representing the 71st District of the Texas House of Representatives, issued commemorative proclamations on behalf of the Texas House of Representatives and Texas Senate. Tony Gilman, Executive Officer, Health Care Policy Council, Office of the Governor, presented a proclamation on behalf of the Office of the Governor. Attendees included: current and former board members and staff; Texas legislators and staff; Texas nursing organizations and associations; hospitals and healthcare facilities; nurse educators; students; and other guests. Special guests who attended the Gala included the daughter-in-law and grandson of Emma Allison, the first nurse licensed in Texas in 1909.

### **Summary of Actions**

A regular meeting of the Board of Nursing was held April 23-24, 2009, in Austin. The following is a summary of Board actions taken during this meeting.



The following proposed rule changes appeared in the May 15, 2009, edition of the *Texas Register* (Volume 34, Number 20) with a comment period ending on June 14, 2009: The Texas Board of Nursing (Board) proposed the repeal of Chapter 216, §§216.1 - 216.11, concerning <u>Continuing Education</u>. This repeal was proposed concurrently with proposed new Chapter 216 which promotes a comprehensive approach to continuing competency in nursing. Comments were received to the proposed repeal of Chapter 216 and concurrent adoption of a new Chapter 216. #### **Education Actions**

- -Moved Clarendon College Vocational Nursing Educational Program in Clarendon, Texas from Full with Warning to Full Program Approval Status.
- -Moved Kilgore College Associate Degree Nursing Educational Program in Kilgore, Texas from Full with Warning to Full Program Approval Status.
- -Accepted the Survey Visit Report on the University of Houston Victoria Baccalaureate Nursing Educational Program in Victoria and Sugarland, Texas and issued commendations and a recommendation.
- -Accepted the Survey Visit Report on the St. Philip's College Associate Degree Nursing Educational Program in San Antonio, Texas and issued commendations, recommendations and requirements.
- -Approved the Dallas Nursing Institute Associate Degree Nursing Educational Program in Dallas, Texas, granted Initial Program Approval Status, and issued a commendation.
- Approved the Texas State Technical College Vocational Nursing Education Program in Harlingen, Texas, granted Initial Program Approval Status, and issued a commendation and a recommendation.
- -Reviewed the Status Report on Inquiries, Proposals, and Approvals: New Nursing Educational Programs.

### Orientation for Deans/Directors/Coordinators Held in Hobby Building

On May 20, 2009, the "Part II - Face-to-Face Session" of the Deans/Directors/Coordinators Orientation was held in the William P. Hobby Building in Austin. Prior to attending the one-day meeting, participants were required to complete "Part I - Online Orientation to the Board Educational Rules and Regulations." The online learning module was designed to provide core content regarding Board Rule 214 relating to <u>Vocational Nursing Education</u> and Board Rule 215 relating to <u>Professional Nursing Education</u>. The one-day meeting offered an opportunity for participants to apply knowledge through interactive, participatory activities.

The Austin workshop was attended by 96 individuals, including deans, directors, and coordinators of professional and vocational nursing educational programs throughout the state, as well as administrators and faculty members. Nursing Consultants from the Education Division of the Texas BON presented the following topics: Process for Faculty Waivers; Faculty/Student Policies; Curriculum Changes; NCLEX Summary and Candidate Reports; NEPIS/CANEP; Evaluation Methods and Tools; Self Study Reports; and Total Program Evaluations. In addition, Mark Majek, Director of Operations, discussed the initial licensure application process and Anthony Diggs, Director of Enforcement, reviewed the petition for declaratory order process, and provided updated information relating to enforcement issues.

### NPAC and ACE Committees Confer to Consider New Joint Charge

In January 2009, the Board charged the Nursing Practice Advisory Committee (NPAC) and the Advisory Committee on Education (ACE) to jointly develop a rule related to the failure to renew a license after a significant passage of time. On June 4, 2009, the two advisory committees met together during a conference call to begin to consider the issues surrounding the charge. The committees agreed to reconvene later this year to continue the discussion.

### Texas Board of Nursing Collecting Information to Better Understand Nursing Errors

This article is the first in a series that will outline the Texas Board of Nursing's (BON) participation in a national study to better understand nursing errors that are also known as nursing practice breakdown.

Boards of nursing possess considerable information that can be used to identify sources of nursing error and thus are well positioned to add to the body of knowledge surrounding errors in health care. Given that nurses comprise the largest group of health care providers and have the most interaction with patients, there is much to learn from understanding factors that lead to a breakdown in a nurse's practice. Identifying, analyzing and tracking practice breakdowns reported to boards of nursing promotes the investigation of generic patterns in error, risk factors, and system contributions. To this end, the National Council of State Boards of Nursing (NCSBN) has implemented a research study to begin to develop new approaches to identify nursing practice breakdown. Using an electronic database called the Taxonomy of Error, Root Cause Analysis of Practice-responsibility – TERCAP®, important information is collected to describe and distinguish types and sources of nursing errors.

The Texas BON has participated in the development of the TERCAP® project since July 2004. In February 2007, the online TERCAP® database became active and Texas became one of the first states to provide information about nursing practice errors reported to the Texas Board of Nursing. An updated version of TERCAP® was implemented in March 2008, to better define the items in the instrument, and since that time Texas has collected comprehensive information to further this national study.

The "heart" of the TERCAP® is composed of a taxonomy or set of categories that are based on notions of good nursing practice. These include:

**Safe Medication Administration**: The nurse administers the right dose of the right medication via the right route to the right patient at the right time for the right reason.

**Documentation**: The nurse ensures complete, accurate and timely documentation.

Attentiveness/Surveillance: The nurse monitors what is happening with the patient and staff. The nurse observes the patient's clinical condition; if the nurse has not observed the patient, then s/he cannot identify changes if they occurred and/ or make knowledgeable discernments and decisions about the patient.

Clinical Reasoning: Nurses interpret patient signs, symptoms and responses to therapies. Nurses evaluate the relevance of changes in patient signs and symptoms and ensure that patient care providers are notified and that patient care is adjusted appropriately. Nurses titrate drugs and other therapies according to their assessment of patient responses.

**Prevention**: The nurse follows usual and customary measures to prevent risks, errors, threats to patient safety and hazards or complications due to illness or hospitalization. Hazards of immobility include skin breakdown, contractures, etc.

**Intervention**: The nurse properly executes healthcare procedures aimed at specific therapeutic goals. Interventions are implemented in a timely manner. Nurses perform the right intervention on the right patient.

**Interpretation of Authorized Provider's Orders**: The nurse interprets authorized provider orders.

**Professional Responsibility/Patient Advocacy:** Advocacy refers to the expectations that a nurse acts responsibly in protecting patient / family vulnerabilities and in advocating to see that patient needs / concerns are addressed. The nurse demonstrates professional responsibility and understands the nature of the nurse-patient relationship.

Why use the TERCAP® data collection instrument?

- Provides consistent and comprehensive data collection about nurses reported to the Board of Nursing in Texas, and other boards of nursing across the country
- Tracks elements of practice breakdown and recurring themes
- Assists in learning from the experiences of nurses who have had nursing practice errors
- Helps identify the characteristics of nurses at risk

#### What might we learn?

- How errors are identified
- When and where errors occur
- Factors in the system that affect errors
- Ways to develop and evaluate new approaches to patient safety

### **Practice Question and Answer**



**Question:** I've been a registered nurse for two years and I have worked in a home health agency for 8 months. One of the patients I visit is an 83 year old male patient with congestive heart failure. I had been visiting him for several weeks, monitoring his vital signs, teaching him about his medications and diet regime. On my most recent visit, he began to complain of shortness of breath as I was leaving. I talked with him and his wife about the importance of calling his physician to report this change. I had several other patients to see that afternoon and when I arrived back at the office, my nurse manager called me into her office and told me that shortly after I had left his home, my patient had been taken to the hospital by EMS and had been admitted to the ICU. She asked me if I knew what had happened. I explained that he complained of suddenly experiencing shortness of breath and that I had encouraged him and his wife to call the physician to report the symptoms. My nurse manager told me that I should have called the physician and assisted the wife in making arrangements for the patient to be evaluated. She said that I failed to assess my patient and provide the necessary intervention that was required in order to protect his safety. I thought it was the patient's responsibility to call his doctor, not mine? Is this true?

#### Answer:

Nurses are required to implement measures to promote a safe environment for their patients. This means they must protect patients from harm and advocate for their safety. When a patient exhibits or reports symptoms to a nurse who is caring for him/her, the nurse has a responsibility to act or intervene on his/her behalf. This is the fundamental principle behind a nurse's duty to a patient. Position Statement 15.14, Duty of a Nurse in Any Setting, explains the nurse's duty as established by the landmark case, Lunsford vs. Board of Nurse Examiners. As the Lunsford case demonstrates, when a nurse knows or should have known that a situation potentially places a patient at risk of harm, the nurse has a duty to intervene. The nurse's knowledge based on educational preparation, experience, and licensure establishes that he/she understands the minimum standards of care and has the ability and duty to recognize potentially harmful situations for the patient.

Failing to adequately assess a patient and provide appropriate interventions can result in harm, thus violating the nurse's duty to always provide for their patients' safety. Holding a nursing license in the State of Texas means that a nurse holds the minimum level of competence to practice safely. While RNs and LVNs are trained and licensed differently, each level of licensure has been prepared to assess patients and recognize the importance of notifying the appropriate health-care provider of a change in condition.

Nurses are required to prevent complications, intervene if complications arise and to take steps to stabilize a patient if complications cannot be avoided. In this case, the nurse may have been able to prevent these complications by completely assessing the patient's new symptoms and taking steps to assist the patient and his wife in seeking an immediate evaluation of his acute symptoms.

In addition, nurses must consult with, utilize and make referrals to community agencies and health care resources to coordinate care for a patient. The nurse in this case should have called the physician to report the acute onset of symptoms, reported her assessment findings, and obtained the necessary orders or instructions with this patient. Nurses must also decide before they accept a job or an assignment whether or not they have the knowledge and skill that is necessary to practice safely. If more education, training or orientation is needed, it is the nurse's responsibility to obtain the required competence so that he/she does not jeopardize patient safety.

These requirements are a part of the standards of practice established by the Texas Board of Nursing (BON) that demonstrate the minimum acceptable level of nursing practice for each level of licensure in any setting. Licensees are encouraged to review Rule 217.11, Standards of Nursing Practice in its entirety; however the specific standards addressed in this Q & A were Rule 217.11(1)(B), (M), (Q), (R) and (T). ### **DELC Work Group Continues Review of Competencies**

The Differentiated Entry Level Competencies (DELC) Work Group met on May 27-29, and again June 29-30, 2009, in the William P. Hobby Building in Austin. Participants continued to address the July 2008 charge from the Board, issued to the Advisory Committee on Education (ACE), to review and revise the DELCs.

Currently, the four categories of competency statements are: (1) Member of the Profession; (2) Provider of Patient-Centered Care; (3) Patient Safety Advocate; and (4) Member of the Health Care Team. The DELC Work Group developed corresponding "Knowledge" and "Clinical Behaviors/Judgments" statements to more fully describe and amplify appropriate nursing actions.

In addition, the Work Group discussed: proposed methodologies for validation of data collection; dissemination to stakeholders for review and input; the use of focus groups to review and refine competency statements; and potential outcome measures. Plans regarding operationalization of the document, as well as future publications and presentations, were considered.

### Nurses on Guard - Error Prevention and Management

### Universal Protocol: Preventing Wrong Site, Wrong Procedure, Wrong Person Surgery

In the April 2009 issue of the Board of Nursing Bulletin, Ms. Michel discussed the role of patient involvement in enhancing patient safety as part of the National Patient Safety Goals. In this issue, Ms. Michel continues her discussion of the National Patient Safety Goals as they relate to Universal Protocol.

The Joint Commission's (TJC's) efforts to prevent wrong site, wrong procedure and wrong person surgery, known as Universal Protocol (UP), became effective in 2004. All accredited hospitals, ambulatory care, and office-based surgery facilities are required to comply. TJC recently revised the requirements for Universal Protocol with implementation in January, 2009 for Ambulatory, Critical Access Hospitals, Disease-Specific Care, Hospitals, and Office-Based Surgery.

The changes to the UP impact all patient care units or areas that perform invasive procedures, including procedures completed outside of operating rooms. Accredited facilities are required to update their current policies, documentation and patient care practices to meet the new requirements.

# What are the three elements of Universal Protocol: Procedural Safety?

1. Conduct a pre-procedure verification.

- 2. Mark the operative/procedure site to identify unambiguously the intended site of incision or insertion.
- 3. Conduct a "time out" immediately before starting the procedure verifying:
  - Correct patient, using two identifiers;
  - Correct side and site marked;
  - Correct procedure consent form completed;
  - Agreement on procedure to be performed;
  - Correct patient position;
  - Relevant images and results are properly labeled and appropriately displayed;
  - The need to administer antibiotics or fluids for irrigation purposes; and
  - Safety precautions based on patient history or medication use.

### Who completes site marking with the new requirements?

The licensed provider performing the procedure will now be required to complete the site marking for procedures in which this is required.

What is the process for exceptions to site marking (if the site cannot be marked)?

The Joint Commission outlines certain procedures that would not require site marking and allow for patient refusal of marking as well. Facilities are required to define their own exception process for these specific cases.

## What role does nursing have in ensuring patient safety related to Universal Protocol elements?

As a member of the procedural care team, nurses play a key role in ensuring the right site, procedure and patient are verified. It is critical that nurses actively participate in the steps of the UP process. Nurses and other members of the procedure care team should actively and directly communicate to verify the patient, site, and procedure. Nurses may also play a role in documentation, as a checklist is now required by TJC. Nursing care that was provided must be documented according to the UP elements. Nurses and other members of the procedure team should be empowered to question at any time if there is a discrepancy with regard to patient identification, site location or the procedure to be completed.

### **GLYNDA GAIL EDWARDS**

Upon further investigation, it was determined that Ms. Edwards had nine aliases, was incarcerated twice, had an outstanding warrant for her arrest, and there was concern that she may be a potential infant abductor. The case was referred to the Plainview Police Department.

Shelia Rochelle Birt, aka: Shelia Moore, had been employed as an independent contractor for a company in Dallas since January, 2006. Her duties included providing summaries of medical records where she signed her name followed by RN. In January 2009, the company attempted to verify the nurse licensure of Ms. Birt and were unable to do so on the BON web site. The employer met with Ms. Birt concerning her nurse licensure and she presented a license indicating nurse licensure compact privilege which bore her name and license number 232604. When the license was checked on the BON web site, it was determined that the license number belonged to someone with a different name. The case was referred to the Dallas County District Attorney's Office.
