OWNER-TRAINER, EUSEVIO HUITRON, HAVING BEEN DULY NOTICED, APPEARED TO A FORMAL HEARING BEFORE THE RETAMA PARK BOARD OF STEWARDS ON 06/14/2008. AFTER HEARING TESTIMONY, AND AFTER DILIBERATION, THE BOARD OF STEWARDS ASSESS THE FOLLOWING PENALTY AGAINST MR. HUITRON: A ONE THOUSAND-FIVE HUNDRED (\$1500.00) DOLLAR FINE, A SUSPENSION OF HIS TEXAS RACING COMMISSION LICENSE FOR SIX (6) MONTHS (JUNE 19, 2008 THRU DECEMBER 18, 2008), AND A LOSS OF PURSE FOR THE HORSE "RARE LEADER" THE FIRST PLACE FINISHER IN THE 8TH RACE AT MANOR DOWNS ON 03/23/2008. THE HORSE "RARE LEADER" IN A POST RACE URINE SAMPLE LABELED MD021891 TESTED POSITIVE FOR A CLASS II PROHIBITED SUBSTANCE, LIDOCAINE AND HYDROXYLIDOCAINE, A METABOLITE OF LIDOCAINE.

DURING THE TERM OF THIS SUSPENSION, ANY HORSE OWNED OR TRAINED BY MR. HUITRON IS DENIED ENTRY PENDING SALE OR TRANSFER TO A PARTY APPROVED BY THE BOARD OF STEWARDS.

DURING THE TERM OF HIS SUSPENSION, MR. HUITRON IS ALSO DENIED ACCESS TO ALL FACILITIES UNDER THE JURISDICTION OF THE TEXAS RACING COMMISSION.

(1ST VIOLATION IN THIS CLASSIFICATION WITHIN 12 MONTHS)

PRIOR TO DISPOSITION OF THIS INITIAL RACE, THE HORSE "RARE LEADER" COMPETED IN THE MAIDEN CLASSIC FINALS ON 04/06/2008 IN RACE #11 AT MANOR DOWNS AND PLACED 4TH, A RACE FOR WHICH "RARE LEADER" WAS INELIGIBLE. AS A RESULT, "RARE LEADER" IS HEREBY DISQUALIFIED FROM BOTH RACES AND DECLARED UNPLACED, WITH THE PURSE TO BE REDISTRIBUTED IN ACCORDANCE WITH THE FOLLOWING OFFICIAL ORDER OF FINISH:

Mr. Huitron, through attorney Paula Flowerday, filed an appeal and request for stay on June 18, 2008. Mr. Huitron included a \$150 appeal bond (Money Order #10159480565). ED King granted the stay by letter to Ms. Flowerday, effective June 19, 2008.

Supplement # 2

This ruling is superceded by COMM 103. By agreement, Eusevio Huitron is hereby suspended ninety (90) days beginning December 8, 2008 through March 8, 2009, for violations found in MAN 1990. In addition, Eusevio Huitron will pay an additional \$3,000 fine, for a total fine of \$4,500, including the \$1,500 fine paid under MAN 1990. Mr. Huitron must pay the remainder of the fine no later than March 8, 2008.

During the term of his suspension, Mr. Huitron is denied access to all areas under the jurisdiction of the Texas Racing Commission.

During the term of his suspension, any horse owned or trained by Mr. Huitron is denied entry pending sale or transfer to a party approved by the Board of Stewards.

"Rare Leader" is also disqualified from the Maiden Classic Trial Race No. 8 at Manor Downs on March 23, 2008, and declared unplaced. In addition, "Rare Leader" is disqualified from the Maiden Classic Finals, Race No. 4 at Manor Downs on April 6, 2008, and declared unplaced. The official order of finish for each of those races is adjusted accordingly:
