Pursuant to the Mineral Interest Pooling Act for Creation of a Pooled Unit for its Texas Steel Unit, Well No. 1, Newark, East (Barnett Shale) Field, Tarrant County, Texas. Chairman Carrillo and Commissioner Jones heard the oral arguments. Commissioner Williams recused himself and was not present. The Commission took no further action regarding this item and will consider this item at the next conference on July 21, 2009.
