311.214 FAILURE TO PAY RACING DEBT

OWNER/TRAINER, TOBY LEE KEETON, HAVING BEEN DULY NOTICED, FAILED TO APPEAR AT A FORMAL HEARING BEFORE THE RETAMA PARK BOARD OF STEWARDS ON 06/17/2008. MR. KEETON TEXAS RACING COMMISSION LICENSE IS HEREBY SUSPENDED, IN-ABSENTIA, FOR FAILING TO SATISFY A DEFAULT JUDGMENT, CAUSE # 328583, THAT WAS ISSUED AGAINST MR. KEETON, ON 09/28/2007, BY BEXAR COUNTY, COUNTY COURT AT LAW # 7, IN THE PRINCIPAL AMOUNT OF \$11764.50, PLUS REASONABLE ATTORNEY FEES OF \$1000.00, PLUS POST JUDGEMENT INTEREST AT THE RATE OF 8.25%, IN FAVOR OF SUSAN MOULTON. PURSUANT TO AN AGREEMENT ENTERED INTO ON 11/01/2007, TOBY KEETON PAID \$5000.00 DOLLARS TO MS MOULTON; THAT PAYMENT BROUGHT THE TOTAL AMOUNT TO \$7764.50 DOLLARS. SINCE THAT TIME, MR KEETON HAS NOT MADE ANY ADDITIONAL PAYMENTS. THEREFORE, THE INTEREST CONTINUES TO ACCRUE AT THE PER DIEM RATE OF \$1.75 DOLLARS. MR KEETON REQUESTED AND RECEIVED THREE CONTINUANCES TO PROVIDE TIME TO SETTLE HIS DEBT TO MS. MOULTON YET FAILED TO COMPLY.

DURING THE TERM OF HIS SUSPENSION MR. KEETON IS DENIED ACCESS TO ALL AREAS UNDER THE JURISDICTION OF THE TEXAS RACING COMMISSION.
