% POP USED IN ANALYSIS = percent of the district's population that lives in census block groups located entirely within the district or in block groups where a majority of the population lives in the district.

HOUSING BUILT -- 1990 TO 2000 = percent of the estimated number of all houses (both occupied and vacant) that were constructed between 1990 and 2000.

HOUSING BUILT -- PRIOR TO 1960 = percent of the estimated number of all houses (both occupied and vacant) that were constructed prior to 1960.

OCCUPIED BY -- RENTER = percent of the estimated number of occupied housing units that were occupied by renters.

OCCUPIED BY -- OWNER = percent of the estimated number of occupied housing units that were owner-occupied.

PERCENT OF INCOME SPENT ON HOUSING -- BY RENTERS -- 35+% = percent of the estimated number of renter-occupied housing units where the cost of the rent and utilities is equal to 35 percent or more of the total household income.

PERCENT OF INCOME SPENT ON HOUSING -- BY RENTERS -- <20% = percent of the estimated number of renter-occupied housing units where the cost of the rent and utilities is less than 20 percent of the total household income.

PERCENT OF INCOME SPENT ON HOUSING -- BY OWNERS -- 35+% = percent of the estimated number of owner-occupied houses with housing expenses equal to or more than 35 percent of the total household income. Housing expenses (owner costs) include mortgage, taxes, property insurance, and utilities.

PERCENT OF INCOME SPENT ON HOUSING -- BY OWNERS -- <20% = percent of the estimated number of owner-occupied houses with housing expenses (see above) less than 20 percent of the total household income.

VALUE OF OWNER-OCC-HOUSING -- \$0 - \$49,999 = percent of the estimated number of owner-occupied houses with estimated value of less than \$50,000. The value is the respondent's estimate of how much the property (house and lot) would sell for in April 2000 if it were for sale.

VALUE OF OWNER-OCC-HOUSING -- \$50,000 - \$99,999 = percent of the estimated number of owner-occupied houses with estimated value between \$50,000 and \$99,999 (see above).

VALUE OF OWNER-OCC-HOUSING -- \$100,000 PLUS = percent of the estimated number of owner-occupied houses with estimated value of \$100,000 or more (see above).
