% POP USED IN ANALYSIS = percent of the district's population that lives in census block groups located entirely within the district or in block groups where a majority of the population lives in the district.

LABOR FORCE STATUS -- ARMED FORCES = percent of the estimated population age 16 and over that was serving in the armed forces the last week of March 2000.

LABOR FORCE STATUS -- CIVILIAN L.F. = percent of the estimated population age 16 and over that was in the civilian labor force the last week of March 2000. The civilian labor force includes those persons age 16 and over who are employed or are seeking employment.

LABOR FORCE STATUS -- NOT IN L.F. = percent of the estimated population age 16 and over that is not in the labor force. Persons in this category include students, housewives, retirees, seasonal workers in the off-season, and institutionalized persons.

CIVILIAN LABOR FORCE -- EMPLOYED = percent of the estimated total civilian labor force that was employed the last week of March 2000.

CIVILIAN LABOR FORCE -- UNEMPLOYED -- TOTAL = percent of the estimated total civilian labor force that was not employed the last week of March 2000.

CIVILIAN LABOR FORCE -- UNEMPLOYED -- BLACK = percent of the estimated Black civilian labor force that was not employed the last week of March 2000.

CIVILIAN LABOR FORCE -- UNEMPLOYED -- HISPANIC = percent of the estimated Hispanic civilian labor force that was not employed the last week of March 2000.

WORKED IN 1999 -- TOTAL = percent of the estimated number of persons age 16 and over in 1999 that worked in 1999.

WORKED IN 1999 -- WORKED 50-52 WKS = percent of the estimated number of persons age 16 and over in 1999 that worked all year (50 to 52 weeks) in 1999, including both full-time and part-time workers.

EMPLOYMENT -- PRIVATE SECTOR = percent of the estimated civilian labor force that was employed by the private sector, including those people who were paid employees of their own companies, the last week of March 2000.

EMPLOYMENT -- GOVT = percent of the estimated civilian labor force that was employed by federal, state, or local government the last week of March 2000.

EMPLOYMENT -- SELF-EMPLOYED = percent of the estimated civilian labor force that was self-employed the last week of March 2000.
