TRAINER, JOSE ALBERTO RAMOS, HAVING BEEN DULY NOTICED, WAIVED HIS RIGHT TO A FORMAL HEARING AND HIS RIGHT TO APPEAL, BEFORE THE RETAMA PARK BOARD OF STEWARDS ON 04/26/08 AND PURSUANT TO AN AGREED SETTLEMENT IS HEREBY FINED ONE THOUSAND FIVE HUNDRED (\$1500.00) DOLLARS AND A SUSPENSION OF HIS TXRC LICENSE FOR SIX MONTHS (05/11/08 THROUGH 11/10/08) AND A LOSS OF PURSE, FOR A POSITIVE TEST OF A CLASS 2 PROHIBITED SUBSTANCE, LIDOCAINE AND HYDROXYLIDOCAINE, SAMPLE NUMBER MD021845, TAKEN FROM HIS HORSE "RAPID FIRE JESS" 2ND PLACE FINISHER IN THE 11TH RACE AT MANOR DOWNS ON 03/16/08. (1ST VIOLATION WITHIN 12 MONTHS)

THE HORSE, "RAPID FIRE JESS" IS HEREBY DISQUALIFIED AND DECLARED UNPLACED WITH THE PURSE TO BE REDISTRIBUTED AS FOLLOWS:

3RD # 8 VAIL MOUNTAIN
4TH # 9 MOUNTAIN OF MONEY
5TH # 3 TRES FORTUNES
6TH # 10 NOCHES CALIENTE

#6 "RAPID FIRE JESS" (UNPLACED)
#2 "INVISIBLE GENT" (UNPLACED)

DURING THE TERM OF HIS SUSPENSION MR.RAMOS IS DENIED ACCESS TO ALL FACILITIES UNDER THE JURISDICTION OF THE TEXAS RACING COMMISSION.

ENTRY OF ANY HORSES OWNED OR TRAINED BY MR. RAMOS IS DENIED PENDING SALE OR TRANSFER TO A PARTY APPROVED BY THE BOARD OF STEWARDS.
