DURING THE TERM OF THIS SUSPENSION, OWNER-TRAINER, FRIESENHAHN, IS DENIED ACCESS TO ALL FACILITIES UNDER THE JURISDICTION OF THE TEXAS RACING COMMISSION. ENTRY OF ANY HORSE OWNED OR TRAINED BY MR. FRIESENHAHN IS DENIED, PENDING SALE OR TRANSFER TO A PARTY APPROVED BY THE BOARD OF STEWARDS.
