FURTHER, "ANGEL CARTEL" IS DISQUALIFIED FROM PARTICIPATION IN THE "SAM HOUSTON MAIDEN CLASSIC FINAL".

"ANGEL CARTEL," A 4-Y-OLD FILLY, OWNED BY JOE F. GUTIERREZ JR AND TRAINED BY BOBBY MARTINEZ WAS NOMINATED TO THE "SAM HOUSTON MAIDEN CLASSIC" AND APPEARED ON THE LIST OF NOMINATIONS, PRINTED ON JUNE 27TH 2008.

"ANGEL CARTEL" WAS LISTED ON THE PROGRAM FOR THE "SAM HOUSTON MAIDEN CLASSIC TRIAL", RUN AS THE SEVENTH RACE AT SAM HOUSTON RACE PARK ON 07/17/2008, WITH HER APPROPRIATE PAST PERFORMANCES.

SUBSEQUENTLY, IT WAS DETERMINED THAT THE 3-Y-OLD FILLY "ANGELS CARTEL" OWNED BY JOE S. GUTIERREZ AND TRAINED BY BOBBY MARTINEZ, WAS IN FACT, THE HORSE THAT COMPETED IN THE SEVENTH RACE ON 07/17/2008 AND FINISHED SECOND.
