Available to Serve on Assignment

The following information on Senior and Former Judges available for assignment was obtained from the Presiding Judges of the Admini follow Judicial Regions (AJRs), and is current as of March 2007. As used in this directory, "former" indicates a judge who served as a regular judge for at least 48 months and has not yet retired (i.e., a judge who is not receiving an annuity under the Judicial Retirement System), and "senior" indicates a judge who served as a regular judge for at least 48 months and has retired (i.e., a judge who is receiving an annuity under the Judicial Retirement System).
