### 5. Consideration and Opportunity for Approval of Proposed Reduction of Certificates Issued

The Board will discuss and have the opportunity to approve the proposed reduction of certificates issued.

At the present time, there are 144 different types of certificates issued. At the same time, there are 83 different types of examinations for securing a teaching certificate. One of the stated State Board for Educator Certification (SBEC) goals is to reduce the total number of types of teaching certificates.

In reviewing the database, 61 types of certificates are no longer being issued as initial certificates; however, since September 1, 1999, these certificates have been issued as standard five-year renewable certificates. SBEC will need to continue to keep these certificates active for future renewals.

In addition, 21 types of current certificates are considered obsolete since they were issued as specialization areas that are no longer available. Furthermore, two types of certificates were identified that do not have tests available for the issuance of a certificate; they should be abolished.

6. Consideration and Opportunity for Approval of *A Career in Teaching* to Open a Satellite Location in McAllen

The Board will discuss and have the opportunity to approve an additional location for A Career in Teaching, an educator preparation program currently in operation.

# 7. Consideration and Opportunity for Approval of the Educator Standards Advisory Committee for 2008-2009

This item presents the State Board for Education Certification (SBEC) the opportunity to approve the new Educator Standards Advisory Committee members.

8. Consideration and Opportunity for Approval of a Plan for Languages Other Than English (LOTE) for the Spanish, German, and French Examinations to Meet State Certification Requirements

The item provides the State Board for Educator Certification (SBEC) the opportunity to approve the use of Educational Testing Service (ETS) existing examinations for Languages Other Than English (LOTE) EC-12 examinations in Spanish, French, and German on a temporary basis. Because of the lengthy test development process, this would allow for candidates in educator preparation programs and certified teachers to test with the new SBEC-approved LOTE EC-12 standards one year earlier. The ETS examination standards align with the LOTE EC-12 standards developed by Texas educators and approved by the SBEC Board. While the ETS examinations are being administered, new test items will be field tested within the operational exams so that there will be one completely unique Texas owned test form for TExES LOTE EC-12 Spanish, French, and German by August 31, 2011. In addition to the content exams, candidates would be required to complete all other requirements of an educator preparation program to be recommended for certification. We are proposing that the ETS languages examinations in Spanish, French, and German be administered as TExES computer-administered examinations beginning fall 2009.

9. Proposed Revisions to 19 TAC Chapter 227, Provisions for Educator Preparation Students

This item provides the State Board for Educator Certification (SBEC) an opportunity to discuss and propose revisions to 19 TAC Chapter 227, <u>Provisions for Educator Preparation Students</u>. The proposed revisions would update the rules to reflect current law, add minimum standards for all educator preparation programs, while still allowing flexibility, and ensure consistency among educator preparation programs in the state. This item also proposes additional changes to incorporate recommendations following the May 9, 2008, SBEC meeting.

10. Proposed Revisions to 19 TAC Chapter 228, Requirements for Educator Preparation Programs, and Proposed Repeal of 19 TAC Chapter 230, Professional Educator Preparation and Certification, Subchapter G, Certification Requirement for Classroom Teachers, §230.191, Preparation Required in All Programs

This item provides the State Board for Educator Certification (SBEC) an opportunity to discuss and propose revisions to 19 TAC Chapter 228, Requirements for Educator Preparation Programs. The proposed revisions would update the rules to reflect current law, add minimum standards for all educator preparation programs, while still allowing flexibility, and ensure consistency among the educator preparation programs in the state. This item also proposes additional changes to incorporate recommendations following the May 9, 2008, SBEC meeting. In addition, this item provides the SBEC an opportunity to discuss and propose the repeal of 19 TAC §230.191, Preparation Required in All Programs. Program preparation requirements in this rule have been incorporated into the proposed revisions to 19 TAC Chapter 228 or have an expiration date in rule of September 1, 2007.

11. Proposed Revisions to Board Operating Policies and Procedures (BOPP)

This item provides the Board the opportunity to approve the requested changes from the May 9, 2008 SBEC meeting to the Board Operating Policies and Procedures (BOPP).

The State Board for Educator Certification (SBEC) will have an opportunity to discuss and approve changes to the 2007-2010 Rule Review Plan for SBEC Rules based on the need to delay the review of rules relating to professional educator preparation and certification. Texas Government Code, §2001.039, requires the rule review of state agency rules, including SBEC rules. The rule review requirement is designed to ensure that the reason for initially adopting a rule continues to exist.
