### LOCAL OFTION ELECTIONS

There were ten local option elections reported in 1945. Six were county-wide and four were precinct elections.

The voting in 1945:

(Note: In the following tabulations the first figure denotes the "wet" total, the second figure the "dry" total.)

- ARCHER COUNTY: Archer County voted (424-885) against legalizing the sale of all alcoholic beverages on July 7, 1945.
- CONCHO COUNTY: Concho County voted (719-663) to permit continued legal sale of beer. This countywide election was held on January 6, 1945.
- CAINES COUNTY: Gaines County voted (566-923) against legalizing the sale of beer on March 10, 1945.
- HUTCHINSON COUNTY: Precinct 3 voted (106-173) to prohibit the sale of all alcoholic beverages on September 8, 1945.
- LIFERTY COUNTY: Precinct 6 voted (319-535) to prohibit the sale of all alcoholic beverages on October 6, 1945. The result of this election is being contested in the Courts.
- MARION COUNTY: Marion County voted (354-986) against legalizing the sale of beer on September 12, 1945.

MCLennan County voted (10,936-9,896) to legalize the sale of beer on May 5, 1945.

FECOS COUNTY: Precinct 6 voted (49-44) to permit the continued sale of all alcoholic beverages. This election was held on January 6, 1945.

REEVES COUNTY: Precinct 2 voted (44-85) to prohibit the sale of all alcoholic beverages on March 10, 1945.

TRINITY CCUNTY: Trinity County voted (937-1,086) to prohibit the sale of all alcoholic beverages on June 9, 1945. The result of this election is being contested in the Courts.

#### LOCAL OPTION ELECTIONS

There were ten local option elections reported in 1945. Six were county-wide and four were precinct elections.

- ARCHER COUNTY: Archer County voted (424-885) against legalizing the sale of all alcoholic beverages on July 7, 1945.
- CONCHO COUNTY: Concho County voted (719-663) to permit continued legal sale of beer. This countywide election was held on January 6, 1945.

GAINES COUNTY: Gaines County voted (566-923) against legalizing the sale of beer on March 10, 1945.

HVICHINSON COUNTY: Precinct 3 voted (106-173) to prohibit the sale of all alcoholic beverages on September 8, 1945.

LIFERTY COUNTY: Precinct 6 voted (319-535) to prohibit the sale of all alcoholic beverages on October 6, 1945. The result of this election is being contested in the Courts.

MARION COUNTY: Marion County voted (354-986) against legalizing the sale of beer on September 12, 1945.

McLennan County voted (10,936-9,896) to legalize the sale of beer on May 5, 1945.

PECOS COUNTY: Precinct 6 voted (49-44) to permit the continued sale of all alcoholic beverages. This election was held on January 6, 1945.

REVES COUNTY: Precinct 2 voted (44-85) to prohibit the sale of all alcoholic beverages on March 10, 1945.

TRINITY COUNTY: Trinity County voted (937-1,086) to prohibit the sale of all alcoholic beverages on June 9, 1945. The result of this election is being contested in the Courts.


