

### LOCAL OPTION ELECTIONS

There were twenty local option elections held in 1962. Sixteen were called to legalize, five became "wet" and eleven remained "dry". Three elections were called to prohibit and all remained "wet". One "wet" for sale of beer and wine before election was held and became "wet" for the sale of all alcoholic beverages.

The voting in 1962:

ANDERSON COUNTY:

The Incorporated City of Palestine, Anderson County, on April 7, 1962, voted 2164 for the legal sale of all alcoholic beverages for off premise consumption only and 2024 against the legal sale of all alcoholic beverages for off premise consumption only. Palestine was "dry" before the election was held and became "wet".

AUSTIN COUNTY: The Incorporated City of San Felipe, Austin County, on December 8, 1962, voted 79 for the legal sale of all alcoholic beverages and 33 against the legal sale of all alcoholic beverages. San Felipe was "wet" before the election was held and remained "wet".

BRAZOS COUNTY: Justice Precinct No. 6, Brazos County, on May 5, 1962, voted 68 for the legal sale of beer and 76 against the legal sale of beer. This Precinct was "dry" before the election was held and remained "dry".

> Justice Precinct No. 6, Brazos County, on November 6, 1962, voted 77 for the legal sale of beer for off premise consumption only and 64 against the legal sale of beerfor off premise consumption only. This Precinct was "dry" before the election was held and became "wet".

> Justice Precinct No. 5, Calhoun County, on April 7, 1962, voted 147 for the legal sale of all alcoholic beverages and 34 against the legal sale of all alcoholic beverages. This Precinct was "wet" before the election was held and remained "wet".

## CALHOUN COUNTY:

#### EASTLAND COUNTY:

The Incorporated City of Ranger, Eastland County, on June 9, 1962, voted 423 for the legal sale of beer and wine and 506 against the legal sale of beer and wine. Ranger was "dry" before the election was held and remained "dry".

The Incorporated City of Ranger, Eastland County, on September 8, 1962, voted 452 for the legal sale of all alcoholic beverages and 480 against the legal sale of all alcoholic beverages, Ranger was"dry" before the election was held and remained "dry".

The Incorporated City of Ranger, Eastland County, on December 8, 1962, voted 325 for the legal sale of beer and 523 against the legal sale of beer. Ranger was "dry" before the election was held and remained "dry".

Justice Precinct No. 1, Grimes County, on November 6, 1962, voted 286 for the legal sale of beer and 367 against the legal sale of beer. This Precinct was "dry" before the election was held and remained "drv".

HARRISON COUNTY: The Incorporated City of Uncertain, Harrison County, on March 10, 1962, voted 87 for the legal sale of all alcoholic beverages and 5 against the legal sale of all alcoholic beverages. Uncertain was "dry" before the election was held and became "wet".

> The Incorporated City of Scottsville, Harrison County, on June 9, 1962, voted 35 for the legal sale of all alcoholic beverages for off premise consumption only and O against the legal sale of all alcoholic beverages for off premise consumption only. Scottsville was "dry" before the election was held and became "wet".

#### GRIMES COUNTY:

HOUSTON COUNTY:

The Incorporated City of Crockett, Houston County, on December 8, 1962, voted 465 for the legal sale of all alcoholic beverages and 1180 against the legal sale of all alcoholic beverages. Crockett was "dry" before the election was held and remained "dry".

The Incorporated City of Sanford, Hutchinson County, on August 4, 1962, voted 33 for the legal sale of all alcoholic beverages for off premise consumption only and 41 against the legal sale of all alcoholic beverages for off premise consumption only. Sanford was "dry" before the election was held and remained "dry".

HUTCHINSON COUNTY:

MARION COUNTY:

Justice Precinct No. 1, Marion County, on March 8, 1962, voted 103 for the legal sale of all alcoholic beverages for off premise consumption only and 54 against the legal sale of all alcoholic beverages for off premise consumption only. This Precinct was "dry" before the election was held and became "wet".

Justice Precinct No. 2, Marion County, on May 1, 1962, voted 114 for the legal sale of all alcoholic beverages and 165 against the legal sale of all alcoholic beverages. This Precinct was "dry" before the election was held and remained "dry".

MATAGORDA COUNTY: Justice Precinct No. 6, Matagorda County, on May 8, 1962, voted 65 for the legal sale of beer for off premise consumption only and 94 against the legal sale of beer for off premise consumption only. This Precinct was "dry" before the eleotion was held and remained "dry".

SAN PATRICIO COUNTY: Justice Precinct No. 5, San Patricio County, on December 8, 1962, voted 368 for the legal sale of all alcoholic beverages and 487 against the legal sale of all alcoholic beverages. This Precinct was "dry" before the election was held and remained "dry". TARRANT COUNTY: The Incorporated City of Sansom Park, Tarrant County, on October 6, 1962, voted 326 for the legal sale of all alcoholic beverages and 325 against the legal sale of all alcoholic beverages. Sansom Park was "wet" before the election was held and remained "wet".

WILLACY COUNTY: Justice Precinct No. 4, Willacy County, on July 7, 1962, voted 95 for the legal sale of all alcoholic beverages and 74 against the legal sale of all alcoholic beverages. This Precinct was "wet" for the sale of beer and wine before the election was held and became "wet" for the sale of all alcoholic beverages.

WOOD COUNTY: The Incorporated City of Mineola, Wood County, on June 16, 1962, voted 387 for the legal sale of all alcoholic beverages for off premise consumption only and 729 against the legal sale of all alcoholic beverages for off premise consumption only. Mineola was "dry" before the election was held and remained "dry".
