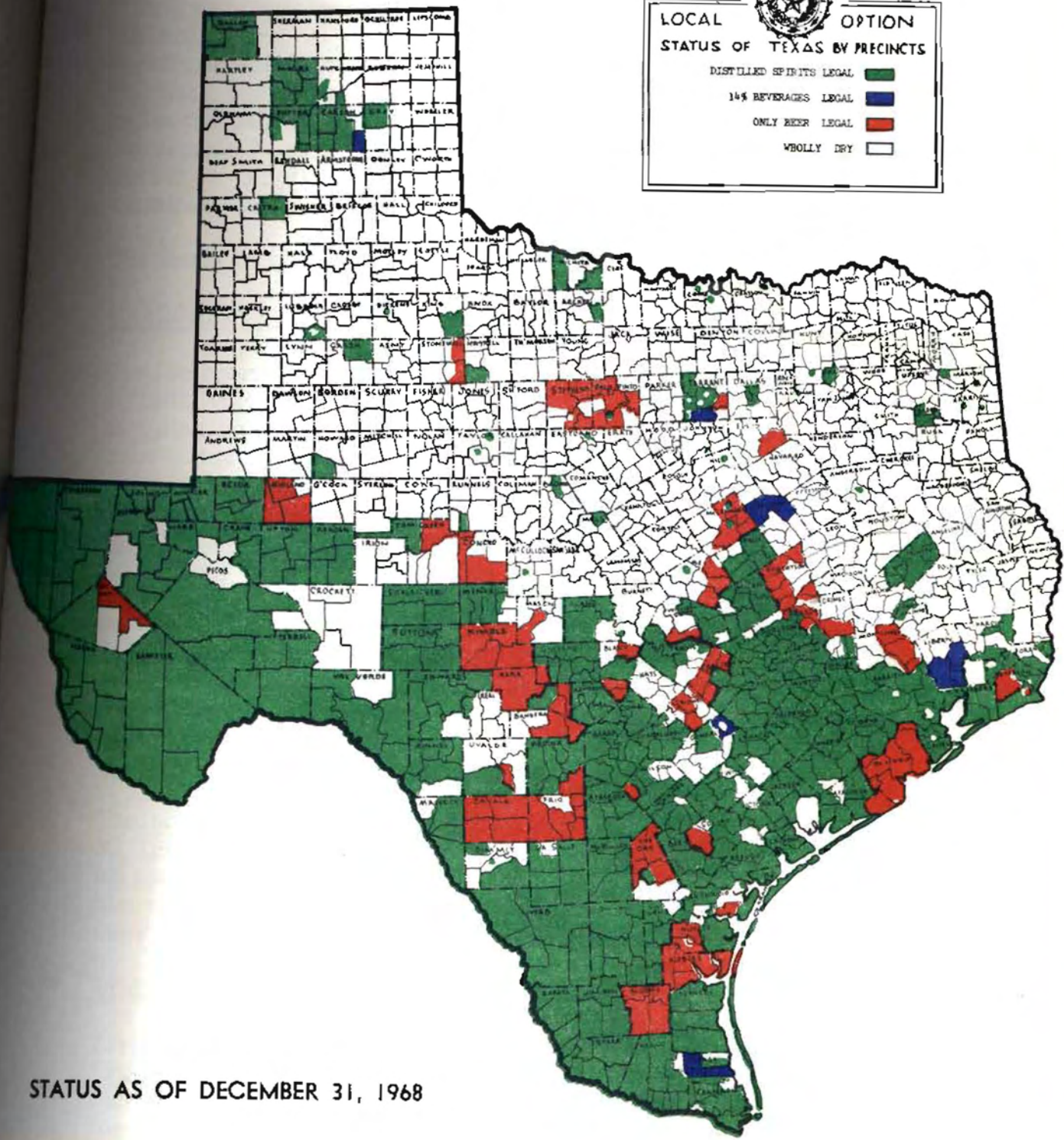

LOCAL OPTION ELECTIONS

There were twenty-one local option elections held in 1968. Twelve elections were called to legalize the sale of all alcoholic beverages for off premise consumption only, six remained "Dry", three remained "Wet", and three became "Wet". Six elections were called to legalize the sale of all alcoholic beverages, four remained "Dry" and two became "Wet". Three elections were called to legalize the sale of beer for off premise consumption only, two became "Wet" and one remained "Dry".

The voting in 1968:

BRAZORIA COUNTY

The Incorporated City of Richwood, Brazoria County, on November 5, 1968, voted 191 "For the legal sale of beer for off premise consumption only" and 144 "Against the legal sale of beer for off premise consumption only". Richwood was "Dry" before the election was held and became "Wet".

COMANCHE COUNTY

Justice Precinct No. 4, Comanche County, on December 7, 1968, voted 82 "For the legal sale of beer for off premise consumption only" and 92 "Against the legal sale of beer for off premise consumption only". This Precinct was "Dry" before the election was held and remained "Dry".

CORYELL COUNTY

The Incorporated City of Copperas Cove, Coryell County, on January 30, 1968, voted 427 "For the legal sale of all alcoholic beverages for off premise consumption only" and 652 "Against the legal sale of all alcoholic beverages for off premise consumption only". Copperas Cove was "Dry" before the election was held and remained "Dry".

DIMMIT COUNTY

Justice Precinct No. 1, Dimmit County, on April 13, 1968, voted 497 "For the legal sale of all alcoholic beverages" and 593 "Against the legal sale of all alcoholic beverages". The Precinct was "Dry" before the election was held and remained "Dry".

Justice Precinct No. 2, Dimmit County, on March 9, 1968, voted 138 "For the legal sale of all alcoholic beverages" and 73 "Against the legal sale of all alcoholic beverages". This Precinct was "Dry" before the election was held and became "Wet".

HOPKINS COUNTY

The Incorporated City of Como in Hopkins County, on June 8, 1968, voted 68 "For the legal sale of all alcoholic beverages for off premise consumption only" and 114 "Against the legal sale of all alcoholic beverages for off premise consumption only". Como was "Dry" before the election was held and remained "Dry".

HUTCHINSON COUNTY

Justice Precinct No. 7, Hutchinson County, on June 8, 1968, voted 43 "For the legal sale of all alcoholic beverages for off premise consumption only" and 12 "Against the legal sale of all alcoholic beverages for off premise consumption only". This Precinct was "Wet" for the legal sale of beer for off premise consumption only and became "Wet" for the legal sale of all alcoholic beverages for off premise consumption only.

JEFFERSON COUNTY

The Incorporated City of Lakeview in Jefferson County, on July 9, 1968, voted 302 "For the legal sale of beer for off premise consumption only" and 158 "Against the legal sale of beer for off premise consumption only". Lakeview was "Dry" before the election was held and became "Wet" for the legal sale of beer for off premise consumption only.

KAUFMAN COUNTY

The Incorporated City of Lawrence in Kaufman County on August 3, 1968, voted 21 "For the legal sale of all alcoholic beverages" and 24 "Against the legal sale of all alcoholic beverages". Lawrence was "Dry" before the election was held and remained "Dry".

LAMPASAS COUNTY

The Incorporated City of Lampasas in Lampasas County, on June 5, 1968, voted 679 "For the legal sale of all alcoholic beverages for off premise consumption only" and 900 "Against the legal sale of all alcoholic beverages for off premise consumption only". Lampasas was "Dry" before the election was held and remained "Dry".

LIVE OAK COUNTY

Justice Precinct No. 3, Live Oak County, on April 8, 1968, voted 106 "For the legal sale of all alcoholic beverages" and 112 "Against the legal sale of all alcoholic beverages". This Precinct was "Dry" before the election was held and remained "Dry".

MADISON COUNTY

Justice Precinct No. 4, Madison County, on May 7, 1968, voted 109 "For the legal sale of all alcoholic beverages for off premise consumption only" and 252 "Against the legal sale of all alcoholic beverages for off premise consumption only". This Precinct was "Dry" before the election was held and remained "Dry".

NAVARRO COUNTY

The Incorporated City of Retreat in Navarro County, on July 2, 1968, voted 32 "For the legal sale of all alcoholic beverages for off premise consumption only" and 95 "Against the legal sale of all alcoholic beverages for off premise consumption only". Retreat was "Dry" before the election was held and remained "Dry".

PALO PINTO COUNTY

Justice Precinct No. 6, Palo Pinto County, on July 1, 1968, voted 79 "For the legal sale of all alcoholic beverages for off premise consumption only" and 95 "Against the legal sale of all alcoholic beverages for off premise consumption only". This Precinct was "Wet" for the legal sale of beer only prior to the election and remained "Wet" for the legal sale of beer only.

POTTER COUNTY

Justice Precinct No. 5, Potter County, on November 5, 1968, voted 442 "For the legal sale of all alcoholic beverages for off premise consumption only" and 209 "Against the sale of all alcoholic beverages for off premise consumption only". This Precinct was "Dry" and became "Wet".

RAINS COUNTY

The Incorporated City of East Tawakoni in Rains County, on February 6, 1968, voted 38 "For the legal sale of all alcoholic beverages for off premise consumption only" and 32 "Against the legal sale of all alcoholic beverages for off premise consumption only". East Tawakoni was "Dry" before the election was held and became "Wet".

SAN JACINTO COUNTY

Justice Precinct No. 3., San Jacinto County, on February 3, 1968, voted 128 "For the legal sale of all alcoholic beverages for off premise consumption only" and 126 "Against the legal sale of all alcoholic beverages for off premise consumption only". This Precinct was "Dry" before the election was held and became "Wet".

SAN PATRICIO COUNTY

Justice Precinct No. 5, San Patricio County, on October 5, 1968, voted 292 "For the legal sale of alcoholic beverages for off premise consumption only" and 582 "Against the legal sale of alcoholic beverages for off premise consumption only". This Precinct was "Dry" before the election was held and remained "Dry".

STONEWALL COUNTY

Justice Precinct No. 2, Stonewall County, on December 7, 1968, voted 71 "For the legal sale of all alcoholic beverages for off premise consumption only" and 31 "Against the legal sale of all alcoholic beverages for off premise consumption only". This Precinct was "Wet" for the sale of beer for off premise consumption only before the election was held and after the election became "Wet" for the sale of all alcoholic beverages for off premise consumption.

TRAVIS COUNTY

Justice Precinct No. 6, Travis County, on November 5, 1968, voted 1825 "For the legal sale of all alcoholic beverages for on premise consumption only" and 832 "Against the legal sale of all alcoholic beverages for on premise consumption only". This Precinct was "Dry" before the election was held and became "Wet".

VICTORIA COUNTY

Justice Precinct No. 6, Victoria County, on December 7, 1968, voted 179 "For the legal sale of all alcoholic beverages" and 245 "Against the legal sale of all alcoholic beverages". This Precinct was "Dry" before the election was held and remained "Dry".
