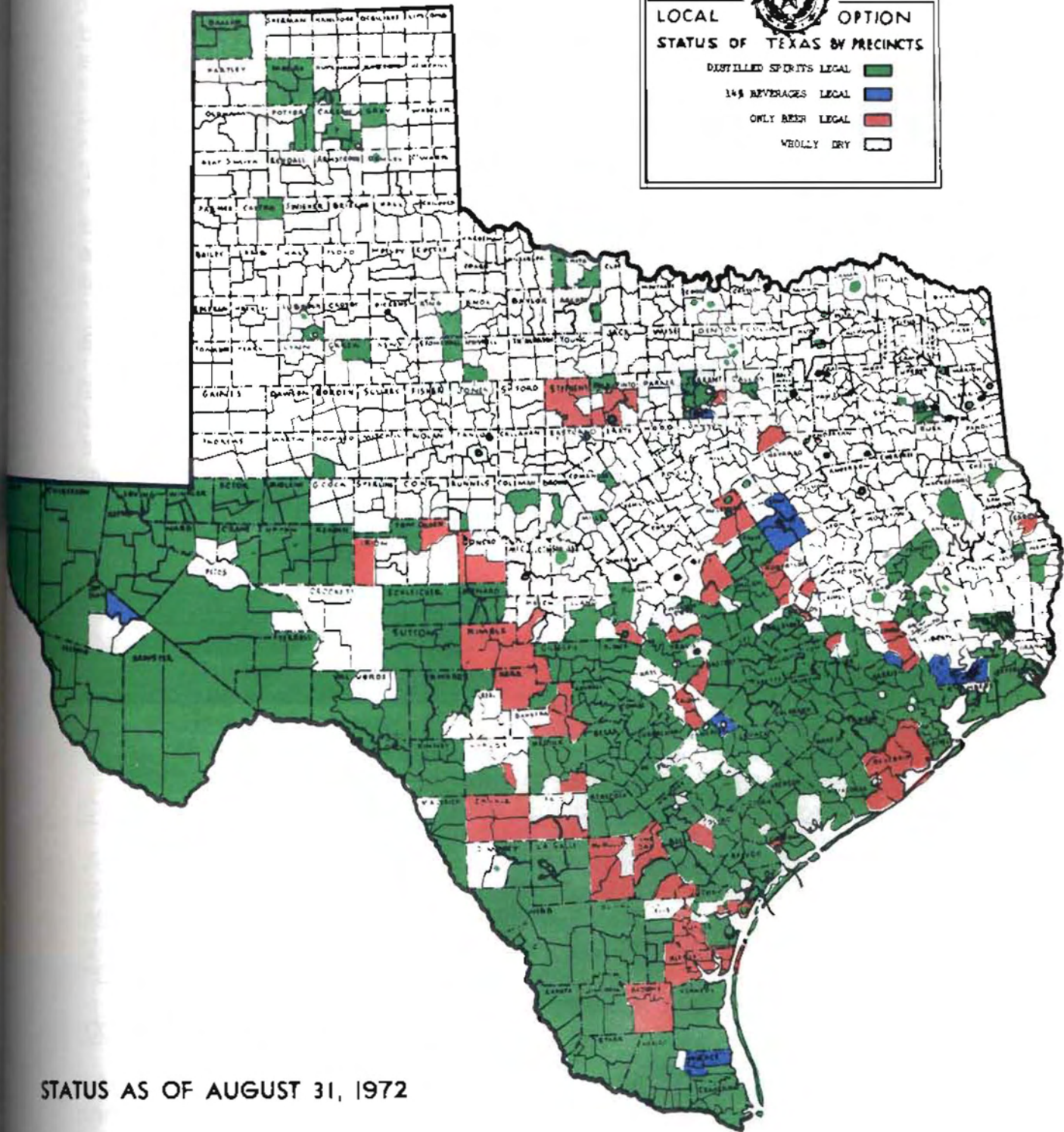

## LOCAL OPTION ELECTIONS

There were fifty-four local option elections during the fiscal year ending August 31, 1972. Nine elections were called to legalize the sale of beer for off-premise consumption only; seven remained "Dry" and two became "Wet". Twenty-two elections were called to legalize the sale of all alcoholic beverages for off-premise consumption only; fifteen remained "Dry" and seven became "Wet". Three elections were called to legalize the sale of all alcoholic beverages; two remained "Dry" and one became "Wet". Twelve elections were called to legalize the sale of all alcoholic beverages including mixed beverages; four remained "Dry" and eight became "Wet". Two elections were called to legalize the sale of mixed beverages and both became "Wet". One election was called to legalize the sale of beer and wine and the area became "Wet". One election was called to prohibit the legal sale of all alcoholic beverages for off-premise consumption only and the area remained "Wet". Four elections were called to legalize the sale of beer; one remained "Dry" and three became "Wet".

The voting for the fiscal year:

### ANGELINA COUNTY

Justice Precinct No. 4, Angelina County, on February 5, 1972, voted 227 "For the legal sale of all alcoholic beverages for off-premise consumption only" and 338 "Against the legal sale of all alcoholic beverages for off-premise consumption only." This precinct was "Dry" before the election was held and remained "Dry".

Justice Precinct No. 4, Angelina County, on April 8, 1972, voted 295 "For the legal sale of all alcoholic beverages for off-premise consumption only" and 482 "Against the legal sale of all alcoholic beverages for off-premise consumption only." This precinct was "Dry" before the election was held and remained "Dry".

### BANDERA COUNTY

Justice Precinct No. 1, Bandera County, on October 9, 1971, voted 382 "For the legal sale of all alcoholic beverages including mixed beverages" and 103 "Against the legal sale of all alcoholic beverages including mixed beverages." This precinct was "Wet" for beer only before the election was held and became "Wet" for the legal sale of all alcoholic beverages including mixed beverages.

## BELL COUNTY

The City of Morgan's Point Resort City, Bell County, on September 28, 1971, voted 40 "For the legal sale of all alcoholic beverages including mixed beverages" and 28 "Against the legal sale of all alcoholic beverages including mixed beverages." Morgan's Point Resort City was "Dry" before the election was held and became "Wet" for the legal sale of all alcoholic beverages including mixed beverages.

The City of Nolanville, Bell County, on November 6, 1971, voted 54 "For the legal sale of all alcoholic beverages for off-premise consumption only" and 85 "Against the legal sale of all alcoholic beverages for off-premise consumption only." Nolanville was "Dry" before the election was held and remained "Dry".

## BRAZOS COUNTY

The City of College Station, Brazos County, on October 9, 1971, voted 1,080 "For the legal sale of all alcoholic beverages including mixed beverages" and 927 "Against the legal sale of all alcoholic beverages including mixed beverages." College Station was "Wet" for the legal sale of beer only before the election was held and became "Wet" for the legal sale of all alcoholic beverages including mixed beverages.

## BURNET COUNTY

Justice Precinct No. 1, Burnet County, on August 8, 1972, voted 572 "For the legal sale of beer for off-premise consumption only" and 548 "Against the legal sale of beer for off-premise consumption only." This precinct was "Dry" before the election was held and became "Wet" for the legal sale of beer for off-premise consumption only.

## COKE COUNTY

Justice Precinct Nos. 1 and 3, Coke County, on June 6, 1972, voted 251 "For the legal sale of beer for off-premise consumption only" and 334 "Against the legal sale of beer for off-premise consumption only." These precincts were "Dry" before the election was held and remained "Dry".

## COLLIN COUNTY

The City of Plano, Collin County, on June 2, 1972, voted 1,504 "For the legal sale of all alcoholic beverages for off-premise consumption only" and 2,289 "Against the legal sale of all alcoholic beverages for off-premise consumption only." Plano was "Dry" before the election was held and remained "Dry".

## DENTON COUNTY

The Incorporated City of Lake Dallas, Denton County, on July 8, 1972, voted 259 "For the legal sale of all alcoholic beverages for off-premise consumption only" and 243 "Against the legal sale of all alcoholic beverages for off-premise consumption only." Lake Dallas was "Dry" before the election was held and became "Wet" for the legal sale of all alcoholic beverages for off-premise consumption only.

The Incorporated City of Pilot Point, Denton County, on April 8, 1972, voted 345 "For the legal sale of all alcoholic beverages for off-premise consumption only" and 363 "Against the legal sale of all alcoholic beverages for off-premise consumption only." Pilot Point was "Dry" before the election was held and remained "Dry".

## DIMMIT COUNTY

The City of Carrizo Springs, Dimmit County, on November 20, 1971, voted 642 "For the legal sale of all alcoholic beverages including mixed beverages" and 557 "Against the legal sale of all alcoholic beverages including mixed beverages." Carrizo Springs was "Dry" before the election was held and became "Wet" for the legal sale of all alcoholic beverages including mixed beverages.

## DONLEY COUNTY

The City of Howardwick, Donley County, on February 1, 1972, voted 23 "For the legal sale of all alcoholic beverages including mixed beverages" and 0 "Against the legal sale of all alcoholic beverages including mixed beverages." Howardwick was "Dry" before the election was held and became "Wet" for the legal sale of all alcoholic beverages including mixed beverages.

Justice Precinct No. 1, Donley County, on April 11, 1972, voted 191 "For the legal sale of all alcoholic beverages for off-premise consumption only" and 202 "Against the legal sale of all alcoholic beverages for off-premise consumption only." This precinct was "Dry" before the election was held and remained "Dry".

## GRIMES COUNTY

Justice Precinct No. 1, Grimes County, on June 3, 1972, voted 402 "For the legal sale of all alcoholic beverages including mixed beverages" and 238 "Against the legal sale of all alcoholic beverages including mixed beverages." This precinct was "Dry" before the election was held and became "Wet" for the legal sale of all alcoholic beverages including mixed beverages.

Justice Precinct No. 2, Grimes County, on June 3, 1972, voted 139 "For the legal sale of beer for off-premise consumption only" and 273 "Against the legal sale of beer for off-premise consumption only." This precinct was "Dry" before the election was held and remained "Dry".

Justice Precinct No. 7, Grimes County, on July 8, 1972, voted 74 "For the legal sale of beer for off-premise consumption only" and 224 "Against the legal sale of beer for off-premise consumption only." This precinct was "Dry" before the election was held and remained "Dry".

#### HAYS COUNTY

Justice Precinct No. 1, Hays County, on April 8, 1972, voted 1,709 "For the legal sale of all alcoholic beverages including mixed beverages" and 1,314 "Against the legal sale of all alcoholic beverages including mixed beverages." This precinct was "Wet" for all alcoholic beverages for off-premise consumption only before the election was held and became "Wet" for the legal sale of all alcoholic beverages including mixed beverages.

#### HENDERSON COUNTY

The Incorporated City of Tool, Henderson County, on July 15, 1972, voted 120 "For the legal sale of all alcoholic beverages for off-premise consumption only" and 208 "Against the legal sale of all alcoholic beverages for off-premise consumption only." Tool was "Dry" before the election was held and remained "Dry".

#### HUNT COUNTY

The City of Commerce, Hunt County, on April 8, 1972, voted 1,491 "For the legal sale of all alcoholic beverages" and 1,169 "Against the legal sale of all alcoholic beverages." Commerce was "Dry" before the election was held and became "Wet" for the legal sale of all alcoholic beverages.

The Incorporated City of West Tawakoni, Hunt County, on November 2, 1971, voted 126 "For the legal sale of beer and wine" and 99 "Against the legal sale of beer and wine." West Tawakoni was "Wet" for the legal sale of all alcoholic beverages for off-premise consumption only before the election was held and became "Wet" for the legal sale of beer and wine.

The Incorporated City of West Tawakoni, Hunt County, on November 9, 1971, voted 77 "For prohibiting the legal sale of all alcoholic beverages for off-premise consumption only" and 178 "Against the prohibiting of the legal sale of all alcoholic beverages for off-premise consumption only." West Tawakoni was "Wet" for the legal sale of all alcoholic beverages for off-premise consumption only before the election was held and remained "Wet".

#### IRION COUNTY

Justice Precinct No. 3, Irion County, on April 8, 1972, voted 57 "For the legal sale of beer only" and 12 "Against the legal sale of beer only." This precinct was "Dry" before the election was held and became "Wet" for the legal sale of beer only.

#### LAMAR COUNTY

The Incorporated City of Paris, Lamar County, on April 11, 1972, voted 2,992 "For the legal sale of all alcoholic beverages for off-premise consumption only" and 3,948 "Against the legal sale of all alcoholic beverages for off-premise consumption only." Paris was "Dry" before the election was held and remained "Dry".

The City of Toco, Lamar County, on January 31, 1972, voted 29 "For the legal sale of all alcoholic beverages for off-premise consumption only" and 3 "Against the legal sale of all alcoholic beverages for off-premise consumption only." Toco was "Dry" before the election was held and became "Wet" for the legal sale of all alcoholic beverages for off-premise consumption only.

#### LIVE OAK COUNTY

Justice Precinct No. 5, Live Oak County, on February 5, 1972, voted 88 "For the legal sale of beer only" and 20 "Against the legal sale of beer only." This precinct was "Dry" before the election was held and became "Wet" for the legal sale of beer only.

#### LUBBOCK COUNTY

The Incorporated City of Lubbock, Lubbock County, on April 8, 1972, voted 22,200 "For the legal sale of mixed beverages" and 20,296 "Against the legal sale of mixed beverages." Lubbock was "Dry" before the election was held and became "Wet" for the legal sale of mixed beverages.

#### MC LENNAN COUNTY

The City of McGregor, McLennan County, on August 5, 1972, voted 585 "For the legal sale of all alcoholic beverages for off-premise consumption only" and 718 "Against the legal sale of all alcoholic beverages for off-premise consumption only." McGregor was "Dry" before the election was held and remained "Dry".



The City of Northcrest, McLennan County, on June 10, 1972, voted 178 "For the legal sale of all alcoholic beverages including mixed beverages" and 143 "Against the legal sale of all alcoholic beverages including mixed beverages." Northcrest was "Wet" for the legal sale of beer only before the election was held and became "Wet" for the legal sale of all alcoholic beverages including mixed beverages.

#### MARION COUNTY

Justice Precinct No. 5, Marion County, on November 30, 1971, voted 72 "For the legal sale of all alcoholic beverages including mixed beverages" and 153 "Against the legal sale of all alcoholic beverages including mixed beverages." This precinct was "Dry" before the election was held and remained "Dry".

#### MAVERICK COUNTY

Justice Precinct No. 3, Maverick County, on December 4, 1971, voted 42 "For the legal sale of all alcoholic beverages" and 150 "Against the legal sale of all alcoholic beverages." This precinct was "Dry" before the election was held and remained "Dry".

#### MONTGOMERY COUNTY

The Incorporated City of Magnolia, Montgomery County, on August 5, 1972, voted 56 "For the legal sale of beer for off-premise consumption only" and 106 "Against the legal sale of beer for off-premise consumption only." Magnolia was "Dry" before the election was held and remained "Dry".

Justice Precinct No. 2, Montgomery County, on August 5, 1972, voted 546 "For the legal sale of all alcoholic beverages including mixed beverages" and 577 "Against the legal sale of all alcoholic beverages including mixed beverages." This precinct was "Dry" before the election was held and remained "Dry".

Justice Precinct No. 3, Montgomery County, on September 4, 1971, voted 593 "For the legal sale of mixed beverages" and 477 "Against the legal sale of mixed beverages." This precinct was "Wet" for the legal sale of beer and wine before the election was held and became "Wet" for the legal sale of mixed beverages.

#### NACOGDOCHES COUNTY

Justice Precinct No. 2, Nacogdoches County, on November 9, 1971, voted 270 "For the legal sale of all alcoholic beverages for off-premise consumption only" and 599 "Against the legal sale of all alcoholic beverages for off-premise consumption only." This precinct was "Dry" before the election was held and remained "Dry".

## NEWTON COUNTY

Justice Precinct No. 3, Newton County, on June 2, 1972, voted 503 "For the legal sale of all alcoholic beverages for off-premise consumption only" and 432 "Against the legal sale of all alcoholic beverages for off-premise consumption only." This precinct was "Dry" before the election was held and became "Wet" for the legal sale of all alcoholic beverages for off-premise consumption only.

## POLK COUNTY

The Incorporated City of Onalaska, Polk County, on November 8, 1971, voted 32 "For the legal sale of all alcoholic beverages including mixed beverages" and 33 "Against the legal sale of all alcoholic beverages including mixed beverages." Onalaska was "Dry" before the election was held and remained "Dry".

The Incorporated City of Onalaska, Polk County, on April 10, 1972, voted 42 "For the legal sale of all alcoholic beverages" and 42 "Against the legal sale of all alcoholic beverages." Onalaska was "Dry" before the election was held and remained "Dry".

The Incorporated City of Onalaska, Polk County, on August 3, 1972, voted 60 "For the legal sale of all alcoholic beverages for off-premise consumption only" and 50 "Against the legal sale of all alcoholic beverages for off-premise consumption only." Onalaska was "Dry" before the election was held and became "Wet" for the legal sale of all alcoholic beverages for off-premise consumption only.

## RANDALL COUNTY

Justice Precinct No. 4, Randall County, on September 8, 1971, voted 3,279 "For the legal sale of all alcoholic beverages including mixed beverages" and 4,019 "Against the legal sale of all alcoholic beverages including mixed beverages." This precinct was "Dry" before the election was held and remained "Dry".

## ROBERTSON COUNTY

Justice Precinct No. 3, Robertson County, on November 6, 1971, voted 211 "For the legal sale of beer for off-premise consumption only" and 365 "Against the legal sale of beer for off-premise consumption only." This precinct was "Dry" before the election was held and remained "Dry".

### SABINE COUNTY

Justice Precinct No. 5, Sabine County, on August 5, 1972, voted 133 "For the legal sale of beer only" and 103 "Against the legal sale of beer only." This precinct was "Dry" before the election was held and became "Wet" for the legal sale of beer only.

### SAN PATRICIO COUNTY

Justice Precinct No. 5, San Patricio County, on September 4, 1971, voted 413 "For the legal sale of beer for off-premise consumption only" and 356 "Against the legal sale of beer for off-premise consumption only." This precinct was "Dry" before the election was held and became "Wet" for the legal sale of beer for off-premise consumption only.

### SAN SABA COUNTY

Justice Precinct No. 1, San Saba County, on August 12, 1972, voted 741 "For the legal sale of all alcoholic beverages for off-premise consumption only" and 534 "Against the legal sale of all alcoholic beverages for off-premise consumption only." This precinct was "Dry" before the election was held and became "Wet" for the legal sale of all alcoholic beverages for off-premise consumption only.

### SCURRY COUNTY

The City of Snyder, Scurry County, on August 5, 1972, voted 1,529 "For the legal sale of all alcoholic beverages for off-premise consumption only" and 1,703 "Against the legal sale of all alcoholic beverages for off-premise consumption only." Snyder was "Dry" before the election was held and remained "Dry".

### SHELBY COUNTY

Justice Precinct No. 1, Shelby County, on June 7, 1972, voted 1,494 "For the legal sale of all alcoholic beverages for off-premise consumption only" and 1,444 "Against the legal sale of all alcoholic beverages for off-premise consumption only." This precinct was "Dry" before the election was held and became "Wet" for the legal sale of all alcoholic beverages for off-premise consumption only.

Justice Precinct No. 2, Shelby County, on August 1, 1972, voted 465 "For the legal sale of all alcoholic beverages for off-premise consumption only" and 497 "Against the legal sale of all alcoholic beverages for off-premise consumption only." This precinct was "Dry" before the election was held and remained "Dry".

Justice Precinct No. 5, Shelby County, on April 29, 1972, voted 349 "For the legal sale of all alcoholic beverages for off-premise consumption only" and 637 "Against the legal sale of all alcoholic beverages for off-premise consumption only." This precinct was "Dry" before the election was held and remained "Dry".

#### TITUS COUNTY

The City of Winfield, Titus County, on April 8, 1972, voted 55 "For the legal sale of all alcoholic beverages for off-premise consumption only" and 132 "Against the legal sale of all alcoholic beverages for off-premise consumption only." Winfield was "Dry" before the election was held and remained "Dry".

#### WALKER COUNTY

The City of Huntsville, Walker County, on December 7, 1971, voted 1,937 "For the legal sale of all alcoholic beverages for off-premise consumption only" and 1,178 "Against the legal sale of all alcoholic beverages for off-premise consumption only." Huntsville was "Dry" before the election was held and became "Wet" for the legal sale of all alcoholic beverages for off-premise consumption only.

The City of Riverside, Walker County, on September 4, 1971, voted 25 "For the legal sale of beer for off-premise consumption only" and 52 "Against the legal sale of beer for off-premise consumption only." Riverside was "Dry" before the election was held and remained "Dry".

Justice Precinct No. 4, Walker County, on October 9, 1971, voted 210 "For the legal sale of beer for off-premise consumption only" and 259 "Against the legal sale of beer for off-premise consumption only." This precinct was "Dry" before the election was held and remained "Dry".

#### WILSON COUNTY

Justice Precinct No. 3, Wilson County, on October 9, 1971, voted 83 "For the legal sale of beer only" and 89 "Against the legal sale of beer only." This precinct was "Dry" before the election was held and remained "Dry".

#### WISE COUNTY

The City of Bridgeport, Wise County, on November 6, 1971, voted 208 "For the legal sale of all alcoholic beverages for off-premise consumption only" and 559 "Against the legal sale of all alcoholic beverages for off-premise consumption only." Bridgeport was "Dry" before the election was held and remained "Dry".
