### LOCAL OPTION ELECTIONS

There have been fifty-five local option elections during the fiscal year ending August 31, 1973. Nineteen elections were called to legalize the sale of all alcoholic beverages for off-premise consumption only; fifteen remained "Dry" and four became "Wet"; however, one of these elections was invalidated and the area reverted to a "Dry" status. Two elections were called to legalize the sale of all alcoholic beverages except mixed beverages; both areas became "Wet". Eleven elections were called to legalize the sale of all alcoholic beverages including mixed beverages; three remained "Dry", six became "Wet", one remained "Wet" for the legal sale of beer and wine only and one remained "Wet" for the legal sale of all alcoholic beverages for off-premise consumption only. Five elections were called to legalize the sale of mixed beverages; all became "Wet". Eight elections were called to legalize the sale of beer for off-premise consumption only; three remained "Dry" and five became "Wet". Three elections were called to legalize the sale of wine and beer for off-premise consumption only; one remained "Dry" and two became "Wet"; however, one of these elections was invalidated and the area reverted to a "Dry" status. Two elections were called to legalize the sale of beer; one remained "Dry" and one became "Wet" One election was called to legalize the sale of wine and beer; this area remained "Dry". One election was called to prohibit the legal sale of wine and beer for off-premise consumption only; this area remained "Wet". One election was called to prohibit the legal sale of all alcoholic beverages for off-premise consumption only; this area became "Dry"; however, the election was invalidated and the area reverted to a "Wet" status. One election was called to prohibit the legal sale of all alcoholic beverages except mixed beverages; this area remained "Wet" One election was called to prohibit the legal sale of beer; this area became "Dry".

The voting for the fiscal year:

#### BELL COUNTY

The City of Nolanville, Bell County, on December 9, 1972, voted 88 "For the legal sale of all alcoholic beverages for off-premise consumption only" and 91 "Against the legal sale of all alcoholic beverages for off-premise consumption only." Nolanville was "Dry" before the election was held and remained "Dry". The City of Nolanville, Bell County, on May 5, 1973, voted 97 "For the legal sale of all alcoholic beverages for off-premise consumption only" and 94 "Against the legal sale of all alcoholic beverages for offpremise consumption only." Nolanville was "Dry" before the election was held and became "Wet" for the legal sale of all alcoholic beverages for off-premise consumption only; however, this election was invalidated by the 169th District Court, Bell County, on June 29, 1973, because it was the second election held on the same issue within a year. Nolanville reverted to a "Dry" status.

### BRAZOS COUNTY

Brazos County, on November 7, 1972, voted 10,319 "For the legal sale of all alcoholic beverages including mixed beverages" and 8,365 "Against the legal sale of all alcoholic beverages including mixed beverages." Brazos County was partially "Wet" for the legal sale of all alcoholic beverages including mixed beverages before the election was held and became wholly "Wet".

### BURNET COUNTY

The City of Granite Shoals, Burnet County, on March 10, 1973, voted 59 "For the legal sale of all alcoholic beverages except mixed beverages" and 24 "Against the legal sale of all alcoholic beverages except mixed beverages." Granite Shoals was "Dry" before the election was held and became "Wet" for the legal sale of all alcoholic beverages except mixed beverages.

### CHEROKEE COUNTY

The Incorporated City of New Summerfield, Cherokee County, on October 7, 1973, voted 73 "For the legal sale of all alcoholic beverages for off-premise consumption only" and 103 "Against the legal sale of all alcoholic beverages for off-premise consumption only." New Summerfield was "Dry" before the election was held and remained "Dry".

### COKE COUNTY

Justice Precinct No. 1, Coke County, on August 4, 1973, voted 191 "For the legal sale of beer for off-premise consumption only" and 283 "Against the legal sale of beer for off-premise consumption only." This precinct was "Dry" before the election was held and remained "Dry".

### COLLIN COUNTY

The Incorporated City of Fairview, Collin County, on July 7, 1973, voted 58 "For the legal sale of all alcoholic beverages for off-premise consumption only" and 161 "Against the legal sale of all alcoholic beverages for off-premise consumption only." Fairview was "Dry" before the election was held and remained "Dry".

## COOKE COUNTY

Justice Precinct No. 3, Cooke County, on November 8, 1972, voted 68 "For the legal sale of beer for off-premise consumption only" and 294 "Against the legal sale of beer for off-premise consumption only." This precinct was "Dry" before the election was held and remained "Dry".

## DALLAS COUNTY

Justice Precinct No. 2, Dallas County, on November 7, 1972, voted 11,652 "For the legal sale of all alcoholic beverages including mixed beverages" and 17,286 "Against the legal sale of all alcoholic beverages including mixed beverages." This precinct was "Dry" before the election was held and remained "Dry".

Justice Precinct No. 6, Dallas County, on February 6, 1973, voted 4,514 "For the legal sale of all alcoholic beverages including mixed beverages" and 5,740 "Against the legal sale of all alcoholic beverages including mixed beverages." This precinct was "Dry" before the election was held and remained "Dry".

### DENTON COUNTY

The Incorporated City of Hickory Creek, Denton County, on December 9, 1972, voted 56 "For the legal sale of all alcoholic beverages for off-premise consumption only" and 106 "Against the legal sale of all alcoholic beverages for off-premise consumption only." Hickory Creek was "Dry" before the election was held and remained "Dry".

The Incorporated City of Lake Dallas, Denton County, on November 18, 1972, voted 206 "For prohibiting the legal sale of wine and beer for off-premise consumption only" and 367 "Against prohibiting the legal sale of wine and beer for off-premise consumption only." Lake Dallas was "Wet" for the legal sale of all alcoholic beverages for off-premise consumption only before the election was held and remained "Wet".

The Incorporated City of Lewisville, Denton County, on January 6, 1973, voted 1,006 "For the legal sale of all alcoholic beverages for off-premise consumption only" and 1,151 "Against the legal sale of all alcoholic beverages for off-premise consumption only." Lewisville was "Dry" before the election was held and remained "Dry".

The Incorporated City of Lincoln Park, Denton County, on January 6, 1973, voted 8 "For the legal sale of mixed beverages" and 0 "Against the legal sale of mixed beverages." Lincoln Park was "Dry" before the election was held and became "Wet" for the legal sale of mixed beverages.

## ECTOR COUNTY

Ector County, on November 7, 1972, voted 13, 575 "For the legal sale of mixed beverages" and 12, 340 "Against the legal sale of mixed beverages. "Ector County was partially "Wet" for the legal sale of mixed beverages before the election was held and became wholly "Wet" for the legal sale of mixed beverages.

### GONZALES COUNTY

The City of Nixon, Gonzales County, on July 7, 1973, voted 228 "For prohibiting the legal sale of all alcoholic beverages except mixed beverages" and 239 "Against prohibiting the legal sale of all alcoholic beverages except mixed beverages." Nixon was "Wet" for the legal sale of all alcoholic beverages except mixed beverages before the election was held and remained "Wet".

### HENDERSON COUNTY

The Incorporated City of Berryville, Henderson County, on March 10, 1973, voted 70 "For the legal sale of beer for off-premise consumption only" and 15 "Against the legal sale of beer for off-premise consumption only." Berryville was "Dry" before the election was held and became "Wet" for the legal sale of beer for off-premise consumption only.

The Incorporated City of Seven Points, Henderson County, on September 9, 1972, voted 44 "For the legal sale of all alcoholic beverages in the newly annexed portion of the city" and 3 "Against the legal sale of all alcoholic beverages in the newly annexed portion of the city." Seven Points was partially "Wet" for the legal sale of all alcoholic beverages before the election was held and became wholly "Wet" for the legal sale of all alcoholic beverages.

### HOOD COUNTY

Justice Precinct No. 3, Hood County, on June 9, 1973, voted 242 "For the legal sale of all alcoholic beverages for off-premise consumption only" and 415 "Against the legal sale of all alcoholic beverages for off-premise consumption only." This precinct was "Dry" before the election was held and remained "Dry".

Justice Precinct No. 4, Hood County, on May 5, 1973, voted 155 "For the legal sale of all alcoholic beverages for off-premise consumption only" and 265 "Against the legal sale of all alcoholic beverages for off-premise consumption only." This precinct was "Dry" before the election was held and remained "Dry".

### JEFF DAVIS COUNTY

Justice Precinct No. 2, Jeff Davis County, on June 9, 1972, voted 33 "For the legal sale of all alcoholic beverages including mixed beverages" and 40 "Against the legal sale of all alcoholic beverages including mixed beverages." This precinct was "Wet" for the legal sale of wine and beer only before the election was held and remained "Wet" for the legal sale of wine and beer only.

### JEFFERSON COUNTY

The City of Pear Ridge, Jefferson County, on June 5, 1973, voted 390 "For the legal sale of all alcoholic beverages for off-premise consumption only" and 197 "Against the legal sale of all alcoholic beverages for off-premise consumption only." Pear Ridge was "Dry" before the election was held and became "Wet" for the legal sale of all alcoholic beverages for off-premise consumption only.

## LAMB COUNTY

The City of Littlefield, Lamb County, on November 7, 1972, voted 1,101 "For the legal sale of all alcoholic beverages including mixed beverages" and 1,134 "Against the legal sale of all alcoholic beverages including mixed beverages." Littlefield was "Dry" before the election was held and remained "Dry".

The City of Littlefield, Lamb County, on January 6, 1973, voted 907 "For the legal sale of all alcoholic beverages for off-premise consumption only" and 1,027 "Against the legal sale of all alcoholic beverages for off-premise consumption only." Littlefield was "Dry" before the election was held and remained "Dry".

## LAMPASAS COUNTY

The City of Lampasas, Lampasas County, on September 9, 1972, voted 870 "For the legal sale of all alcoholic beverages for off-premise consumption only" and 872 "Against the legal sale of all alcoholic beverages for off-premise consumption only." Lampasas was "Dry" before the election was held and remained "Dry".

Justice Precinct No. 1, Lampasas County, on April 7, 1973, voted 1,114 "For the legal sale of all alcoholic beverages for off-premise consumption only" and 1,202 "Against the legal sale of all alcoholic beverages for off-premise consumption only." This precinct was "Dry" before the election was held and remained "Dry".

## LIBERTY COUNTY

Justice Precinct No. 5, Liberty County, on April 7, 1973, voted 247 "For the legal sale of all alcoholic beverages for off-premise consumption only" and 163 "Against the legal sale of all alcoholic beverages for off-premise consumption only." This precinct was "Dry" before the election was held and became "Wet" for the legal sale of all alcoholic beverages for off-premise consumption only.

## MC LENNAN COUNTY

The Incorporated City of Waco, McLennan County, on November 7, 1972, voted 16,939 "For the legal sale of all alcoholic beverages including mixed beverages" and 12,478 "Against the legal sale of all alcoholic beverages including mixed beverages." Waco was "Wet" for the legal sale of beer only before the election was held and became "Wet" for the legal sale of all alcoholic beverages including mixed beverages.

The Incorporated City of Hewitt, McLennan County, on November 4, 1972, voted 119 "For prohibiting the legal sale of beer" and 56 "Against prohibiting the legal sale of beer." Hewitt was "Wet" for the legal sale of beer before the election was held and became "Dry".

## MONTGOMERY COUNTY

Justice Precinct No. 1, Montgomery County, on September 9, 1972, voted 1,434 "For the legal sale of all alcoholic beverages including mixed beverages" and 836 "Against the legal sale of all alcoholic beverages including mixed beverages." This precinct was "Wet" for the legal sale of beer before the election was held and became "Wet" for the legal sale of all alcoholic beverages including mixed beverages.

## NAVARRO COUNTY

The Incorporated City of Angus, Navarro County, on October 28, 1972, voted 73 "For the legal sale of wine and beer for off-premise consumption only" and 70 "Against the legal sale of wine and beer for offpremise consumption only. " Angus was "Dry" before the election was held and became "Wet" for the legal sale of wine and beer for offpremise consumption only. Within thirty days after this election a suit was filed in the District Court of Navarro County, 13th Judicial District, to contest this election and to have same declared void on the grounds that the election involved an alcoholic beverage classified as liquor, namely wine, and was held within a period of less than eighteen months after incorporation, as prohibited in Article 666-40b of the Penal Code of the State of Texas. In a judgment dated January 29, 1973, the District Court of Navarro County ruled and declared the election held in the Incorporated City of Angus, Navarro County, on October 28, 1972, void, invalid and of no force and effect, and Angus reverted to a "Dry" status.

The City of Angus, Navarro County, on July 7, 1973, voted 95 "For the legal sale of beer for off-premise consumption only" and 82 "Against the legal sale of beer for off-premise consumption only." Angus was "Dry" before the election was held and became "Wet" for the legal sale of beer for off-premise consumption only.

## NEWTON COUNTY

The Incorporated City of Newton, Newton County, on October 7, 1972, voted 289 "For prohibiting the legal sale of all alcoholic beverages for off-premise consumption only" and 280 "Against prohibiting the legal sale of all alcoholic beverages for off-premise consumption only." Newton was "Wet" for the legal sale of all alcoholic beverages for off-premise consumption only before the election was held and became "Dry". This election was contested in the District Court of Newton County, as the ballots used in the election read "For the legal sale of all alcoholic beverages for off-premise consumption only" and "Against the sale of all alcoholic beverages for off-premise consumption only. " The District Court of Newton County ruled the election was valid. The ruling was appealed to the Court of Civil Appeals of the Ninth Supreme Judicial District of Texas and that court affirmed the decision of the trial court Appellant made a motion for rehearing in the Court of Civil Appeals which resulted in an opinion delivered May 17, 1973, in which the Court of Civil Appeals of the Ninth Supreme Judicial District reversed the judgment of the trial court and declared the election to be invalid because the word "legal" was missing from the second statement on the ballot. The order canvassing and declarint the results of said election was set aside and held for naught by the Court and Newton reverted to a "Wet" status for the legal sale of all alcoholic beverages for off-premise consumption only.

### NUECES COUNTY

Justice Precinct No. 6, Nueces County, on November 7, 1972, voted 1,951 "For the legal sale of all alcoholic beverages including mixed beverages" and 1,895 "Against the legal sale of all alcoholic beverages including mixed beverages." This precinct was "Dry" before the election was held and became "Wet" for the legal sale of all alcoholic beverages including mixed beverages.

### PANOLA COUNTY

The City of Carthage, Panola County, on November 4, 1972, voted 722 "For the legal sale of all alcoholic beverages for off-premise consumption only" and 1,140 "Against the legal sale of all alcoholic beverages for off-premise consumption only." Carthage was "Dry" before the election was held and remained "Dry". Justice Precinct No. 3, Panola County, on September 9, 1972, voted 261 "For the legal sale of all alcoholic beverages for off-premise consumption only" and 526 "Against the legal sale of all alcoholic beverages for off-premise consumption only." This precinct was "Dry" before the election was held and remained "Dry".

### POTTER COUNTY

Justice Precinct No. 1, Potter County, on November 7, 1972, voted 9,499 "For the legal sale of mixed beverages" and 8,496 "Against the legal sale of mixed beverages." This precinct was "Wet" for the legal sale of all alcoholic beverages before the election was held and became "Wet" for the legal sale of mixed beverages.

## RAINS COUNTY

The City of East Tawakoni, Rains County, on December 8, 1972, voted 42 "For the legal sale of all alcoholic beverages including mixed beverages" and 56 "Against the legal sale of all alcoholic beverages including mixed beverages." East Tawakoni was "Wet" for the legal sale of all alcoholic beverages for off-premise consumption only before the election was held and remained "Wet" for the legal sale of all alcoholic beverages for off-premise consumption only.

### RANDALL COUNTY

Justice Precinct No. 3, Randall County, on July 7, 1973, voted 72 "For the legal sale of all alcoholic beverages including mixed beverages" and 33 "Against the legal sale of all alcoholic beverages including mixed beverages." This precinct was "Dry" before the election was held and became "Wet" for the legal sale of all alcoholic beverages including mixed beverages.

Justice Precinct No. 4, Randall County, on November 7, 1972, voted 8,721 "For the legal sale of all alcoholic beverages including mixed beverages" and 7,612 "Against the legal sale of all alcoholic beverages including mixed beverages." This precinct was "Dry" before the election was held and became "Wet" for the legal sale of all al-coholic beverages including mixed beverages.

### SAN AUGUSTINE COUNTY

Justice Precinct No. 2, San Augustine County, on November 7, 1972, voted 275 "For the legal sale of all alcoholic beverages for off-premise consumption only" and 209 "Against the legal sale of all alcoholic beverages for off-premise consumption only." This precinct was "Dry" before the election was held and became "Wet" for the legal sale of all alcoholic beverages for off-premise consumption only.

## SCURRY COUNTY

Justice Precinct No. 1, Scurry County, on December 9, 1972, voted 1,064 "For the legal sale of all alcoholic beverages for off-premise consumption only" and 2,116 "Against the legal sale of all alcoholic beverages for off-premise consumption only." This precinct was "Dry" before the election was held and remained "Dry".

## SOMERVELL COUNTY

The City of Glen Rose, Somervell County, on September 9, 1972, voted 316 "For the legal sale of beer for off-premise consumption only" and 319 "Against the legal sale of beer for off-premise consumption only." Glen Rose was "Dry" before the election was held and remained "Dry".

The City of Glen Rose, Somervell County, on November 4, 1972, voted 413 "For the legal sale of wine and beer for off-premise consumption only" and 392 "Against the legal sale of wine and beer for off-premise consumption only." Glen Rose was "Dry" before the election was held and became "Wet" for the legal sale of wine and beer for off-premise consumption only.

## TARRANT COUNTY

Justice Precinct No. 3, Tarrant County, on July 10, 1973, voted 6, 383 "For the legal sale of beer for off-premise consumption only" and 5,998 "Against the legal sale of beer for off-premise consumption only." This precinct was "Dry" before the election was held and became "Wet" for the legal sale of beer for off-premise consumption only.

Justice Precinct No. 3, Tarrant County, on July 10, 1973, voted 6, 277 "For the legal sale of mixed beverages" and 6, 077 "Against the legal sale of mixed beverages." This precinct was "Dry" before the election was held and became "Wet" for the legal sale of mixed beverages.

## TRAVIS COUNTY

Justice Precinct No. 1, Travis County, on July 17, 1973, voted 78 "For the legal sale of beer for off-premise consumption only" and 54 "Against the legal sale of beer for off-premise consumption only." This precinct was "Dry" before the election was held and became "Wet" for the legal sale of beer for off-premise consumption only.

## TYLER COUNTY

Justice Precinct No. 4, Tyler County, on November 7, 1972, voted 467 "For the legal sale of all alcoholic beverages for off-premise consumption only" and 905 "Against the legal sale of all alcoholic beverages for off-premise consumption only." This precinct was "Dry" before the election was held and remained "Dry".

## UVALDE COUNTY

Justice Precinct No. 2, Uvalde County, on February 3, 1973, voted 258 "For the legal sale of wine and beer" and 307 "Against the legal sale of wine and beer." This precinct was "Dry" before the election was held and remained "Dry".

## WALKER COUNTY

The City of Huntsville, Walker County, on October 31, 1972, voted 1,214 "For the legal sale of mixed beverages" and 930 "Against the legal sale of mixed beverages." Huntsville was "Wet" for the legal sale of all alcoholic beverages for off-premise consumption only before the election was held and became "Wet" for the legal sale of mixed beverages.

## WILLIAMSON COUNTY

Justice Precinct No. 1, Williamson County, on January 6, 1973, voted 803 "For the legal sale of wine and beer for off-premise consumption only" and 1,177 "Against the legal sale of wine and beer for off-premise consumption only." This precinct was "Dry" before the election was held and remained "Dry".

Justice Precinct No. 3, Williamson County, on November 4, 1972, voted 310 "For the legal sale of beer for off-premise consumption only" and 284 "Against the legal sale of beer for off-premise consumption only." This precinct was "Dry" before the election was held and became "Wet" for the legal sale of beer for off-premise consumption only.

## WILSON COUNTY

Justice Precinct No. 3, Wilson County, on November 7, 1972, voted 181 "For the legal sale of beer only" and 152 "Against the legal sale of beer only." This precinct was "Dry" before the election was held and became "Wet" for the legal sale of beer only.

Justice Precinct No. 4, Wilson County, on July 7, 1973, voted 49 "For the legal sale of beer only" and 70 "Against the legal sale of beer only." This precinct was "Dry" before the election was held and remained "Dry".

## WOOD COUNTY

The Incorporated City of Yantis, Wood County, on October 7, 1972, voted 18 "For the legal sale of all alcoholic beverages for off-premise consumption only" and 98 "Against the legal sale of all alcoholic beverages for off-premise consumption only." Yantis was "Dry" before the election was held and remained "Dry".
