## LOCAL OPTION ELECTIONS

There have been forty-five local option elections during the fiscal year ending August 31, 1974. Ten elections were called to legalize the sale of all alcoholic beverages including mixed beverages; six remained "Dry" and four became "Wet". Three elections were called to legalize the sale of all alcoholic beverages except mixed beverages; one remained "Dry" and two became "Wet". Twelve elections were called to legalize the sale of all alcoholic beverages for off-premise consumption only; five remained "Dry" and seven became "Wet". One election was called to legalize the sale of beer and wine; this area became "Wet". One election was called to prohibit the legal sale of all alcoholic beverages for off-premise consumption only; this area remained "Wet". Five elections were called to legalize the sale of beer for off-premise consumption only; three remained "Dry" and two became "Wet". Three elections were called to legalize the sale of beer and wine for off-premise consumption only; one area remained "Dry" and two became "Wet". Five elections were called to prohibit the legal sale of beer for off-premise consumption; four became "Dry"; however, three of these elections were ruled invalid and the areas reverted to a "Wet" status; one area became "Wet". Four elections were called to prohibit the legal sale of mixed beverages; all became "Dry"; however, two of these elections were ruled invalid and the areas reverted to a "Wet" status. One election was called to prohibit the legal sale of all alcoholic beverages including mixed beverages; this area became "Dry".

The voting for the fiscal year:

### BANDERA COUNTY

Justice Precinct No. 2, Bandera County, on April 9, 1974, voted 183 "For the legal sale of all alcoholic beverages except mixed beverages" and 63 "Against the legal sale of all alcoholic beverages except mixed beverages." This precinct was "Wet" for the legal sale of beer before the election was held and became "Wet" for the legal sale of all alcoholic beverages except mixed beverages.

### BELL COUNTY

The City of Nolanville, Bell County, on September 8, 1973, voted 151 "For the legal sale of all alcoholic beverages except mixed beverages" and 154 "Against the legal sale of all alcoholic beverages except mixed beverages." Nolanville was "Dry" before the election was held and remained "Dry".

The City of Nolanville, Bell County, on November 3, 1973, voted 196 "For the legal sale of all alcoholic beverages including mixed beverages" and 204 "Against the legal sale of all alcoholic beverages including mixed beverages." Nolanville was "Dry" before the election was held and remained "Dry".

The City of Nolanville, Bell County, on December 11, 1973, voted 242 "For the legal sale of all alcoholic beverages for off-premise consumption only" and 200 "Against the legal sale of all alcoholic beverages for off-premise consumption only." Nolanville was "Dry" before the election was held and became "Wet" for the legal sale of all alcoholic beverages for off-premise consumption only.

#### DAWSON COUNTY

The City of Lamesa, Dawson County, on June 22, 1974, voted 1,220 "For the legal sale of all alcoholic beverages for off-premise consumption only" and 1,730 "Against the legal sale of all alcoholic beverages for off-premise consumption only." Lamesa was "Dry" before the election was held and remained "Dry".

#### DENTON COUNTY

The Incorporated Town of Corral City, Denton County, on October 29, 1973, voted 9 "For the legal sale of all alcoholic beverages including mixed beverages" and 4 "Against the legal sale of all alcoholic beverages including mixed beverages." Corral City was "Dry" before the election was held and became "Wet" for the legal sale of all alcoholic beverages including mixed beverages.

The Incorporated Town of Flower Mound, Denton County, on November 3, 1973, voted 190 "For the legal sale of all alcoholic beverages including mixed beverages" and 305 "Against the legal sale of all alcoholic beverages including mixed beverages." Flower Mound was "Dry" before the election was held and remained "Dry".

The Incorporated Town of Flower Mound, Denton County, on March 9, 1974, voted 229 "For the legal sale of beer and wine for off-premise consumption only" and 333 "Against the legal sale of beer and wine for off-premise consumption only." Flower Mound was "Dry" before the election was held and remained "Dry".

#### GONZALES COUNTY

Justice Precinct No. 2, Gonzales County on December 8, 1973, voted 88 "For the legal sale of beer and wine" and 66 "Against the legal sale of beer and wine." This precinct was "Dry" before the election was held and became "Wet" for the legal sale of beer and wine.

## HAYS COUNTY

Justice Precinct No. 2, Hays County, on December 8, 1973, voted 250 "For the legal sale of all alcoholic beverages for off-premise consumption only" and 214 "Against the legal sale of all alcoholic beverages for off-premise consumption only." This precinct was "Dry" before the election was held and became "Wet" for the legal sale of all alcoholic beverages for off-premise consumption only.

## HENDERSON COUNTY

The City of Gun Barrel City, Henderson County, on January 5, 1974, voted 106 "For the legal sale of all alcoholic beverages for off-premise consumption only" and 36 "Against the legal sale of all alcoholic beverages for off-premise consumption only." Gun Barrel City was "Wet" for the legal sale of beer for off-premise consumption only before the election was held and became "Wet" for the legal sale of all alcoholic beverages for off-premise consumption only.

## JEFF DAVIS COUNTY

Justice Precinct No. 2, Jeff Davis County, on July 6, 1974, voted 73 "For the legal sale of all alcoholic beverages for off-premise consumption only" and 8 "Against the legal sale of all alcoholic beverages for off-premise consumption only." Justice Precinct No. 2 was "Wet" for the legal sale of beer and wine before the election was held and became "Wet" for the legal sale of all alcoholic beverages for off-premise consumption only.

Justice Precinct No. 3, Jeff Davis County, on September 1, 1973, voted 34 "For the legal sale of all alcoholic beverages including mixed beverages" and 69 "Against the legal sale of all alcoholic beverages including mixed beverages." This precinct was "Dry" before the election was held and remained "Dry".

## LEON COUNTY

Justice Precinct No. 8, Leon County, on September 11, 1973, voted 137 "For the legal sale of all alcoholic beverages for off-premise consumption only" and 380 "Against the legal sale of all alcoholic beverages for off-premise consumption only." This precinct was "Dry" before the election was held and remained "Dry".

## LIBERTY COUNTY

The Incorporated City of Cleveland, Liberty County, on June 8, 1974, voted 700 "For the legal sale of all alcoholic beverages including mixed beverages" and 777 "Against the legal sale of all alcoholic beverages including mixed beverages." Cleveland was "Dry" before the election was held and remained "Dry".

Justice Precinct No. 3, Liberty County, on December 18, 1973, voted 202 "For the legal sale of all alcoholic beverages for off-premise consumption only" and 334 "Against the legal sale of all alcoholic beverages for off-premise consumption only." This precinct was "Dry" before the election was held and remained "Dry".

#### MC CULLOCH COUNTY

The Incorporated City of Melvin, McCulloch County, on March 9, 1974, voted 73 "For the legal sale of all alcoholic beverages including mixed beverages" and 41 "Against the legal sale of all alcoholic beverages including mixed beverages." Melvin was "Dry" before the election was held and became "Wet" for the legal sale of all alcoholic beverages including mixed beverages.

#### MONTGOMERY COUNTY

Justice Precinct No. 2, Montgomery County, on November 3, 1973, voted 239 "For the legal sale of all alcoholic beverages including mixed beverages" and 313 "Against the legal sale of all alcoholic beverages including mixed beverages." This precinct was "Dry" before the election was held and remained "Dry".

Justice Precinct No. 3, Montgomery County, on September 8, 1973, voted 611 "For the legal sale of all alcoholic beverages including mixed beverages" and 542 "Against the legal sale of all alcoholic beverages including mixed beverages." This precinct was "Dry" before the election was held and became "Wet" for the legal sale of all alcoholic beverages including mixed beverages.

The Town of Magnolia, Montgomery County, on December 8, 1973, voted 114 "For prohibiting the legal sale of all alcoholic beverages including mixed beverages" and 68 "Against prohibiting the legal sale of all alcoholic beverages including mixed beverages." Magnolia was "Wet" for the legal sale of all alcoholic beverages including mixed beverages before the election was held and became "Dry".

The Town of Magnolia, Montgomery County, on March 9, 1974, voted 101 "For the legal sale of beer and wine for off-premise consumption only" and 79 "Against the legal sale of beer and wine for off-premise consumption only." Magnolia was "Dry" before the election was held and became "Wet" for the legal sale of beer and wine for off-premise consumption only.

#### MOORE COUNTY

The City of Cactus, Moore County, on April 2, 1974, voted 47 "For the legal sale of all alcoholic beverages including mixed beverages" and 32 "Against the legal sale of all alcoholic beverages including mixed beverages." Cactus was "Wet" for the legal sale of all alcoholic beverages for off-premise consumption only before the election was held and became "Wet" for the legal sale of all alcoholic beverages including mixed beverages.

## NACOGDOCHES COUNTY

Justice Precinct No. 1, Nacogdoches County, on September 8, 1973, voted 2,627 "For prohibiting the legal sale of all alcoholic beverages for off-premise consumption only" and 4,663 "Against prohibiting the legal sale of all alcoholic beverages for off-premise consumption only." This precinct was "Wet" for the legal sale of all alcoholic beverages for off-premise consumption only before the election was held and remained "Wet".

## NAVARRO COUNTY

The City of Angus, Navarro County, on May 4, 1974, voted 43 "For the legal sale of beer for off-premise consumption only" and 74 "Against the legal sale of beer for off-premise consumption only." Angus was "Dry" before the election was held and remained "Dry".

The City of Mustang, Navarro County, on October 30, 1973, voted 29 "For the legal sale of beer for off-premise consumption only" and 0 "Against the legal sale of beer for off-premise consumption only." Mustang was "Dry" before the election was held and became "Wet" for the legal sale of beer for off-premise consumption only.

## NEWTON COUNTY

Justice Precinct No. 8, Newton County, on October 6, 1973, voted 256 "For the legal sale of all alcoholic beverages for off-premise consumption only" and 192 "Against the legal sale of all alcoholic beverages for off-premise consumption only." This precinct was "Dry" before the election was held and became "Wet" for the legal sale of all alcoholic beverages for off-premise consumption only.

## NUECES COUNTY

Justice Precinct No. 2, Nueces County, on June 25, 1974, voted 114 "For the legal sale of all alcoholic beverages except mixed beverages" and 13 "Against the legal sale of all alcoholic beverages except mixed beverages." This precinct was "Dry" before the election was held and became "Wet" for the legal sale of all alcoholic beverages except mixed beverages.

## ORANGE COUNTY

The City of Rose City, Orange County, on April 6, 1974, voted 77 "For the legal sale of beer for off-premise consumption only" and 104 "Against the legal sale of beer for off-premise consumption only." Rose City was "Dry" before the election was held and remained "Dry".

## POTTER COUNTY

Justice Precinct No. 3, Potter County, on November 6, 1973, voted 428 "For the legal sale of all alcoholic beverages including mixed beverages" and 659 "Against the legal sale of all alcoholic beverages including mixed beverages." This precinct was "Dry" before the election was held and remained "Dry".

## SAN SABA COUNTY

Justice Precinct No. 3, San Saba County, on May 4, 1974, voted 124 "For the legal sale of all alcoholic beverages for off-premise consumption only" and 180 "Against the legal sale of all alcoholic beverages for off-premise consumption only." This precinct was "Dry" before the election was held and remained "Dry".

## TARRANT COUNTY

The City of Bedford, Tarrant County, on November 27, 1973, voted 760 "For prohibiting the legal sale of beer for off-premise consumption only" and 739 "Against prohibiting the legal sale of beer for off-premise consumption only." Bedford was "Wet" for the legal sale of beer for off-premise consumption only before the election was held and became "Dry". On January 7, 1974, the District Court of Tarrant County, Texas, 96th Judicial District, declared this election null and void because of irregularities in the petition seeking the election and the manner in which the election was called. Bedford reverted to a "Wet" status for the legal sale of beer for off-premise consumption only.

The City of Bedford, Tarrant County, on November 27, 1973, voted 790 "For prohibiting the legal sale of mixed beverages" and 713 "Against prohibiting the legal sale of mixed beverages." Bedford was "Wet" for the legal sale of mixed beverages before the election was held and became "Dry".

The City of Bedford, Tarrant County, on June 27, 1974, voted 714 "For prohibiting the legal sale of beer for off-premise consumption only" and 743 "Against prohibiting the legal sale of beer for off-premise consumption only." Bedford was "Wet" for the legal sale of beer for off-premise consumption only before the election was held and remained "Wet".

The City of Colleyville, Tarrant County, on November 27, 1973, voted 492 "For prohibiting the legal sale of beer for off-premise consumption only" and 306 "Against prohibiting the legal sale of beer for off-premise consumption only." Colleyville was "Wet" for the legal sale of beer for off-premise consumption only before the election was held and became "Dry".



The City of Colleyville, Tarrant County, on November 27, 1973, voted 533 "For prohibiting the legal sale of mixed beverages" and 266 "Against prohibiting the legal sale of mixed beverages." Colleyville was "Wet" for the legal sale of mixed beverages before the election was held and became "Dry".

The City of Euless, Tarrant County, on June 4, 1974, voted 1,030 "For prohibiting the legal sale of mixed beverages" and 831 "Against prohibiting the legal sale of mixed beverages." Euless was "Wet" for the legal sale of mixed beverages before the election was held and became "Dry". On July 10, 1974, the 96th District Court of Tarrant County, Texas, declared this election null and void because of irregularities in the petition seeking the election and the manner in which the election was called. Euless reverted to a "Wet" status for the legal sale of mixed beverages.

The City of Euless, Tarrant County, on June 4, 1974, voted 985 "For prohibiting the legal sale of beer for off-premise consumption only" and 871 "Against prohibiting the legal sale of beer for off-premise consumption only." Euless was "Wet" for the legal sale of beer for off-premise consumption only before the election was held and became "Dry". On July 10, 1974, the 96th District Court of Tarrant County, Texas, declared this election null and void because of irregularities in the petition seeking the election and the manner in which the election was called. Euless reverted to a "Wet" status for the legal sale of beer for off-premise consumption only.

The City of Hurst, Tarrant County, on June 4, 1974, voted 1,715 "For prohibiting the legal sale of mixed beverages" and 1,159 "Against prohibiting the legal sale of mixed beverages." Hurst was "Wet" for the legal sale of mixed beverages before the election was held and became "Dry". On July 11, 1974, the 96th District Court of Tarrant County, Texas, declared this election null and void because of irregularities in the petition seeking the election and the manner in which the election was called. Hurst reverted to a "Wet" status for the legal sale of mixed beverages.

The City of Hurst, Tarrant County, on June 4, 1974, voted 1,659 "For prohibiting the legal sale of beer for off-premise consumption only" and 1,207 "Against prohibiting the legal sale of beer for off-premise consumption only." Hurst was "Wet" for the legal sale of beer for off-premise consumption only before the election was held and became "Dry". On July 11, 1974, the 96th District Court of Tarrant County, Texas, declared this election null and void because of irregularities in the petition seeking the election and the manner in which the election was called. Hurst reverted to a "Wet" status for the legal sale of beer for off-premise consumption only.

## TITUS COUNTY

The Incorporated City of Monticello, Titus County, on December 8, 1973, voted 29 "For the legal sale of beer for off-premise consumption only" and 7 "Against the legal sale of beer for off-premise consumption only." Monticello was "Dry" before the election was held and became "Wet" for the legal sale of beer for off-premise consumption only.

## WALKER COUNTY

The City of New Waverly, Walker County, on June 8, 1974, voted 122 "For the legal sale of all alcoholic beverages for off-premise consumption only" and 123 "Against the legal sale of all alcoholic beverages for off-premise consumption only." New Waverly was "Dry" before the election was held and remained "Dry".

Justice Precinct No. 4, New Waverly, Walker County, on August 3, 1974, voted 152 "For the legal sale of beer and wine for off-premise consumption only" and 116 "Against the legal sale of beer and wine for off-premise consumption only." This precinct was "Dry" before the election was held and became "Wet" for the legal sale of beer and wine for off-premise consumption only.

## WILLACY COUNTY

Justice Precinct No. 5, Willacy County, on March 30, 1974, voted 76 "For the legal sale of beer for off-premise consumption only" and 99 "Against the legal sale of beer for off-premise consumption only." This precinct was "Dry" before the election was held and remained "Dry".

## ZAVALA COUNTY

Justice Precinct No. 1, Zavala County, on March 9, 1974, voted 86 "For the legal sale of all alcoholic beverages for off-premise consumption only" and 19 "Against the legal sale of all alcoholic beverages for off-premise consumption only." This precinct was "Wet" for the legal sale of beer only before the election was held and became "Wet" for the legal sale of all alcoholic beverages for off-premise consumption only.

Justice Precinct No. 4, Zavala County, on April 20, 1974, voted 145 "For the legal sale of all alcoholic beverages for off-premise consumption" and 103 "Against the legal sale of all alcoholic beverages for off-premise consumption." This precinct was "Wet" for the legal sale of beer before the election was held and became "Wet" for the legal sale of all alcoholic beverages for off-premise consumption only.
