LOCAL OPTION ELECTIONS

There were fifty-one local option elections during the fiscal year ending August 31, 1976. Twenty-two elections were called to legalize the sale of all alcoholic beverages for off-premise consumption only: fifteen remained "Dry" and seven became "Wet". Six elections were called to legalize the sale of beer for off-premise consumption only: four remained "Dry" and two became "Wet". Ten elections were called to legalize the sale of all alcoholic beverages including mixed beverages; eight remained "Dry" and two became "Wet". Two elections were called to legalize the sale of mixed beverages; both of these areas became "Wet". Seven elections were called to legalize the sale of beer and wine for off-premise consumption only; five remained "Dry" and two became "Wet". One election was called to legalize the sale of all alcoholic beverages except mixed beverages: this area became "Wet". One election was called to legalize the sale of beer and wine; this area became "Wet". One election was called to prohibit the legal sale of beer and wine for off-premise consumption only; this area remained "Wet". One election was called to prohibit the legal sale of beer; this area became "Dry".

The voting for the fiscal year:

ARCHER COUNTY

The City of Archer City, Archer County on December 8, 1975 voted 334 "For the legal sale of all alcoholic beverages for off-premise consumption only" and 295 "Against the legal sale of all alcoholic beverages for off-premise consumption only." The City of Archer City was "Dry" before the election was held and became "Wet" for the legal sale of all alcoholic beverages for off-premise consumption only.

BELL COUNTY

City of Killeen, Bell County on August 28, 1976 voted 2, 339 "For the legal sale of all alcoholic beverages including mixed beverages" and 2, 729 "Against the legal sale of all alcoholic beverages including mixed beverages." Killeen was "Dry" before the election was held and remained "Dry".

BOSQUE COUNTY

City of Morgan, Bosque County on August 7, 1976 voted 80 "For the legal sale of beer and wine for off-premise consumption only" and 124 "Against the legal sale of beer and wine for off-premise consumption only." Morgan was "Dry" before the election was held and remained "Dry".

CALLAHAN COUNTY

The City of Baird, Callahan County on December 2, 1975 voted 276 "For the legal sale of all alcoholic beverages for off-premise consumption only" and 334 "Against the legal sale of all alcoholic beverages for off-premise consumption only." Baird was "Dry" before the election was held and remained "Dry".

The City of Baird, Callahan County on February 7, 1976 voted 235 "For the legal sale of beer and wine for off-premise consumption only" and 371 "Against the legal sale of beer and wine for off-premise consumption only." Baird was "Dry" before the election was held and remained "Dry".

City of Putnam, Callahan County on March 9, 1976 voted 36 "For the legal sale of all alcoholic beverages for off-premise consumption only" and 30 "Against the legal sale of all alcoholic beverages for off-premise consumption only." Putnam was "Dry" before the election was held and became "Wet" for the legal sale of all alcoholic beverages for off-premise consumption only.

CHAMBERS COUNTY

Justice Precinct #5, Chambers County on April 24, 1976 voted 100 "For the legal sale of all alcoholic beverages including mixed beverages" and 199 "Against the legal sale of all alcoholic beverages including mixed beverages." Justice Precinct #5 was "Dry" before the election was held and remained "Dry".

CHEROKEE COUNTY

Justice Precinct No. 2, Cherokee County on June 19, 1976 voted 604 "For the legal sale of all alcoholic beverages for off-premise consumption only" and 1, 042 "Against the legal sale of all alcoholic beverages for off-premise consumption only." Justice Precinct No. 2 was "Dry" before the election was held and remained "Dry".

Justice Precinct No. 6, Cherokee County on June 2, 1976 voted 385 "For the legal sale of all alcoholic beverages for off-premise consumption only" and 711 "Against the legal sale of all alcoholic beverages for off-premise consumption only." Justice Precinct No. 6 was "Dry" before the election was held and remained "Dry".

DALLAS COUNTY

City of Kleberg, Dallas County on September 20, 1975 voted 276 "For the legal sale of all alcoholic beverages for off-premise consumption only" and 515 "Against the legal sale of all alcoholic beverages for off-premise consumption only." Kleberg was "Dry" before the election was held and remained "Dry".

DAWSON COUNTY

Justice Precinct No. 2, Dawson County on April 3, 1976 voted 118 "For the legal sale of all alcoholic beverages for off-premise consumption only" and 179 "Against the legal sale of all alcoholic beverages for off-premise consumption only." Justice Precinct No. 2 was "Dry" before the election was held and remained "Dry".

DENTON COUNTY

Incorporated City of Denton, Denton County on April 3, 1976 voted 4,832 "For the legal sale of beer and wine" and 4,250 "Against the legal sale of beer and wine." Denton was "Dry" before the election was held and became "Wet" for the legal sale of beer and wine.

DIMMIT COUNTY

City of Asherton, Dimmit County on September 27, 1975 voted 151 "For the legal sale of mixed beverages" and 20 "Against the legal sale of mixed beverages." Asherton was "Wet" for the legal sale of all alcoholic beverages before the election was held and became "Wet" for the legal sale of mixed beverages also.

GRAYSON COUNTY

City of Pottsboro, Grayson County on April 17, 1976 voted 84 "For the legal sale of beer for off-premise consumption only" and 259 "Against the legal sale of beer for off-premise consumption only." Pottsboro was "Dry" before the election was held and remained "Dry".

GRIMES COUNTY

Justice Precinct No. 2, Grimes County on September 6, 1975 voted 77 "For the legal sale of beer for off-premise consumption only" and 225 "Against the legal sale of beer for off-premise consumption only." Justice Precinct No. 2 was "Dry" before the election was held and remained "Dry".

Tustice Precinct No. 7, Grimes County on October 4, 1975 voted 139 "For the legal sale of beer for off-premise consumption only" and 193 "Against the legal sale of beer for off-premise consumption only." Justice Precinct No. 7 was "Dry" before the election was held and remained "Dry".

HARDIN COUNTY

Justice Precinct No. 5, Hardin County on October 4, 1975 voted 378 "For the legal sale of all alcoholic beverages for off-premise consumption only" and 756 "Against the legal sale of all alcoholic beverages for off-premise consumption only." Justice Precinct No. 5 was "Dry" before the election was held and remained "Dry".

HARRISON COUNTY

Incorporated Town of Waskom, Harrison County on September 6, 1975 voted 124 "For the legal sale of all alcoholic beverages for offpremise consumption only" and 250 "Against the legal sale of all alcoholic beverages for off-premise consumption only." Waskom was "Dry" before the election was held and remained "Dry".

Justice Precinct No. 6, Harrison County on November 29, 1975 voted 252 "For the legal sale of all alcoholic beverages including mixed beverages" and 310 "Against the legal sale of all alcoholic beverages including mixed beverages." Justice Precinct No. 6 was "Dry" before the election was held and remained "Dry".

Justice Precinct No. 6, Harrison County on March 6, 1976 voted 404 "For the legal sale of all alcoholic beverages except mixed beverages" and 292 "Against the legal sale of all alcoholic beverages except mixed beverages." Justice Precinct No. 6 was "Dry" before the election was held and became "Wet" for the legal sale of all alcoholic beverages except mixed beverages.

HARTLEY COUNTY

Justice Precinct No. 4, Hartley County on September 6, 1975 voted 197 "For the legal sale of beer for off-premise consumption only" and 136 "Against the legal sale of beer for off-premise consumption only." Justice Precinct No. 4 was "Dry" before the election was held and became "Wet" for the legal sale of beer for off-premise consumption only.

HAYS COUNTY

Justice Precinct No. 3, Hays County on August 7, 1976 voted 237 "For the legal sale of all alcoholic beverages including mixed beverages" and 424 "Against the legal sale of all alcoholic beverages including mixed beverages." Justice Precinct No. 3 was "Dry" before the election was held and remained "Dry".

Justice Precinct No. 4, Hays County on November 4, 1975 voted 334 "For the legal sale of all alcoholic beverages for off-premise consumption only" and 462 "Against the legal sale of all alcoholic beverages for off-premise consumption only." Justice Precinct No. 4 was "Dry" before the election was held and remained "Dry".

HILL COUNTY

City of Bynum, Hill County on January 3, 1976 voted 29 "For the legal sale of all alcoholic beverages including mixed beverages" and voted 77 "Against the legal sale of all alcoholic beverages including mixed beverages." City of Bynum was "Dry" before the election was held and remained "Dry".

City of Hubbard, Hill County on November 4, 1975 voted 120"For the legal sale of all alcoholic beverages including mixed beverages" and 526 "Against the legal sale of all alcoholic beverages including mixed beverages." Hubbard was "Dry" before the election was held and remained "Dry".

City of Penelope, Hill County on June 5, 1976 voted 42 "For the legal sale of all alcoholic beverages for off-premise consumption only" and 41 "Against the legal sale of all alcoholic beverages for off-premise consumption only." Penelope was "Dry" before the election was held and became "Wet" for the legal sale of all alcoholic beverages for off-premise consumption only.

HOOD COUNTY

Justice Precinct No. 3, Hood County on April 6, 1976 voted 1,005 "For the legal sale of beer and wine for off-premise consumption only" and 764 "Against the legal sale of beer and wine for off-premise consumption only." Justice Precinct No. 3 was "Dry" before the election was held and became "Wet" for the legal sale of beer and wine for offpremise consumption only.

HOPKINS COUNTY

City of Como, Hopkins County on July 10, 1976 voted 107 "For the legal sale of all alcoholic beverages for off-premise consumption only" and 169 "Against the legal sale of all alcoholic beverages for off-premise consumption only." Como was "Dry" before the election was held and remained "Dry".

IRION COUNTY

Incorporated City of Mertzon, Irion County on March 6, 1976 voted 79 "For the legal sale of beer for off-premise consumption only" and 134 "Against the legal sale of beer for off-premise consumption only." Mertzon was "Dry" before the election was held and remained "Dry".

KIMBLE COUNTY

Justice Precinct No. 1, Kimble County on October 4, 1975 voted 366 "For the legal sale of all alcoholic beverages for off-premise consumption only" and 192 "Against the legal sale of all alcoholic beverages for off-premise consumption only." Justice Precinct No. 1 was "Dry" before the election was held and became "Wet" for the legal sale of all alcoholic beverages for off-premise consumption only.

Justice Precinct No. 3, Kimble County on October 4, 1975 voted 72 "For the legal sale of all alcoholic beverages for off-premise consumption only" and 26 "Against the legal sale of all alcoholic beverages for off-premise consumption only." Justice Precinct No. 3 was "Dry" before the election was held and became "Wet" for the legal sale of all alcoholic beverages for off-premise consumption only.

LAMAR COUNTY

City of Sun Valley, Lamar County on July 6, 1976 voted 30 "For the legal sale of beer for off-premise consumption only" and 1 "Against the legal sale of beer for off-premise consumption only." Sun Valley was "Dry" before the election was held and became "Wet" for the legal sale of beer for off-premise consumption only.

LAMPASAS COUNTY

City of Lampasas, Lampasas County on May 8, 1976 voted 741 "For the legal sale of beer and wine for off-premise consumption only" and 821 "Against the legal sale of beer and wine for off-premise consumption only." Lampasas was "Dry" before the election was held and remained "Dry".

LEON COUNTY

City of Marquez, Leon County on February 10, 1976 voted 71 "For the legal sale of all alcoholic beverages for off-premise consumption only" and 39 "Against the legal sale of all alcoholic beverages for off-premise consumption only." Marquez was "Dry" before the election was held and became "Wet" for the legal sale of all alcoholic beverages for off-premise consumption only.

LLANO COUNTY

Sunrise Beach Village, Llano County on December 6, 1975 voted 136 "For the legal sale of beer and wine for off-premise consumption only" and 50 "Against the legal sale of beer and wine for off-premise consumption only." Sunrise Beach Village was "Dry" before the election was held and became "Wet" for the legal sale of beer and wine for offpremise consumption only.

MADISON COUNTY

Justice Precinct No. 2, Madison County on April 3, 1976 voted 162 "For the legal sale of all alcoholic beverages for off-premise consumption only" and 236 "Against the legal sale of all alcoholic beverages for off-premise consumption only." Justice Precinct No. 2 was "Dry" before the election was held and remained "Dry".

MCLENNAN COUNTY

City of Lorena, McLennan County on August 14, 1976 voted 57 "For prohibiting the legal sale of beer" and 24 "Against prohibiting the legal sale of beer." Lorena was "Wet" for the legal sale of beer before the election was held and became "Dry".

MITCHELL COUNTY

Justice Precinct No. 3, Mitchell County on November 4, 1975 voted 20 "For the legal sale of all alcoholic beverages for off-premise consumption only" and 23 "Against the legal sale of all alcoholic beverages for off-premise consumption only." Justice Precinct No. 3 was "Dry" before the election was held and remained "Dry".

MORRIS COUNTY

City of Lone Star, Morris County on March 6, 1976 voted 204 "For the legal sale of all alcoholic beverages for off-premise consumption only" and 407 "Against the legal sale of all alcoholic beverages for off-premise consumption only." Lone Star was "Dry" before the election was held and remained "Dry".

NAVARRO COUNTY

City of Angus, Navarro County on May 4, 1976 voted 37 "For prohibiting the legal sale of beer and wine for off-premise consumption only" and 70 "Against prohibiting the legal sale of beer and wine for off-premise consumption only." Angus was "Wet" for the legal sale of all alcoholic beverages for off-premise consumption only before the election was held and remained "Wet".

NOLAN COUNTY

City of Sweetwater, Nolan County on September 5, 1975 voted 1,981 "For the legal sale of all alcoholic beverages for off-premise consumption only" and 1,408 "Against the legal sale of all alcoholic beverages for off-premise consumption only." Sweetwater was "Dry" before the election was held and became "Wet" for the legal sale of all alcoholic beverages for off-premise consumption only.

OCHILTREE COUNTY

Justice Precinct No. 3, Ochiltree County on February 10, 1976 voted 284 "For the legal sale of all alcoholic beverages for off-premise consumption only" and 438 "Against the legal sale of all alcoholic beverages for off-premise consumption only." Justice Precinct No. 3 was "Dry" before the election was held and remained "Dry".

PECOS COUNTY

Justice Precinct No. 6, Pecos County on May 8, 1976 voted 29 "For the legal sale of all alcoholic beverages including mixed beverages" and 81 "Against the legal sale of all alcoholic beverages including mixed beverages." Justice Precinct No. 6 was "Dry" before the election was held and remained "Dry".

REEVES COUNTY

Justice Precinct No. 2, Reeves County on March 6, 1976 voted 50 "For the legal sale of all alcoholic beverages including mixed beverages" and 18 "Against the legal sale of all alcoholic beverages including mixed beverages." Justice Precinct No. 2 was "Dry" before the election was held and became "Wet" for the legal sale of all alcoholic beverages including mixed beverages.

SABINE COUNTY

Justice Precinct No. 2, Sabine County on June 19, 1976 voted 213 "For the legal sale of beer and wine for off-premise consumption only" and 384 "Against the legal sale of beer and wine for off-premise consumption only." Justice Precinct No. 2 was "Dry" before the election was held and remained "Dry".

SHACKELFORD COUNTY

Shackelford County on December 2, 1975 voted 470 "For the legal sale of beer and wine for off-premise consumption only" and 678 "Against the legal sale of beer and wine for off-premise consumption only." Shackelford County was "Dry" before the election was held and remained "Dry".

Incorporated City of Moran, Shackelford County on February 3, 1976 voted 46 "For the legal sale of all alcoholic beverages for off-premise consumption only" and 117 "Against the legal sale of all alcoholic beverages for off-premise consumption only." Moran was "Dry" before the election was held and remained "Dry".

SMITH COUNTY

City of Tyler, Smith County on July 12, 1976 voted 7,227 "For the legal sale of all alcoholic beverages for off-premise consumption only" and 10,099 "Against the legal sale of all alcoholic beverages for off-premise consumption only." Tyler was "Dry" before the election was held and remained "Dry".

TAYLOR COUNTY

Justice Precinct No. 1, Taylor County on February 17, 1976 voted 11,291 "For the legal sale of all alcoholic beverages including mixed beverages" and 12,905 "Against the legal sale of all alcoholic beverages including mixed beverages." Justice Precinct No. 1 was "Dry" before the election was held and remained "Dry".

WALLER COUNTY

Justice Precinct No. 3, Waller County on December 6, 1975 voted 68 "For the legal sale of mixed beverages" and 34 "Against the legal sale of mixed beverages." Justice Precinct No. 3 was "Wet" for the legal sale of all alcoholic beverages and became "Wet" for the legal sale of all alcoholic beverages including mixed beverages.

WILLACY COUNTY

Justice Precinct No. 7, Willacy County on November 4, 1975 voted 75"For the legal sale of all alcoholic beverages including mixed beverages" and 10 "Against the legal sale of all alcoholic beverages including mixed beverages." Justice Precinct No. 7 was "Dry" before the election was held and became "Wet" for the legal sale of all alcoholic beverages including mixed beverages.
