BRAZORIA COUNTY

City of Angleton, Brazoria County on May 7, 1977 voted 991 "For the legal sale of all alcoholic beverages including mixed beverages" and 905 "Against the legal sale of all alcoholic beverages including mixed beverages." Angleton was "Dry" before the election was held and became "Wet" for the legal sale of all alcoholic beverages including mixed beverages.

BURNET COUNTY

City of Bertram, Burnet County on July 9, 1977 voted 148 "For the legal sale of beer and wine for off-premise consumption only" and 130 "Against the legal sale of beer and wine for off-premise consumption only." Bertram was "Dry" before the election was held and became "Wet" for the legal sale of beer and wine for off-premise consumption only.

City of Granite Shoals, Burnet County on May 21, 1977 voted 81 "For the legal sale of all alcoholic beverages including mixed beverages" and 68 "Against the legal sale of all alcoholic beverages including mixed beverages." Granite Shoals was "Dry" before the election was held and became "Wet" for the legal sale of all alcoholic beverages including mixed beverages.

CHEROKEE COUNTY

Justice Precinct No. 6, Cherokee County on September 18, 1976 voted 403 "For the legal sale of beer and wine for off-premise consumption only" and 667 "Against the legal sale of beer and wine for off-premise consumption only." Justice Precinct No. 6 was "Dry" before the election was held and remained "Dry".

COMANCHE COUNTY

Justice Precinct No. 4, Comanche County on February 4, 1977 voted 207 "For the legal sale of all alcoholic beverages for off-premise consumption only" and 119 "Against the legal sale of all alcoholic beverages for off-premise consumption only." Justice Precinct No. 4 was "Dry" before the election was held and became "Wet" for the legal sale of all alcoholic beverages for off-premise consumption only.

DALLAS COUNTY

City of Addison, Dallas County on September 2, 1976 voted 242 "For the legal sale of all alcoholic beverages including mixed beverages" and 70 "Against the legal sale of all alcoholic beverages including mixed beverages." Addison was "Dry" before the election was held and became "Wet" for the legal sale of all alcoholic beverages including mixed beverages.

DAWSON COUNTY

Justice Precinct No. 2, Dawson County on December 1, 1976 voted 101 "For the legal sale of beer for off-premise consumption only" and 162 "Against the legal sale of beer for off-premise consumption only." Justice Precinct No. 2 was "Dry" before the election was held and remained "Dry".

DENTON COUNTY

City of Denton, Denton County on August 6, 1977 held a prohibitory election and voted 7,266 "For the legal sale of wine and beer" and 3,810 "Against the legal sale of wine and beer." Denton was "Wet" for the legal sale of wine and beer before the election was held and remained "Wet" for the legal sale of wine and beer. This election is on appeal.

City of Lewisville, Denton County on May 7, 1977 voted 1,344 "For the legal sale of all alcoholic beverages for off-premise consumption only" and 1,929 "Against the legal sale of all alcoholic beverages for off-premise consumption only." Lewisville was "Dry" before the election was held and remained "Dry".

DONLEY COUNTY

City of Howardwick, Donley County on February 5, 1977 voted 69 "For the legal sale of all alcoholic beverages including mixed beverages" and 22 "Against the legal sale of all alcoholic beverages including mixed beverages." Howardwick was "Dry" before the election was held and became "Wet" for the legal sale of all alcoholic beverages including mixed beverages.

ELLIS COUNTY

City of Alma, Ellis County on February 5, 1977 voted 48 "For the legal sale of beer and wine for off-premise consumption only" and 19 "Against the legal sale of beer and wine for off-premise consumption only." Alma was "Dry" before the election was held and became "Wet" for the legal sale of beer and wine for off-premise consumption only.

Justice Precinct No. 3, Ellis County on April 9, 1977 voted 1,196 "For the legal sale of all alcoholic beverages for off-premise consumption only" and 1,868 "Against the legal sale of all alcoholic beverages for off-premise consumption only." Justice Precinct No. 3 was "Dry" before the election was held and remained "Dry".

Justice Precinct No. 7, Ellis County on June 18, 1977 voted 155 "For the legal sale of all alcoholic beverages for off-premise consumption only" and 771 "Against the legal sale of all alcoholic beverages for off-premise consumption only." Justice Precinct No. 7 was "Dry" before the election was held and remained "Dry".

FALLS COUNTY

City of Rosebud, Falls County on May 21, 1977 voted 217 "For the legal sale of all alcoholic beverages including mixed beverages" and 125 "Against the legal sale of all alcoholic beverages including mixed beverages." Rosebud was "Dry" before the election was held and became "Wet" for the legal sale of all alcoholic beverages including mixed beverages.

FRIO COUNTY

City of Dilley, Frio County on January 8, 1977 voted 295 "For the legal sale of mixed beverages" and 297 "Against the legal sale of mixed beverages." Dilley was "Dry" before the election was held and remained "Dry".

HENDERSON COUNTY

City of Seven Points, Henderson County on May 7, 1977 voted 29 "For the legal sale of all alcoholic beverages" and 3 "Against the legal sale of all alcoholic beverages." Seven Points was "Dry" before the election was held and became "Wet" for the legal sale of all alcoholic beverages.

HOOD COUNTY

Justice Precinct No. 4, Hood County on August 6, 1977 voted 183 "For the legal sale of wine and beer for off-premise consumption" and 311 "Against the legal sale of wine and beer for off-premise consumption." Justice Precinct No. 4 was "Dry" before the election was held and remained "Dry".

HUNT COUNTY

City of Neylandville, Hunt County on December 4, 1976 voted 44 "For the legal sale of all alcoholic beverages for off-premise consumption only" and 35 "Against the legal sale of all alcoholic beverages for off-premise consumption only." Neylandville was "Dry" before the election was held and became "Wet" for the legal sale of all alcoholic beverages for off-premise consumption only.

JASPER COUNTY

Justice Precinct No. 1, Jasper County on September 4, 1976 voted 288 "For the legal sale of all alcoholic beverages for off-premise consumption only" and 629 "Against the legal sale of all alcoholic beverages for off-premise consumption only." Justice Precinct No. 1 was "Dry" before the election was held and remained "Dry".

JOHNSON COUNTY

City of Rio Vista, Johnson County on February 1, 1977 voted 56 "For the legal sale of beer and wine for off-premise consumption only" and 127 "Against the legal sale of beer and wine for off-premise consumption only." Rio Vista was "Dry" before the election was held and remained "Dry".

City of Venus, Johnson County on September 28, 1976 voted 86 "For the legal sale of beer for off-premise consumption only" and 129 "Against the legal sale of beer for off-premise consumption only." Venus was "Dry" before the election was held and remained "Dry".

KAUFMAN COUNTY

Justice Precinct No. 2, Kaufman County on November 20, 1976 voted 674 "For the legal sale of all alcoholic beverages including mixed beverages" and 1,437 "Against the legal sale of all alcoholic beverages including mixed beverages." Justice Precinct No. 2 was "Dry" before the election was held and remained "Dry".

LAMAR COUNTY

City of Sun Valley, Lamar County on August 2, 1977 voted 31 "For the legal sale of all alcoholic beverages including mixed beverages" and 0 "Against the legal sale of all alcoholic beverages including mixed beverages." Sun Valley was "Dry" before the election was held and became "Wet" for the legal sale of all alcoholic beverages including mixed beverages.

LLANO COUNTY

Justice Precinct No. 1, Llano County on May 7, 1977 voted 144 "For the legal sale of all alcoholic beverages except mixed beverages" and 165 "Against the legal sale of all alcoholic beverages except mixed beverages." Justice Precinct No. 1 was "Dry" before the election was held and remained "Dry".

Justice Precinct No. 7, Llano County on November 6, 1976 voted 66 "For the legal sale of mixed beverages" and 56 "Against the legal sale of mixed beverages." Llano was "Dry" before the election was held and became "Wet" for the legal sale of mixed beverages.

MONTGOMERY COUNTY

Justice Precinct No. 2, Montgomery County on January 8, 1977 voted 637 "For the legal sale of all alcoholic beverages including mixed beverages" and 829 "Against the legal sale of all alcoholic beverages including mixed beverages." Justice Precinct No. 2 was "Dry" before the election was held and remained "Dry".

MOORE COUNTY

Incorporated City of Cactus, Moore County on October 9, 1976 voted 61 "For the legal sale of all alcoholic beverages including mixed beverages" and 44 "Against the legal sale of all alcoholic beverages including mixed beverages." Cactus was "Dry" before the election was held and became "Wet" for the legal sale of all alcoholic beverages including mixed beverages.

ORANGE COUNTY

City of Orange, Orange County on December 4, 1976 voted 2,295 "For the legal sale of all alcoholic beverages including mixed beverages" and 1,689 "Against the legal sale of all alcoholic beverages including mixed beverages." Orange was "Dry" before the election was held and became "Wet" for the legal sale of all alcoholic beverages including mixed beverages.

Justice Precinct No. 4, Orange County on February 5, 1977 voted 1,045 "For the legal sale of beer and wine for off-premise consumption only" and 1,886 "Against the legal sale of beer and wine for off-premise consumption only." Justice Precinct No. 4 was "Dry" before the election was held and remained "Dry".

PECOS COUNTY

Justice Precinct No. 6, Pecos County on August 6, 1977 voted 39 "For the legal sale of beer for off-premise consumption only" and 59 "Against the legal sale of beer for off-premise consumption only." Justice Precinct No. 6 was "Dry" before the election was held and remained "Dry".

REEVES COUNTY

Justice Precinct No. 4, Reeves County on March 12, 1977 voted 22 "For the legal sale of all alcoholic beverages including mixed beverages" and 62 "Against the legal sale of all alcoholic beverages including mixed beverages." Justice Precinct No. 4 was "Dry" before the election was held and remained "Dry".

REFUGIO COUNTY

Justice Precinct No. 6, Bayside, Refugio County on December 4, 1976 voted 122 "For the legal sale of all alcoholic beverages for off-premise consumption only" and 66 "Against the legal sale of all alcoholic beverages for off-premise consumption only." Justice Precinct No. 6 was "Dry" before the election was held and became "Wet" for the legal sale of all alcoholic beverages for off-premise consumption only.

TARRANT COUNTY

City of North Richland Hills, Tarrant County on April 26, 1977 voted on two issues: 1,272 "For the legal sale of beer for off-premise consumption only" and 1,441 "Against the legal sale of beer for off-premise consumption only" and 1,203 "For the legal sale of mixed beverages" and 1,501 "Against the legal sale of mixed beverages." North Richland Hills, being located in two justice precincts, was partially "Dry" and partially "Wet" before the election was held and became completely "Dry". However, on May 9, 1977 the County Judge declared this election null and void.

City of North Richland Hills, Tarrant County on August 9, 1977 again voted on two issues: 2,302 "For the legal sale of beer for off-premise consumption only" and 1,530 "Against the legal sale of beer for off-premise consumption only" and 2,246 "For the legal sale of mixed beverages" and 1,559 "Against the legal sale of mixed beverages." North Richland Hills, being located in two justice precincts, was partially "Dry" and partially "Wet" before the election was held and remained partially "Dry" and partially "Wet" for the legal sale of beer for off-premise consumption only and for the legal sale of mixed beverages.

WILLIAMSON COUNTY

City of Thrall, Williamson County on August 6, 1977 voted 96 "For the legal sale of all alcoholic beverages including mixed beverages" and 19 "Against the legal sale of all alcoholic beverages including mixed beverages." Thrall was "Dry" before the election was held and became "Wet" for the legal sale of all alcoholic beverages including mixed beverages.

Justice Precinct No. 1, Williamson County on February 5, 1977 voted 1,153 "For the legal sale of beer and wine" and 1,781 "Against the legal sale of beer and wine." Justice Precinct No. 1 was "Dry" before the election was held and remained "Dry".
