LOCAL OPTION ELECTIONS

There were forty-four local option elections during the fiscal year ending August 31, 1978. Eight elections were called to legalize the sale of beer and wine for off-premise consumption only; three remained "Dry", four became "Wet" and one remained partially "Wet". Two elections were called to legalize the sale of mixed beverages; both areas became "Wet". Eight elections were called to legalize the sale of beer for off-premise consumption only; four remained "Dry" and four became "Wet". Sixteen elections were called to legalize the sale of all alcoholic beverages for off-premise consumption only; ten remained "Dry" and six became "Wet". Five elections were called to legalize the sale of all alcoholic beverages including mixed beverages; one remained "Dry", one remained "Wet" and three became "Wet". One election was called to legalize the sale of beer and wine; this area became "Wet". Two elections were called to legalize the sale of all alcoholic beverages except mixed beverages; both areas became "Wet". Two elections were called to legalize the sale of beer; both areas became "Wet".

The voting for the fiscal year:

ARCHER COUNTY

City of Lakeside, Archer County, on March 25, 1978, voted 70 "For the legal sale of beer and wine for off-premise consumption only" and 17 "Against the legal sale of beer and wine for off-premise consumption only." Lakeside was "Dry" before the election was held and became "Wet" for the legal sale of beer and wine for off-premise consumption only.

City of Megargel, Archer County, on May 20, 1978, voted 106 "For the legal sale of all alcoholic beverages for off-premise consumption only" and 75 "Against the legal sale of all alcoholic beverages for off-premise consumption only." Megargel was "Dry" before the election was held and became "Wet" for the legal sale of all alcoholic beverages for off-premise consumption only.

Justice Precinct No. 4, Archer County, on July 8, 1978, voted 120 "For the legal sale of beer for off-premise consumption only" and 321 "Against the legal sale of beer for off-premise consumption only." Justice Precinct No. 4 was "Dry" before the election was held and remained "Dry".

BAYLOR COUNTY

Justice Precinct No. 2, Baylor County, on July 8, 1978, voted 369 "For the legal sale of beer for off-premise consumption only" and 302 "Against the legal sale of beer for off-premise consumption only." Justice Precinct No. 2 was "Dry" before the election was held and became "Wet" for the legal sale of beer for off-premise consumption only.

BELL COUNTY

City of Killeen, Bell County, on July 8, 1978, voted 1,635 "For the legal sale of beer for off-premise consumption only" and 1,416 "Against the legal sale of beer for off-premise consumption only." Killeen was "Dry" before the election was held and became "Wet" for the legal sale of beer for off-premise consumption only.

BLANCO COUNTY

Justice Precinct No. 1, Blanco County, on March 11, 1978, voted 276 "For the legal sale of all alcoholic beverages including mixed beverages" and 113 "Against the legal sale of all alcoholic beverages including mixed beverages." Justice Precinct No. 1 was "Dry" before the election was held and became "Wet" for the legal sale of all alcoholic beverages including mixed beverages.

BRAZORIA COUNTY

Village of Surfside Beach, Brazoria County, on March 18, 1978, voted 89 "For the legal sale of all alcoholic beverages including mixed beverages" and 41 "Against the legal sale of all alcoholic beverages including mixed beverages." Surfside Beach was "Dry" before the election was held and became "Wet" for the legal sale of all alcoholic beverages including mixed beverages.

BREWSTER COUNTY

Justice Precinct No. 2, Brewster County, on October 5, 1977, voted 30 "For the legal sale of mixed beverages" and 5 "Against the legal sale of mixed beverages." Justice Precinct No. 2 was "Dry" before the election was held and became "Wet" for the legal sale of mixed beverages.

COLLIN COUNTY

City of Plano, Collin County, on October 8, 1977, voted 5,791 "For the legal sale of beer and wine for off-premise consumption only" and 4,464 "Against the legal sale of beer and wine for off-premise consumption only." Plano was "Dry" before the election was held and became "Wet" for the legal sale of beer and wine for off-premise consumption only.

CROCKETT COUNTY

Justice Precinct No. 1, Crockett County, on January 10, 1978, voted 553 "For the legal sale of all alcoholic beverages for off-premise consumption only" and 664 "Against the legal sale of all alcoholic beverages for off-premise consumption only." Justice Precinct No. 1 was "Dry" before the election was held and remained "Dry".

Justice Precinct No. 1, Crockett County, on April 8, 1978, voted 479 "For the legal sale of beer for off-premise consumption only" and 666 "Against the legal sale of beer for off-premise consumption only." Justice Precinct No. 1 was "Dry" before the election was held and remained "Dry".

DENTON COUNTY

City of Denton, Denton County, on February 4, 1978, voted 6,398 "For the legal sale of beer and wine" and 2,199 "Against the legal sale of beer and wine." Denton was "Dry" before the election was held and became "Wet" for the legal sale of beer and wine.

City of Eastvale, Denton County, on July 8, 1978, voted 84 "For the legal sale of wine and beer for off-premise consumption only" and 74 "Against the legal sale of wine and beer for off-premise consumption only." Eastvale was "Dry" before the election was held and became "Wet" for the legal sale of wine and beer for off-premise consumption only.

DONLEY COUNTY

Justice Precinct No. 1, Donley County, on June 6, 1978, voted 147 "For the legal sale of all alcoholic beverages for off-premise consumption only" and 268 "Against the legal sale of all alcoholic beverages for off-premise consumption only." Justice Precinct No. 1 was "Dry" before the election was held and remained "Dry".

ERATH COUNTY

Justice Precinct No. 3, Erath County, on June 6, 1978, voted 371 "For the legal sale of all alcoholic beverages for off-premise consumption only" and 723 "Against the legal sale of all alcoholic beverages for off-premise consumption only." Justice Precinct No. 3 was "Dry" before the election was held and remained "Dry".

FREESTONE COUNTY

City of Wortham, Freestone County, on January 7, 1978, voted 145 "For the legal sale of all alcoholic beverages for off-premise consumption only" and 268 "Against the legal sale of all alcoholic beverages for off-premise consumption only." Wortham was "Dry" before the election was held and remained "Dry".

FRIO COUNTY

Justice Precinct No. 1, Frio County, on January 21, 1978, voted 270 "For the legal sale of all alcoholic beverages including mixed beverages" and 62 "Against the legal sale of all alcoholic beverages including mixed beverages." Justice Precinct No. 1 was "Wet" for the legal sale of beer for on-premise consumption only before the election was held and became "Wet" for the legal sale of all alcoholic beverages including mixed beverages.

Justice Precinct No. 2, Frio County, on March 25, 1978, voted 269 "For the legal sale of all alcoholic beverages including mixed beverages" and 400 "Against the legal sale of all alcoholic beverages including mixed beverages." Justice Precinct No. 2 was "Dry" before the election was held and remained "Dry".

GONZALES COUNTY

City of Waelder, Gonzales County, on February 4, 1978, voted 100 "For the legal sale of all alcoholic beverages except mixed beverages" and 77 "Against the legal sale of all alcoholic beverages except mixed beverages." Waelder was "Dry" before the election was held and became "Wet" for the legal sale of all alcoholic beverages except mixed beverages.

GRAYSON COUNTY

City of Denison, Grayson County, on January 24, 1978, voted 443 "For the legal sale of all alcoholic beverages except mixed beverages" and 247 "Against the legal sale of all alcoholic beverages except mixed beverages." Denison was partially "Wet" for the legal sale of all alcoholic beverages except mixed beverages and became totally "Wet" for the legal sale of all alcoholic beverages except mixed beverages.

JACKSON COUNTY

Justice Precinct No. 4, Jackson County, on March 28, 1978, voted 158 "For the legal sale of beer for off-premise consumption only" and 214 "Against the legal sale of beer for off-premise consumption only." Justice Precinct No. 4 was "Dry" before the election was held and remained "Dry".

JEFFERSON COUNTY

Justice Precinct No. 7, Jefferson County, on March 11, 1978, voted 2,089 "For the legal sale of all alcoholic beverages including mixed beverages" and 3,836 "Against the legal sale of all alcoholic beverages including mixed beverages." Justice Precinct No. 7 was "Wet" for the legal sale of all alcoholic beverages except mixed beverages before the election was held and remained "Wet" for the legal sale of all alcoholic beverages except mixed beverages.

Town of Bevil Oaks, Jefferson County, on October 11, 1977, voted 177 "For the legal sale of beer and wine for off-premise consumption only" and 195 "Against the legal sale of beer and wine for off-premise consumption only." Bevil Oaks was "Dry" before the election was held and remained "Dry".

JIM WELLS COUNTY

Justice Precinct No. 3, Jim Wells County, on August 5, 1978, voted 80 "For the legal sale of wine and beer for off-premise consumption only" and 55 "Against the legal sale of wine and beer for off-premise consumption only." Justice Precinct No. 3 was "Dry" before the election was held and became "Wet" for the legal sale of wine and beer for off-premise consumption only.

KLEBERG COUNTY

"For the legal sale of all alcoholic beverages for off-premise consumption only" and 250 "Against the legal sale of all alcoholic beverages for off-premise consumption only." Justice Precinct No. 2 was "Dry" before the election was held and became "Wet" for the legal sale of all alcoholic beverages for off-premise consumption only.

Justice Precinct No. 4, Kleberg County, on July 8, 1978, voted 177 "For the legal sale of all alcoholic beverages for off-premise consumption only" and 15 "Against the legal sale of all alcoholic beverages for off-premise consumption only." Justice Precinct No. 4 was "Dry" before the election was held and became "Wet" for the legal sale of all alcoholic beverages for off-premise consumption only.

LLANO COUNTY

Justice Precinct No. 1, Llano County, on November 8, 1977, voted 237 "For the legal sale of all alcoholic beverages for off-premise consumption only" and 226 "Against the legal sale of all alcoholic beverages for off-premise consumption only." Justice Precinct No. 1 was "Dry" before the election was held and became "Wet" for the legal sale of all alcoholic beverages for off-premise consumption only. This election was declared void by District Court on December 21, 1977, and Justice Precinct No. 1 returned to a "Dry" status.

Justice Precinct No. 1, Llano County, on January 21, 1978, voted 393 "For the legal sale of all alcoholic beverages for off-premise consumption only" and 268 "Against the legal sale of all alcoholic beverages for off-premise consumption only." Justice Precinct No. 1 was "Dry" before the election was held and became "Wet" for the legal sale of all alcoholic beverages for off-premise consumption only.

MCLENNAN COUNTY

Justice Precinct No. 4, McLennan County, on October 11, 1977, voted 513 "For the legal sale of beer for off-premise consumption only" and 469 "Against the legal sale of beer for off-premise consumption only." Justice Precinct No. 4 was "Dry" before the election was held and became "Wet" for the legal sale of beer for off-premise consumption only.

Justice Precinct No. 7, McLennan County, on September 10, 1977, voted 192 "For the legal sale of beer and wine for off-premise consumption only" and 249 "Against the legal sale of beer and wine for off-premise consumption only." Justice Precinct No. 7 was "Dry" before the election was held and remained "Dry".

MONTGOMERY COUNTY

Town of Patton Village, Montgomery County, on August 12, 1978, voted 44 "For the legal sale of beer for off-premise consumption only" and 107 "Against the legal sale of beer for off-premise consumption only." Patton Village was "Dry" before the election was held and remained "Dry".

POLK COUNTY

City of Onalaska, Polk County, on April 17, 1978, voted 45 "For the legal sale of all alcoholic beverages for off-premise consumption only" and 23 "Against the legal sale of all alcoholic beverages for off-premise consumption only." Onalaska was partially "Wet" for the legal sale of all alcoholic beverages for off-premise consumption only before the election was held and became totally "Wet" for the legal sale of all alcoholic beverages for off-premise consumption only.

RUNNELS COUNTY

Justice Precinct No. 2, Runnels County, on December 5, 1977, voted 549 "For the legal sale of beer and wine for off-premise consumption only" and 581 "Against the legal sale of beer and wine for off-premise consumption only." Justice Precinct No. 2 was "Dry" before the election was held and remained "Dry".

SCURRY COUNTY

City of Snyder, Scurry County, on May 8, 1978, voted 1,420 "For the legal sale of all alcoholic beverages for off-premise consumption only" and 2,225 "Against the legal sale of all alcoholic beverages for off-premise consumption only." Snyder was "Dry" before the election was held and remained "Dry".

TITUS COUNTY

City of Miller's Cove, Titus County, on March 11, 1978, voted 29 "For the legal sale of beer" and 1 "Against the legal sale of beer." Miller's Cove was "Dry" before the election was held and became "Wet" for the legal sale of beer.

WISE COUNTY

City of Lake Bridgeport, Wise County, on February 4, 1978, voted 69"For the legal sale of beer" and 46 "Against the legal sale of beer." Lake Bridgeport was "Dry" before the election was held and became "Wet" for the legal sale of beer.

WARD COUNTY

Justice Precinct No. 3, Ward County, on April 8, 1978, voted 107 "For the legal sale of beer and wine for off-premise consumption only" and 173 "Against the legal sale of beer and wine for off-premise consumption only." Justice Precinct No. 3 was partially "Wet" for the legal sale of all alcoholic beverages except mixed beverages before the election was held and remained partially "Wet" for the legal sale of all alcoholic beverages except mixed beverages.

ZAVALA COUNTY

City of Crystal City, Zavala County, on March 25, 1978, voted 126 "For the legal sale of mixed beverages" and 72 "Against the legal sale of mixed beverages." Crystal City was "Dry" before the election was held and became "Wet" for the legal sale of mixed beverages.
