LOCAL OPTION ELECTIONS

There were twenty-seven local option elections during the fiscal year ending August 31, 1980. Eight elections were called to legalize the sale of all alcoholic beverages for off-premise consumption only; six remained "Dry" and two became "Wet." One election was called to legalize the sale of all alcoholic beverages including mixed beverages; this area became "Wet." Four elections were called to legalize the sale of beer for off-premise consumption only; three remained "Dry" and one became "Wet." Seven elections were called to legalize the sale of beer and wine for off-premise consumption only; six remained "Dry" and one became "Wet." One election was called to legalize the sale of all alcoholic beverages; this area remained "Dry." Four elections were called to legalize the sale of mixed beverages; two remained "Wet" and two became "Wet." Two elections were called to legalize the sale of all alcoholic beverages except mixed beverages; one remained "Dry" and one became "Wet."

The voting for the fiscal year:

BOSQUE COUNTY

Justice Precinct No. 3, Bosque County, on January 19, 1980, voted 551 "For the legal sale of all alcoholic beverages for off-premise consumption only" and 242 "Against the legal sale of all alcoholic beverages for off-premise consumption only." Justice Precinct No. 3 was "Dry" before the election was held and became "Wet" for the legal sale of all alcoholic beverages for off-premise consumption only.

CONCHO COUNTY

City of Paint Rock, Concho County, on April 5, 1980, voted 51 "For the legal sale of beer for off-premise consumption only" and 55 "Against the legal sale of beer for off-premise consumption only." Paint Rock was "Dry" before the election was held and remained "Dry."

COOKE COUNTY

City of Muenster, Cooke County, on March 8, 1980, voted 194 "For the legal sale of mixed beverages" and 71 "Against the legal sale of mixed beverages." Muenster was "Wet" for the legal sale of all alcoholic beverages before the election was held and became "Wet" for the legal sale of mixed beverages.

City of Lindsay, Cooke County, on April 5, 1980, voted 130 "For the legal sale of mixed beverages" and 23 "Against the legal sale of mixed beverages." Lindsay was "Wet" for the legal sale of all alcoholic beverages before the election was held and became "Wet" for the legal sale of mixed beverages.

DAWSON COUNTY

Justice Precinct No. 2, Dawson County, on January 8, 1980, voted 83 "For the legal sale of beer for off-premise consumption only" and 184 "Against the legal sale of beer for off-premise consumption only." Justice Precinct No. 2 was "Dry" before the election was held and remained "Dry".

DENTON COUNTY

City of Bartonville, Denton County, on October 6, 1979, voted 70 "For the legal sale of wine and beer for off-premise consumption only" and 0 "Against the legal sale of wine and beer for off-premise consumption only." Bartonville was "Dry" before the election was held and became "Wet" for the legal sale of wine and beer for off-premise consumption only.

City of Hickory Creek, Denton County, on April 5, 1980, voted 179 "For the legal sale of beer and wine for off-premise consumption only" and 194 "Against the legal sale of beer and wine for off-premise consumption only." Hickory Creek was "Dry" before the election was held and remained "Dry".

City of Hickory Creek, Denton County, on June 6, 1980, voted 135 "For the legal sale of beer and wine for off-premise consumption only" and 151 "Against the legal sale of beer and wine for off-premise consumption only." Hickory Creek was "Dry" before the election was held and remained "Dry".

City of Shady Shores, Denton County, on August 8, 1980, voted 69 "For the legal sale of beer and wine for off-premise consumption only" and 125 "Against the legal sale of beer and wine for off-premise consumption only." Shady Shores was "Dry" before the election was held and remained "Dry".

FRIO COUNTY

Justice Precinct No. 2, Frio County, on September 29, 1979, voted 328 "For the legal sale of beer for on-premise consumption only" and 112 "Against the legal sale of beer for on-premise consumption only." Justice Precinct No. 2 was partially "Dry" before the election was held and became "Wet" for the legal sale of beer for on-premise consumption only."

GLASSCOCK COUNTY

Justice Precinct No. 3, Glasscock County, on November 6, 1979, voted 35 "For the legal sale of wine and beer for off-premise consumption only" and 67 "Against the legal sale of wine and beer for off-premise consumption only." Justice Precinct No. 3 was "Dry" before the election was held and remained "Dry".

GONZALES COUNTY

City of Waelder, Gonzales County, on February 9, 1980, voted 166 "For the legal sale of all alcoholic beverages, except mixed beverages" and 94 "Against the legal sale of all alcoholic beverages, except mixed beverages." Waelder was "Wet" for the legal sale of all alcoholic beverages, except mixed beverages and remained "Wet" for the legal sale of all alcoholic beverages, except mixed beverages.

HILL COUNTY

City of Mount Calm, Hill County, on October 27, 1979, voted 54 "For the legal sale of all alcoholic beverages" and 140 "Against the legal sale of all alcoholic beverages." Mount Calm was "Dry" before the election was held and remained "Dry".

City of Bynum, Hill County, on July 19, 1980, voted 62 "For the legal sale of all alcoholic beverages for off-premise consumption only" and 51 "Against the legal sale of all alcoholic beverages for off-premise consumption only." Bynum was "Dry" before the election was held and became "Wet" for the legal sale of all alcoholic beverages for off-premise consumption only.

JACK COUNTY

City of Jacksboro, Jack County, on September 8, 1979, voted 550 "For the legal sale of all alcoholic beverages for off-premise consumption only" and 868 "Against the legal sale of all alcoholic beverages for off-premise consumption only." Jacksboro was "Dry" before the election was held and remained "Dry".

JIM WELLS COUNTY

Justice Precinct No. 3, Jim Wells County, on September 8, 1979, voted 43 "For the legal sale of all alcoholic beverages for off-premise consumption only" and 51 "Against the legal sale of all alcoholic beverages for off-premise consumption only." Justice Precinct No. 3 was "Dry" before the election was held and remained "Dry".

KARNES COUNTY

City of Kenedy, Karnes County, on May 10, 1980, voted 135 "For the legal sale of mixed beverages" and 133 "Against the legal sale of mixed beverages." Kenedy was "Dry" before the election was held and became "Wet" for the legal sale of mixed beverages.

KAUFMAN COUNTY

City of Post Oak Bend, Kaufman County, on November 3, 1979, voted 39 "For the legal sale of beer for off-premise consumption only" and 106 "Against the legal sale of beer for off-premise consumption only." Post Oak Bend was "Dry" before the election was held and remained "Dry".

KLEBERG COUNTY

Justice Precinct No. 2, Kleberg County, on January 5, 1980, voted 196 "For the legal sale of mixed beverages" and 78 "Against the legal sale of mixed beverages." Justice Precinct No. 2 was "Dry" before the election was held and became "Wet" for the legal sale of mixed beverages.

LIMESTONE COUNTY

City of Coolidge, Limestone County, on January 5, 1980, voted 113 "For the legal sale of beer and wine for on-premise consumption only" and 165 "Against the legal sale of beer and wine for on-premise consumption only." Coolidge was "Dry" before the election was held and remained "Dry".

MARION COUNTY

Justice Precinct No. 2, Marion County, on September 4, 1980, voted 204 "For the legal sale of wine and beer for off-premise consumption only" and 286 "Against the legal sale of wine and beer for off-premise consumption only." Justice Precinct No. 2 was "Dry" before the election was held and remained "Dry".

RED RIVER COUNTY

City of Bogata, Red River County, on October 6, 1979, voted 158 "For the legal sale of all alcoholic beverages for off-premise consumption only" and 367 "Against the legal sale of all alcoholic beverages for off-premise consumption only." Bogata was "Dry" before the election was held and remained "Dry".

RUNNELS COUNTY

Justice Precinct No. 2, Runnels County, on April 3, 1980, voted 639 "For the legal sale of all alcoholic beverages for off-premise consumption only" and 647 "Against the legal sale of all alcoholic beverages for off-premise consumption only." Justice Precinct No. 2 was "Dry" before the election was held and remained "Dry".

City of Ballinger, Runnels County, on April 22, 1980, voted 636 "For the legal sale of all alcoholic beverages for off-premise consumption only" and 651 "Against the legal sale of all alcoholic beverages for off-premise consumption only." Ballinger was "Dry" before the election was held and remained "Dry".

Justice Precinct No. 2, Runnels County, on June 17, 1980, voted 671 "For the legal sale of all alcoholic beverages except mixed beverages" and 756 "Against the legal sale of all alcoholic beverages except mixed beverages." Justice Precinct No. 2 was "Dry" before the election was held and remained "Dry".

TITUS COUNTY

City of Millers Cove, Titus County, on September 6, 1979, voted 16 "For the legal sale of all alcoholic beverages, including mixed beverages" and 0 "Against the legal sale of all alcoholic beverages, including mixed beverages." Millers Cove was "Wet" for the legal sale of beer for on-premise consumption before the election was held and became totally "Wet" for the legal sale of all alcoholic beverages, including mixed beverages.

YOUNG COUNTY

City of Newcastle, Young County, on August 28, 1980, voted 162 "For the legal sale of all alcoholic beverages for off-premise consumption only" and 211 "Against the legal sale of all alcoholic beverages for off-premise consumption only." Newcastle was "Dry" before the election was held and remained "Dry".
