## LOCAL OPTION ELECTIONS

There were forty-six local option elections during the fiscal year ending August 31, 1981. Nineteen elections were called to legalize the sale of all alcoholic beverages for off-premise consumption only; seven became "wet" and twelve remained "dry." Four elections were called to legalize the sale of mixed beverages; two became "wet" and two remained "dry." Seven elections were called to legalize the sale of alcoholic beverages including mixed beverages; four became "wet" and three remained "dry." One election was called to legalize the sale of all alcoholic beverages except mixed beverages; one became "wet." Ten elections were called to legalize the sale of beer and wine for off-premise consumption only; four became "wet" and six remained "dry." Three elections were called to legalize the sale of beer for off-premise consumption only; two remained "dry" and one became "wet." Two elections were called to legalize the sale of beer and wine; two remained "dry."

The voting for the fiscal year:

### BOWIE COUNTY

City of Nash, Bowie County, on April 11, 1981, voted 246 for "the legal sale of beer and wine for off-premise consumption only" and 476 against "the legal sale of beer and wine for off-premise consumption only." City of Nash was "dry" before the election was held and remained "dry."

### CHAMBERS COUNTY

Precinct No. 5, Chambers County, on June 6, 1981, voted 123 for "the legal sale of all alcoholic beverages for off-premise consumption only" and 201 against "the legal sale of all alcoholic beverages for off-premise consumption only." Precinct No. 5 was "dry" before the election was held and remained "dry."

### COLLIN COUNTY

City of Melissa, Collin County, on February 10, 1981, voted 125 for "the legal sale of all alcoholic beverages for off-premise consumption only" and 133 against "the legal sale of all alcoholic beverages for off-premise consumption only." City of Melissa was "dry" before the election was held and remained "dry."

City of Melissa, Collin County, on May 9, 1981, voted 149 for "the legal sale of beer and wine for off-premise consumption only" and 142 against "the legal sale of beer and wine for off-premise consumption only." City of Melissa was "dry" before the election was held and became "wet" for the legal sale of beer and wine for off-premise consumption only.

Precinct No. 5, Collin County, on June 6, 1981, voted 7,629 for "the legal sale of all alcoholic beverages including mixed beverages" and 8,736 against "the legal sale of all alcoholic beverages including mixed beverages." Precinct No. 5 was "dry" before the election was held and remained "dry."

#### DENTON COUNTY

City of The Colony, Denton County, on November 8, 1980, voted 1,082 for "the legal sale of all alcoholic beverages including mixed beverages" and 813 against "the legal sale of all alcoholic beverages including mixed beverages." City of The Colony was "dry" before the election was held and became "wet" for the legal sale of all alcoholic beverages including mixed beverages.

#### DEWITT COUNTY

Precinct No. 6, DeWitt County, on November 12, 1980, voted 149 for "the legal sale of beer for off-premise consumption only" and 56 against "the legal sale of beer for off-premise consumption only." Precinct No. 6 was "dry" before the election was held and became "wet" for the legal sale of beer for off-premise consumption only.

#### DONLEY COUNTY

City of Howardwick, Donley County, on July 13, 1981, voted 78 for "the legal sale of all alcoholic beverages including mixed beverages" and 43 against "the legal sale of all alcoholic beverages including mixed beverages." City of Howardwick was "dry" before the election was held and became "wet" for the legal sale of all alcoholic beverages including mixed beverages.

#### EASTLAND COUNTY

Precinct No. 1, Eastland County, on June 6, 1981, voted 456 for "the legal sale of all alcoholic beverages for off-premise consumption only" and 910 against "the legal sale of all alcoholic beverages for off-premise consumption only." Precinct No. 1 was "dry" before the election was held and remained "dry."

FOARD COUNTY

City of Crowell, Foard County, on October 4, 1980, voted 322 for "the legal sale of all alcoholic beverages for off-premise consumption only" and 665 against "the legal sale of all alcoholic beverages for off-premise consumption only." City of Crowell was "dry" before the election was held and remained "dry."

GRAYSON COUNTY

City of Pottsboro, Grayson County, on March 7, 1981, voted 210 for "the legal sale of beer for off-premise consumption only" and 227 against "the legal sale of beer for off-premise consumption only." City of Pottsboro was "dry" before the election was held and remained "dry."

City of Pottsboro, Grayson County, on May 16, 1981, voted 175 for "the legal sale of beer and wine for off-premise consumption only" and 267 against "the legal sale of beer and wine for off-premise consumption only." City of Pottsboro was "dry" before the election was held and remained "dry."

GRIMES COUNTY

City of Navasota, Grimes County, on November 8, 1980, voted 579 for "the legal sale of all alcoholic beverages including mixed beverages" and 310 against "the legal sale of all alcoholic beverages including mixed beverages." City of Navasota was "dry" before the election was held and became "wet" for the legal sale of all alcoholic beverages including mixed beverages.

HALL COUNTY

City of Turkey, Hall County, on December 5, 1980, voted 136 for "the legal sale of all alcoholic beverages for off-premise consumption only" and 211 against "the legal sale of all alcoholic beverages for off-premise consumption only." City of Turkey was "dry" before the election was held and remained "dry."

HENDERSON COUNTY

City of Caney, Henderson County, on December 6, 1980, voted 19 for "the legal sale of mixed beverages" and 46 against "the legal sale of mixed beverages." City of Caney was "dry" before the election was held and remained "dry."

City of Seven Points, Henderson County, on August 8, 1981, voted 200 for "the legal sale of all alcoholic beverages except mixed beverages" and 44 against "the legal sale of all alcoholic beverages except mixed beverages." City of Seven Points was "dry" before the election was held and became "wet" for the legal sale of all alcoholic beverages except mixed beverages.

City of Tool, Henderson County, on August 8, 1981, voted 337 for "the legal sale of beer and wine for off-premise consumption only" and 270 against "the legal sale of beer and wine for off-premise consumption only." City of Tool was "dry" before the election was held and became "wet" for the legal sale of beer and wine for off-premise consumption only.

#### HILL COUNTY

City of Itasca, Hill County, on October 4, 1980, voted 301 for "the legal sale of alcoholic beverages for off-premise consumption only" and 304 against "the legal sale of alcoholic beverages for off-premise consumption only." City of Itasca was "dry" before the election was held and remained "dry."

#### HUNT COUNTY

City of Lone Oak, Hunt County, on November 6, 1980, voted 62 for "the legal sale of beer and wine for off-premise consumption only" and 143 against "the legal sale of beer and wine for off-premise consumption only." City of Lone Oak was "dry" before the election was held and remained "dry."

#### HUTCHINSON COUNTY

Precinct No. 9, Hutchinson County, on March 31, 1981, voted 6 for "the legal sale of all alcoholic beverages for off-premise consumption only" and 20 against "the legal sale of all alcoholic beverages for off-premise consumption only." Precinct No. 9 was "dry" before the election was held and remained "dry."

#### JACKSON COUNTY

Precinct No. 2, Jackson County, on October 6, 1980, voted 290 for "the legal sale of mixed beverages" and 149 against "the legal sale of mixed beverages." Precinct No. 2 was "dry" before the election was held and became "wet" for the legal sale of mixed beverages.

Precinct No. 1, Jackson County, on October 6, 1980, voted 403 for "the legal sale of mixed beverages" and 436 against "the legal sale of mixed beverages." Precinct No. 1 was "dry" before the election was held and remained "dry."

Precinct No. 4, Jackson County, on August 22, 1981, voted 148 for "the legal sale of beer and wine" and 218 against "the legal sale of beer and wine." Precinct No. 4 was "dry" before the election was held and remained "dry."

#### JEFF DAVIS COUNTY

Precinct No. 3, Jeff Davis County, on June 5, 1981, voted 42 for "the legal sale of beer and wine" and 108 against "the legal sale of beer and wine." Precinct No. 3 was "dry" before the election was held and remained "dry."

#### JOHNSON COUNTY

City of Venus, Johnson County, on March 7, 1981, voted 93 for "the legal sale of all alcoholic beverages for off-premise consumption only" and 134 against "the legal sale of all alcoholic beverages for off-premise consumption only." City of Venus was "dry" before the election was held and remained "dry."

City of Rio Vista, Johnson County, on March 28, 1981, voted 76 for "the legal sale of beer and wine for off-premise consumption only" and 113 against "the legal sale of beer and wine for off-premise consumption only." City of Rio Vista was "dry" before the election was held and remained "dry."

City of Rio Vista, Johnson County, on August 29, 1981, voted 59 for "the legal sale of beer for off-premise consumption only" and 114 against "the legal sale of beer for off-premise consumption only." City of Rio Vista was "dry" before the election was held and remained "dry."

#### KLEBERG COUNTY

Precinct No. 1, Kleberg County, on February 7, 1981, voted 225 for "the legal sale of all alcoholic beverages including mixed beverages" and 246 against "the legal sale of all alcoholic beverages including mixed beverages." Precinct No. 1 was "dry" before the election was held and remained "dry."

LEON COUNTY

City of Jewett, Leon County, on February 3, 1981, voted 153 for "the legal sale of all alcoholic beverages for off-premise consumption only" and 152 against "the legal sale of all alcoholic beverages for off-premise consumption only." City of Jewett was "dry" before the election was held and became "wet" for the legal sale of all alcoholic beverages for off-premise consumption only.

LLANO COUNTY

City of Sunrise Beach Village, Llano County, on September 4, 1980, voted 96 for "the legal sale of all alcoholic beverages for off-premise consumption only" and 87 against "the legal sale of all alcoholic beverages for off-premise consumption only." City of Sunrise Beach Village was "dry" before the election was held and became "wet" for the legal sale of all alcoholic beverages for off-premise consumption only.

MARION COUNTY

Precinct No. 2, Marion County, on September 4, 1980, voted 204 for "the legal sale of beer and wine for off-premise consumption only" and 286 against "the legal sale of beer and wine for off-premise consumption only." Precinct No. 2 was "dry" before the election was held and remained "dry."

City of Jefferson, Marion County, on June 2, 1981, voted 534 for "the legal sale of all alcoholic beverages for off-premise consumption only" and 273 against "the legal sale of all alcoholic beverages for off-premise consumption only." City of Jefferson was "dry" before the election was held and became "wet" for the legal sale of all alcoholic beverages for off-premise consumption only.

NAVARRO COUNTY

Precinct No. 107, Navarro County, on February 7, 1981, voted 76 for "the legal sale of all alcoholic beverages including mixed beverages" and 111 against "the legal sale of all alcoholic beverages including mixed beverages." Precinct No. 107 was "dry" before the election was held and remained "dry."

City of Rice, Navarro County, on August 8, 1981, voted 109 for "the legal sale of all alcoholic beverages for off-premise consumption only" and 100 against "the legal sale of all alcoholic beverages for off-premise consumption only." City of Rice was "dry" before the election was held and became "wet" for the legal sale of all alcoholic beverages for off-premise consumption only.



NUECES COUNTY

City of Driscoll, Nueces County, on June 30, 1981, voted 93 for "the legal sale of beer and wine for off-premise consumption only" and 36 against "the legal sale of beer and wine for off-premise consumption only." City of Driscoll was "dry" before the election was held and became "wet" for the legal sale of beer and wine for off-premise consumption only.

POLK COUNTY

Precinct No. 1, Polk County, on May 9, 1981, voted 536 for "the legal sale of all alcoholic beverages for off-premise consumption only" and 660 against "the legal sale of all alcoholic beverages for off-premise consumption only." Precinct No. 1 was "dry" before the election was held and remained "dry."

REAL COUNTY

Precinct No. 3, Real County, on January 3, 1981, voted 86 for "the legal sale of all alcoholic beverages for off-premise consumption only" and 158 against "the legal sale of all alcoholic beverages for off-premise consumption only." Precinct No. 3 was "dry" before the election was held and remained "dry."

RED RIVER COUNTY

City of Annona, Red River County, on December 6, 1980, voted 173 for "the legal sale of all alcoholic beverages for off-premise consumption only" and 69 against "the legal sale of all alcoholic beverages for off-premise consumption only." City of Annona was "dry" before the election was held and became "wet" for the legal sale of all alcoholic beverages for off-premise consumption only.

ROBERTS COUNTY

Precinct No. 3, Roberts County, on March 7, 1981, voted 36 for "the legal sale of all alcoholic beverages for off-premise consumption only" and 111 against "the legal sale of all alcoholic beverages for off-premise consumption only." Precinct No. 3 was "dry" before the election was held and remained "dry."

ROBERTSON COUNTY

Precinct No. 5, Robertson County, on May 9, 1981, voted 215 for "the legal sale of all alcoholic beverages for off-premise consumption only" and 172 against "the legal sale of all alcoholic beverages for off-premise consumption only." Precinct No. 5 was "dry" before the election was held and became "wet" for the legal sale of all alcoholic beverages for off-premise consumption only.

SAN PATRICIO COUNTY

City of Portland, San Patricio County, on June 6, 1981, voted 742 for "the legal sale of all alcoholic beverages for off-premise consumption only" and 689 against "the legal sale of all alcoholic beverages for off-premise consumption only." City of Portland was "dry" before the election was held and became "wet" for the legal sale of all alcoholic beverages for off-premise consumption only.

TARRANT COUNTY

City of Bedford, Tarrant County, on December 30, 1980, voted 1,435 for "the legal sale of mixed beverages" and 848 against "the legal sale of mixed beverages." City of Bedford was "dry" before the election was held and became "wet" for the legal sale of mixed beverages.

City of Everman, Tarrant County, on June 6, 1981, voted 617 for "the legal sale of all alcoholic beverages including mixed beverages" and 398 against "the legal sale of all alcoholic beverages including mixed beverages." City of Everman was "dry" before the election was held and became "wet" for the legal sale of all alcoholic beverages including mixed beverages.

TERRY COUNTY

City of Brownfield, Terry County, on October 20, 1980, voted 953 for "the legal sale of all alcoholic beverages for off-premise consumption only" and 1,770 against "the legal sale of all alcoholic beverages for off-premise consumption only." City of Brownfield was "dry" before the election was held and remained "dry."

WALKER COUNTY

City of Huntsville, Walker County, on August 8, 1981, voted 326 for "the legal sale of beer and wine for off-premise consumption only" and 264 against "the legal sale of beer and wine for off-premise consumption only." City of Huntsville was "dry" before the election was held and became "wet" for the legal sale of beer and wine for off-premise consumption only.

WILLACY COUNTY

Precinct No. 5, Willacy County, on November 8, 1980, voted 95 for "the legal sale of beer and wine for off-premise consumption only" and 121 against "the legal sale of beer and wine for off-premise consumption only." Precinct No. 5 was "dry" before the election was held and remained "dry."
