LOCAL OPTION ELECTIONS

There were thirty-two local option elections during the fiscal year ending August 31, 1982. Eleven elections were called to legalize the sale of all alcoholic beverages for off-premise consumption only; nine remained "dry" and two became "wet." Five elections were called to legalize the sale of all alcoholic beverages including mixed beverages; two remained "dry" and three became "wet." Seven elections were called to legalize the sale of beer and wine for off-premise consumption only; six remained "dry" and one became "wet." Three elections were called to legalize the sale of beer for off-premise consumption only; three became "wet." Two elections were called to legalize the sale of mixed beverages; two became "wet." Two elections were called to legalize the sale of all alcoholic beverages except mixed beverages; two became "wet." One election was called to legalize the sale of all alcoholic beverages except mixed beverages for on- or off-premise consumption; one remained "dry." One election was called to legalize the sale of all alcoholic beverages for off-premise consumption including mixed beverages; one remained "dry."

The voting for the fiscal year:

ANGELINA COUNTY

City of Lufkin, Angelina County, on December 5, 1981, voted 3,493 for "the legal sale of all alcoholic beverages for off-premise consumption only" and 3,897 against "the legal sale of all alcoholic beverages for off-premise consumption only." City of Lufkin, Angelina County, was "dry" before the election was held and remained "dry."

BELL COUNTY

City of Harker Heights, Bell County, on September 1, 1981, voted 215 for "the legal sale of all alcoholic beverages including mixed beverages" and 181 against "the legal sale of all alcoholic beverages including mixed beverages." City of Harker Heights, Bell County, was "dry" before the election was held and became "wet" for the legal sale of all alcoholic beverages including mixed beverages.

CAMERON COUNTY

City of Bayview, Cameron County, on September 12, 1981, voted 51 for "the legal sale of all alcoholic beverages including mixed beverages" and 60 against "the legal sale of all alcoholic beverages including mixed beverages." City of Bayview, Cameron County, was "dry" before the election was held and remained "dry."

City of Brownsville, Cameron County, on November 7, 1981, voted 84 for "the legal sale of beer and wine for off-premise consumption only" and 56 against "the legal sale of beer and wine for off-premise consumption only." City of Brownsville, Cameron County, was "dry" before the election was held and became "wet" for the legal sale of beer and wine for off-premise consumption only.

CHAMBERS COUNTY

Precinct No. 1, Chambers County, on July 10, 1982, voted 138 for "the legal sale of mixed beverages" and 101 against "the legal sale of mixed beverages." Precinct No. 1, Chambers County, was "dry" before the election was held and became "wet" for the legal sale of mixed beverages.

Precinct No. 2, Chambers County, on August 14, 1982, voted 99 for "the legal sale of all alcoholic beverages except mixed beverages" and 39 against "the legal sale of all alcoholic beverages except mixed beverages." Precinct No. 2, Chambers County, was "dry" before the election was held and became "wet" for the legal sale of all alcoholic beverages except mixed beverages.

COLLIN COUNTY

City of Fairview, Collin County, on September 3, 1981, voted 47 for "the legal sale of beer and wine for off-premise consumption only" and 265 against "the legal sale of beer and wine for off-premise consumption only." City of Fairview, Collin County, was "dry" before the election was held and remained "dry."

City of Westminster, Collin County, on September 3, 1981, voted 49 for "the legal sale of beer and wine for off-premise consumption only" and 107 against "the legal sale of beer and wine for off-premise consumption only." City of Westminster, Collin County, was "dry" before the election was held and remained "dry."

City of McKinney, Collin County, on November 3, 1981, voted 7,051 for "the legal sale of all alcoholic beverages for off-premise consumption only" and 9,523 against "the legal sale of all alcoholic beverages for off-premise consumption only." City of McKinney, Collin County, was "dry" before the election was held and remained "dry."

City of Altoga, Collin County, on July 10, 1982, voted 16 for "the legal sale of beer and wine for off-premise consumption only" and 95 against "the legal sale of beer and wine for off-premise consumption only." City of Altoga, Collin County, was "dry" before the election was held and remained "dry."

DALLAS COUNTY

City of Irving, Dallas County, on October 17, 1981, voted 13,158 for "the legal sale of mixed beverages" and 12,373 against "the legal sale of mixed beverages." City of Irving, Dallas County, was "dry" before the election was held and became "wet" for the legal sale of mixed beverages.

DENTON COUNTY

City of Corinth, Denton County, on March 6, 1982, voted 91 for "the legal sale of all alcoholic beverages including mixed beverages" and 194 against "the legal sale of all alcoholic beverages including mixed beverages." City of Corinth, Denton County, was "dry" before the election was held and remained "dry."

ELLIS COUNTY

City of Alma, Ellis County, on February 27, 1982, voted 42 for "the legal sale of all alcoholic beverages for off-premise consumption only" and 34 against "the legal sale of all alcoholic beverages for off-premise consumption only." City of Alma, Ellis County, was "dry" before the election was held and became "wet" for the legal sale of all alcoholic beverages for off-premise consumption only.

City of Ferris, Ellis County, on August 28, 1982, voted 167 for "the legal sale of all alcoholic beverages for off-premise consumption only" and 406 against "the legal sale of all alcoholic beverages for off-premise consumption only." City of Ferris, Ellis County, was "dry" before the election was held and remained "dry."

ERATH COUNTY

City of Stephenville, Erath County, on May 8, 1982, voted 1,106 for "the legal sale of beer and wine for off-premise consumption only" and 2,145 against "the legal sale of beer and wine for off-premise consumption only." City of Stephenville, Erath County, was "dry" before the election was held and remained "dry."

FREESTONE COUNTY

City of Kirvin, Freestone County, on June 1, 1982, voted 25 for "the legal sale of all alcoholic beverages for off-premise consumption only" and 38 against "the legal sale of all alcoholic beverages for off-premise consumption only." City of Kirvin, Freestone County, was "dry" before the election was held and remained "dry."

HALL COUNTY

City of Estelline, Hall County, on October 13, 1981, voted 57 for "the legal sale of all alcoholic beverages for off-premise consumption only" and 59 against "the legal sale of all alcoholic beverages for off-premise consumption only." City of Estelline, Hall County, was "dry" before the election was held and remained "dry."

City of Estelline, Hall County, on December 8, 1981, voted 70 for "the legal sale of beer and wine for off-premise consumption only" and 72 against "the legal sale of beer and wine for off-premise consumption only." City of Estelline, Hall County, was "dry" before the election was held and remained "dry."

HILL COUNTY

City of Itasca, Hill County, on December 5, 1981, voted 318 for "the legal sale of all alcoholic beverages except mixed beverages for on- or off-premise consumption" and 356 against "the legal sale of all alcoholic beverages except mixed beverages for on- or off-premise consumption." City of Itasca, Hill County, was "dry" before the election was held and remained "dry."

City of Abbott, Hill County, on April 3, 1982, voted 94 for "the legal sale of all alcoholic beverages for off-premise consumption only" and 50

against "the legal sale of all alcoholic beverages for off-premise consumption only." City of Abbott, Hill County, was "dry" before the election was held and became "wet" for the legal sale of all alcoholic beverages for off-premise consumption only.

HOPKINS COUNTY

City of Como, Hopkins County, on July 10, 1982, voted 112 for "the legal sale of all alcoholic beverages for off-premise consumption only" and 173 against "the legal sale of all alcoholic beverages for off-premise consumption only." City of Como, Hopkins County, was "dry" before the election was held and remained "dry."

KLEBERG COUNTY

Precinct No. 2, Kleberg County, on July 10, 1982, voted 167 for "the legal sale of all alcoholic beverages including mixed beverages" and 56 against "the legal sale of all alcoholic beverages including mixed beverages." Precinct No. 2, Kleberg County, was "dry" before the election was held and became "wet" for the legal sale of all alcoholic beverages including mixed beverages.

LAMAR COUNTY

City of Blossom, Lamar County, on September 5, 1981, voted 141 for "the legal sale of all alcoholic beverages for off-premise consumption only" and 195 against "the legal sale of all alcoholic beverages for off-premise consumption only." City of Blossom, Lamar County, was "dry" before the election was held and remained "dry."

LLANO COUNTY

Precinct No. 2, Llano County, on July 10, 1982, voted 177 for "the legal sale of all alcoholic beverages for off-premise consumption only" and 299 against "the legal sale of all alcoholic beverages for off-premise consumption only." Precinct No. 2, Llano County, was "dry" before the election was held and remained "dry."

MCLENNAN COUNTY

City of Waco, McLennan County, on November 7, 1981, voted 662 for "the legal sale of beer and wine for off-premise consumption only" and 794 against "the legal sale of beer and wine for off-premise consumption only." City of Waco, McLennan County, was "dry" before the election was held and remained "dry."

MARION COUNTY

Precinct No. 1, Marion County, on May 8, 1982, voted 200 for "the legal sale of beer for off-premise consumption only" and 126 against "the legal sale of beer for off-premise consumption only." Precinct No. 1, Marion County, was "dry" before the election was held and became "wet" for the legal sale of beer for off-premise consumption only.

ORANGE COUNTY

City of Orange, Orange County, on November 3, 1981, voted 255 for "the legal sale of all alcoholic beverages except mixed beverages" and 191 against "the legal sale of all alcoholic beverages except mixed beverages." City of Orange, Orange County, was "dry" before the election was held and became "wet" for the legal sale of all alcoholic beverages except mixed beverages.

SABINE COUNTY

City of Bronson, Sabine County, on March 22, 1982, voted 52 for "the legal sale of all alcoholic beverages for off-premise consumption including mixed beverages" and 81 against "the legal sale of all alcoholic beverages for off-premise consumption including mixed beverages." City of Bronson, Sabine County, was "dry" before the election was held and remained "dry."

TARRANT COUNTY

City of Westworth Village, Tarrant County, on September 26, 1981, voted 254 for "the legal sale of beer for off-premise consumption only" and 166 against "the legal sale of beer for off-premise consumption only." City of Westworth Village, Tarrant County, was "dry" before the election was held and became "wet" for the legal sale of beer for off-premise consumption only.

City of Westworth Village, Tarrant County, on April 24, 1982, voted 183 for "the legal sale of all alcoholic beverages including mixed beverages" and 105 against "the legal sale of all alcoholic beverages including mixed beverages." City of Westworth Village, Tarrant County, was "dry" before the election was held and became "wet" for the legal sale of all alcoholic beverages including mixed beverages.

City of Watauga, Tarrant County, on July 31, 1982, voted 516 for "the legal sale of beer for off-premise consumption only" and 212 against "the legal sale of beer for off-premise consumption only." City of Watauga, Tarrant County, was "dry" before the election was held and became "wet" for the legal sale of beer for off-premise consumption only.

YOUNG COUNTY

City of Newcastle, Young County, on December 5, 1981, voted 145 for "the legal sale of all alcoholic beverages for off-premise consumption only" and 212 against "the legal sale of all alcoholic beverages for off-premise consumption only." City of Newcastle, Young County, was "dry" before the election was held and remained "dry."
