TEXAS ALCOHOLIC BEVERAGE COMMISSION

LOCAL OPTION ELECTIONS

There were thirty-four local option elections during the fiscal year ending August 31, 1986. Four elections were called to legalize the sale of all alcoholic beverages, including mixed beverages; three remained "dry" and one became "wet." Seventeen elections were called to legalize the sale of all alcoholic beverages for off-premise consumption only; thirteen remained "dry" and four became "wet." Six elections were called to legalize the sale of beer and wine for off-premise consumption only; all remained "dry." Three elections were called to legalize the sale of beer; all became "wet." Two elections were called to legalize the sale of mixed beverages; two became "wet." One election was called to legalize the sale of all alcoholic beverages, except mixed beverages; one remained "dry." One election was called to legalize the sale of beer for off-premise consumption only; one became "wet."

The voting for the fiscal year:

CHEROKEE COUNTY

Town of Cuney, Cherokee County, on September 23, 1985, voted 51 for "the legal sale of all alcoholic beverages for off-premise consumption only" and 9 against "the legal sale of all alcoholic beverages for off-premise consumption only." Town of Cuney, Cherokee County, was "dry" before the election was held and became "wet" for the legal sale of all alcoholic beverages for off-premise consumption only.

COLEMAN COUNTY

Precinct No. 3, Coleman County, on February 8, 1986, voted 162 for "the legal sale of all alcoholic beverages for off-premise consumption only" and 419 against "the legal sale of all alcoholic beverages for off-premise consumption only." Precinct No. 3, Coleman County, was "dry" before the election was held and remained "dry."

COLLIN COUNTY

City of New Hope, Collin County, on August 9, 1986, voted 86 for "the legal sale of all alcoholic beverages for off-premise consumption only" and 190 against "the legal sale of all alcoholic beverages for off-premise consumption only." City of New Hope, Collin County, was "dry" before the election was held and remained "dry."

CONCHO COUNTY

Precinct No. 1, Concho County, on January 13, 1986, voted 112 for "the legal sale of beer" and 66 against "the legal sale of beer." Precinct No. 1, Concho County, was "dry" before the election was held and became "wet" for the legal sale of beer.

DALLAS COUNTY

City of DeSoto, Dallas County, on July 26, 1986, voted 1,477 for "the legal sale of beer and wine for off-premise consumption only" and 3,054 against "the legal sale of beer and wine for off-premise consumption only." City of DeSoto, Dallas County, was "dry" before the election was held and remained "dry."

DENTON COUNTY

Precinct No. 4, Denton County, on May 24, 1986, voted 520 for "the legal sale of all alcoholic beverages for off-premise consumption only" and 1,461 against "the legal sale of all alcoholic beverages for off-premise consumption only." Precinct No. 4, Denton County, was "dry" before the election was held and remained "dry."

EASTLAND COUNTY

City of Ranger, Eastland County, on December 17, 1985, voted 50 for "the legal sale of all alcoholic beverages for off-premise consumption only" and 147 against "the legal sale of all alcoholic beverages for off-premise consumption only." Prior to this election, the City of Ranger had been voted "wet" on the above issue, but later additional area annexed into the city limits, and this election was to attempt to get this annexed area "wet," also. The City of Ranger remains "wet," except for the annexed area, which remains "dry."

GAINES COUNTY

City of Seminole, Gaines County, on June 3, 1986, voted 286 for "the legal sale of all alcoholic beverages for off-premise consumption only" and 506 against "the legal sale of all alcoholic beverages for off-premise consumption only." City of Seminole, Gaines County, was "dry" before the election was held and remained "dry."

GRAYSON COUNTY

City of Knollwood, Grayson County, on September 14, 1985, voted 28 for "the legal sale of all alcoholic beverages, including mixed beverages" and 32 against "the legal sale of all alcoholic beverages, including mixed beverages." City of Knollwood, Grayson County, was "dry" before the election was held and remained "dry."

GRAYSON COUNTY

City of Knollwood, Grayson County, on November 9, 1985, voted 79 for "the legal sale of all alcoholic beverages for off-premise consumption only" and 34 against "the legal sale of all alcoholic beverages for off-premise consumption only." City of Knollwood, Grayson County, was "dry" before the election was held and became "wet" for the legal sale of all alcoholic beverages for off-premise consumption only.

Local Option Elections (continued)

GRAYSON COUNTY

City of Gunter, Grayson County, on November 23, 1985, voted 83 for "the legal sale of beer and wine for off-premise consumption only" and 239 against "the legal sale of beer and wine for off-premise consumption only." City of Gunter, Grayson County, was "dry" before the election was held and remained "dry."

GRAYSON COUNTY

City of Luella, Grayson County, on May 24, 1986, voted 37 for "the legal sale of all alcoholic beverages for off-premise consumption only" and 187 against "the legal sale of all alcoholic beverages for off-premise consumption only." City of Luella, Grayson County, was "dry" before the election was held and remained "dry."

HENDERSON COUNTY

City of Malakoff, Henderson County, on March 8, 1986, voted 137 for "the legal sale of beer and wine for off-premise consumption only" and 514 against "the legal sale of beer and wine for off-premise consumption only." City of Malakoff, Henderson County, was "dry" before the election was held and remained "dry."

HENDERSON COUNTY

City of Caney City, Henderson County, on March 11, 1986, voted 36 for "the legal sale of all alcoholic beverages, except mixed beverages" and 48 against "the legal sale of all alcoholic beverages, except mixed beverages." Prior to this election, the City of Caney City had been voted "wet" on the above issue, but later additional area annexed into the city limits, and this election was to attempt to get this annexed area "wet," also. The City of Caney City remains "wet," except for the annexed area, which remains "dry."

HOCKLEY COUNTY

Town of Opdyke West, Hockley County, on December 9, 1985, voted 36 for "the legal sale of beer" and 10 against "the legal sale of beer." Town of Opdyke West, Hockley County, was "dry" before the election was held and became "wet" for the legal sale of beer.

HOCKLEY COUNTY

City of Levelland, Hockley County, on February 8, 1986, voted 1,538 for "the legal sale of all alcoholic beverages for off-premise consumption only" and 1,669 against "the legal sale of all alcoholic beverages for off-premise consumption only." City of Levelland, Hockley County, was "dry" before the election was held and remained "dry."

HOWARD COUNTY

Precinct No. 1, Howard County, on June 9, 1986, voted 3,457 for "the legal sale of mixed beverages" and 1,818 against "the legal sale of mixed beverages." Precinct No. 1, Howard County, was "wet" for all alcoholic beverages, except mixed beverages before the election was held and became "wet" for the legal sale of all alcoholic beverages, including mixed beverages.

LAMAR COUNTY

City of Reno, Lamar County, on November 5, 1985, voted 133 for "the legal sale of all alcoholic beverages for off-premise consumption only" and 233 against "the legal sale of all alcoholic beverages for off-premise consumption only." City of Reno, Lamar County, was "dry" before the election was held and remained "dry."

LAMAR COUNTY

City of Reno, Lamar County, on August 9, 1986, voted 114 for "the legal sale of beer and wine for off-premise consumption only" and 259 against "the legal sale of beer and wine for off-premise consumption only." City of Reno, Lamar County, was "dry" before the election was held and remained "dry."

LAMB COUNTY

City of Olton, Lamb County, on June 21, 1986, voted 288 for "the legal sale of all alcoholic beverages for off-premise consumption only" and 351 against "the legal sale of all alcoholic beverages for off-premise consumption only." City of Olton, Lamb County, was "dry" before the election was held and remained "dry."

LAMPASAS COUNTY

City of Lampasas, Lampasas County, on December 10, 1985, voted 808 for "the legal sale of all alcoholic beverages for off-premise consumption only" and 752 against "the legal sale of all alcoholic beverages for off-premise consumption only." City of Lampasas, Lampasas County, was "dry" before the election was held and became "wet" for the legal sale of all alcoholic beverages for off-premise consumption only.

LAMPASAS COUNTY

Precinct No. 4, Lampasas County, on August 19, 1986, voted 295 for "the legal sale of beer and wine for off-premise consumption only" and 393 against "the legal sale of beer and wine for off-premise consumption only." Precinct No. 4, Lampasas County, was "dry" before the election was held and remained "dry."

Local Option Elections (concluded)

LEE COUNTY

Precinct No. 1, Lee County, on December 4, 1985, voted 90 for "the legal sale of all alcoholic beverages, including mixed beverages" and 36 against "the legal sale of all alcoholic beverages, including mixed beverages." Precinct No. 1, Lee County, was "wet" for the sale of all alcoholic beverages, except mixed beverages before the election was held and became "wet" for the legal sale of all alcoholic beverages, including mixed beverages.

LEON COUNTY

Precinct No. 5, Leon County, on May 24, 1986, voted 193 for "the legal sale of all alcoholic beverages for off-premise consumption only" and 229 against "the legal sale of all alcoholic beverages for off-premise consumption only." Precinct No. 5, Leon County, was "dry" before the election was held and remained "dry."

MEDINA COUNTY

Precinct No. 4, Medina County, on October 15, 1985, voted 199 for "the legal sale of all alcoholic beverages, including mixed beverages" and 223 against "the legal sale of all alcoholic beverages, including mixed beverages." Precinct No. 4, Medina County, was "dry" before the election was held and remained "dry."

POLK COUNTY

City of Onalaska, Polk County, on August 9, 1986, voted 21 for "the legal sale of all alcoholic beverages for off-premise consumption only" and 26 against "the legal sale of all alcoholic beverages for off-premise consumption only." This election was to take in a portion of the city that had been annexed, and as a result of the election the old city limits remained "wet," while the new area remained "dry."

ROBERTSON COUNTY

Precinct No. 1, Robertson County, on July 26, 1986, voted 103 for "the legal sale of beer for off-premise consumption only" and 74 against "the legal sale of beer for off-premise consumption only." Precinct No. 1, Robertson County, was "dry" before the election was held and became "wet" for the legal sale of beer for off-premise consumption only.

RUNNELS COUNTY

Precinct No. 2, Runnels County, on November 5, 1985, voted 603 for "the legal sale of all alcoholic beverages for off-premise consumption only" and 777 against "the legal sale of all alcoholic beverages for off-premise consumption only." Precinct No. 2, Runnels County, was "dry" before the election was held and remained "dry."

RUNNELS COUNTY

Precinct No. 1, Runnels County, on December 6, 1985, voted 683 for "the legal sale of all alcoholic beverages for off-premise consumption only" and 659 against "the legal sale of all alcoholic beverages for off-premise consumption only." Precinct No. 1, Runnels County, was "dry" before the election was held and became "wet" for the legal sale of all alcoholic beverages for off-premise consumption only.

STONEWALL COUNTY

Precinct No. 4, Stonewall County, on March 8, 1986, voted 44 for "the legal sale of all alcoholic beverages for off-premise consumption only" and 61 against "the legal sale of all alcoholic beverages for off-premise consumption only." Precinct No. 4, Stonewall County, was "dry" before the election was held and remained "dry."

TARRANT COUNTY

City of Haltom, Tarrant County, on July 26, 1986, voted 1,613 for "the legal sale of beer and wine for off-premise consumption only" and 2,003 against "the legal sale of beer and wine for off-premise consumption only." City of Haltom, Tarrant County, was "dry" before the election was held and remained "dry."

TARRANT COUNTY

City of White Settlement, Tarrant County, on August 23, 1986, voted 692 for "the legal sale of all alcoholic beverages, including mixed beverages" and 1,429 against "the legal sale of all alcoholic beverages, including mixed beverages." City of White Settlement, Tarrant County, was "dry" before the election was held and remained "dry."

WICHITA COUNTY

Precinct No. 1, Wichita County, on February 8, 1986, voted 11,296 for "the legal sale of mixed beverages" and 5,083 against "the legal sale of mixed beverages." Precinct No. 1, Wichita County, was "wet" for all alcoholic beverages, except mixed beverages before the election was held, and became "wet" for all alcoholic beverages, including mixed beverages.

WISE COUNTY

Town of Lake Bridgeport, Wise County, on May 10, 1986, voted 98 for "the legal sale of beer" and 74 against "the legal sale of beer." Town of Lake Bridgeport, Wise County, was "dry" before the election was held and became "wet" for the legal sale of beer.
