### LOCAL OPTION ELECTIONS

There were twenty-two local option elections during the fiscal year ending August 31, 1989. Five elections were called to legalize the sale of all alcoholic beverages, including mixed beverages; four remained "dry" and one became "wet." One election was called to legalize the sale of beer and wine; one became "wet." One election was called to prohibit the sale of all alcoholic beverages for off-premise consumption only; one remains "wet." Five elections were called to legalize the sale of beer and wine for off-premise consumption only; four remain "dry" and one became "wet." One election was called to legalize the sale of beer for off-premise consumption only; one remained "dry." Nine elections were called to legalize the sale of all alcoholic beverages for off-premise consumption only; five became "wet" and four remained "dry."

The voting for the fiscal year:

### BURNET COUNTY

A local option election was held on May 20, 1989, in Justice Precinct 3, Burnet County, for the issue of "The legal sale of beer and wine for off-premise consumption only." The election was tied by a vote of 93 FOR and 93 AGAINST. Justice Precinct 3, Burnet County, was "dry" before the election and remains "dry."

### CAMP COUNTY

A local option election was held on September 3, 1988, in Justice Precinct 2, Camp County, for the issue of "The legal sale of all alcoholic beverages for off-premise consumption only." The election failed by a vote of 233 FOR and 399 AGAINST. Justice Precinct 2, Camp County, was "dry" before the election and remains "dry."

### COLEMAN COUNTY

A local option election was held on August 5, 1989, in the City of Coleman, Coleman County, for the issue of "The legal sale of beer for off-premise consumption only." The election failed by a vote of 315 FOR and 797 AGAINST. The City of Coleman, Coleman County, was "dry" before the election and remains "dry."

### COOKE COUNTY

A local option election was held on January 7, 1989, in the Town of Oak Ridge, Cooke County, for the issue of "The legal sale of all alcoholic beverages for off-premise consumption only." The election passed by a vote of 52 FOR and 2 AGAINST. The Town of Oak Ridge, Cooke County, was "dry" before the election and became "wet" for the legal sale of all alcoholic beverages for off-premise consumption only.

### DALLAS COUNTY

A local option election was held on November 5, 1988, in the City of Wilmer, Dalla County, for the issue of "The legal sale of all alcoholic beverages, including mixed beverages." The election failed by a vote of 240 FOR and 383 AGAINST. The City of Wilmer, Dallas County, was "dry" before the election and remains "dry."

## DAWSON COUNTY

A local option election was held on January 31, 1989, in the Town of Los Ybanez, Dawson County, for the issue of "The legal sale of all alcoholic beverages, including mixed beverages." The election passed by a vote of 31 FOR and 3 AGAINST. The Town of Los Ybanez, Dawson County, was "dry" before the election and became "wet" for the legal sale of all alcoholic beverages, including mixed beverages.

### DENTON COUNTY

A local option election was held on May 15, 1989, in the City of Northlake, Denton County, for the issue of "The legal sale of all alcoholic beverages, including mixed beverages." The election failed by a vote of 7 FOR and 28 AGAINST. The City of Northlake, Denton County, was "dry" before the election and remains "dry."

### EASTLAND COUNTY

A local option election was held on November 19, 1988, in the City of Ranger, Eastland County, for the issue of "The legal sale of all alcoholic beverages for off-premise consumption only" for newly annexed area. The election passed by a vote of 3 FOR and O AGAINST. The City of Ranger, Eastland County, was "wet" before the election and will remain "wet" to include the newly annexed area.

#### GLASSCOCK COUNTY

A local option election was held on March 7, 1989, in Justice Precinct 1, Glasscock County, for the issue of "The legal sale of beer and wine for off-premise consumption only." The election passed by a vote of 49 FOR and 4 AGAINST. Justice Precinct 1, Glasscock County, was "dry" before the election and became "wet" for the legal sale of beer and wine for off-premise consumption only.

#### GRAYSON COUNTY

A local option election was held on October 18, 1988, in Justice Precinct 8, Grayson County, for the issue of "The legal sale of all alcoholic beverages for off-premise consumption only." The election passed by a vote of 870 FOR and 763 AGAINST. Justice Precinct 8, Grayson County, was "dry" before the election and became "wet" for legal sale of all alcoholic beverages for off-premise consumption only.

### GRAYSON COUNTY

Alocal option election was held on June 10, 1989, in the City of Pottsboro, Grayson County, for the issue of "To prohibit the sale of all alcoholic beverages for offpremise consumption only." The election failed by a vote of 137 FOR and 172 ASAINST. The City of Pottsboro, Grayson County was "wet" before the election and remains "wet."

### HILL COUNTY

A local option election was held on April 8, 1989, in the City of Abbott, Hill County, for the issue of "The legal sale of all alcoholic beverages for off-premise consumption only." The election passed by a vote of 70 FOR and 23 AGAINST. The City of Abbott, Hill County, was "dry" before the election and became "wet" for the legal sale of all alcoholic beverage for off-premise consumption only.

## HUNT COUNTY

A local option election was held on April 8, 1989, in the City of Greenville, Hunt County, for the issue of "The legal sale of all alcoholic beverages, including mixed beverages." The election failed by a vote of 2,100 FOR and 2,874 AGAINST. The City of Greenville, Hunt County, was "dry" before the election and remains "dry."

### LEON COUNTY

A local option election was held on September 16, 1988, in Justice Precinct 5, Leon County, for the issue of "The legal sale of all alcoholic beverages for off-premise consumption only." The election failed by a vote of 176 FOR and 214 AGAINST. Justice Precinct 5, Leon County, was "dry" before the election and remains "dry."

### LEON COUNTY

A local option election was held on July 21, 1989, in Justice Precinct 5, Leon County, for the issue of "The legal sale of beer and wine for off-premise consumption only." The election failed by a vote of 166 FOR and 200 AGAINST. Justice Precinct 5, Leon County, was "dry" before the election and remains "dry."

## PALO PINTO COUNTY

A local option election was held on October 4, 1988, in the City of Graford, Palo Pinto County, for the issue of "The legal sale of all alcoholic beverages for off-premise consumption only." The election passed by a vote of 86 FOR and 49 AGAINST. The City of Graford, Palo Pinto County, was "dry" before the election and became "wet" for the legal sale of all alcoholic beverages for off-premise consumption.

# Local Option Elections (concluded)

#### PARKER COUNTY

A local option election was held on January 7, 1989, in the City of Willow Park, Parker County, for the issue of "The legal sale of beer and wine for off-premise consumption only." The election failed by a vote of 343 FOR and 533 AGAINST. The City of Willow Park, Parker County, was "dry" before the election and remains "dry."

### POTTER COUNTY

A local option election was held on June 27, 1989, in Justice Precinct 3, Potter County, for the issue of "The legal sale of all alcoholic beverages, including mixed beverages." The election failed by a vote of 866 FOR and 1,279 AGAINST. Justice Precinct 3, Potter County, was "dry" before the election and remains "dry."

## SCHLEICHER COUNTY

A local option election was held on August 22, 1989, in Justice Precinct 2, Schleicher County, for the issue of "The legal sale of beer and wine." The election passed by a vote of 49 FOR and 25 AGAINST. Justice Precinct 2, Schleicher County, was "wet" for the legal sale of all alcoholic beverages for off-premise consumption only before the election and became "wet" for the legal sale of beer and wine.

## UPSHUR COUNTY

A local option election was held on December 10, 1988, in Justice Precinct 5, Upshur County, for the issue of "The legal sale of all alcoholic beverages for off-premise consumption only." The election failed by a vote of 262 FOR and 296 AGAINST. Justice Precinct 5, Upshur County, was "dry" before the election and remains "dry."

### VAN ZANDT COUNTY

A local option election was held on September 6, 1988, in the City of Edgewood, Van Zandt County, for the issue of "The legal sale of all alcoholic beverages for off-premise consumption only." The election failed by a vote of 306 FOR and 332 AGAINST. The City of Edgewood, Van Zandt County, was "dry" before the election and remains "dry."

#### WILBARGER COUNTY

A local option election was held on January 7, 1989 in Justice Precinct 2, Wilbarger County, for the issue of "The legal sale of beer and wine for off-premise consumption only." The election failed by a vote of 44 FOR and 84 AGAINST. Justice Precinct 2, Wilbarger County, was "dry" before the election and remains "dry."
