Trainer Brad Hess, having been duly notified, appeared before the Board of Judges at Valley Race Park on 2/26/2009. A formal hearing was held and as a result Mr. Hess is hereby fined the sum of seven hundred fifty dollars (\$750.00) for racing the following greyhounds with a prohibited substance in their system. "Superior Molly" in the 2nd race,(VG062756), "Won Nite Scandal" in the 3rd race (VG062759) and "Roc A By Alvin" in the 6th race (VG062763) on 01/21/09, as well as "Later Much Stop" in the 6th race (VG062783) and "Slatex Pedro" in the 7th race (VG062787) on 01/22/09 at Valley Race Park. All five samples were found to contain "Salicylate Acid", a class 5 prohibited substance.

All five greyhounds are disqualified and declared unplaced and the purses earned shall be redistributed as follows:
