TDHCA Governing Board to Meet February 1

WHO: Texas Department of Housing and Community Affairs (TDHCA) and the TDHCA Governing Board.

WHAT: The TDHCA Governing Board, chaired by Ms. Elizabeth Anderson, will meet Thursday, February 1, 2007, to discuss several agenda items. The agenda includes the presentation, discussion, and possible approval of:
