State housing agency sending \$2.6 million to Panhandle for needed home repairs

(AUSTIN) — The Texas Department of Housing and Community Affairs (TDHCA) today awarded \$2.6 million in housing funds to eight rural cities and one nonprofit housing organization in the Panhandle region through its HOME Investment Partnerships (HOME) Program. The funds represent a share of \$14.8 million awarded statewide by TDHCA which will significantly help rural Texas improve its stock of existing housing for low income residents.

Award recipients will use the funds to repair or replace 44 deteriorating homes owned and lived in by individuals and families earning no more than 80 percent of the area median family income. Assistance may include roof repair or replacement, as well as repairs to the electrical and plumbing systems. If a home has deteriorated to the point it no longer is cost effective to repair, it may be demolished and replaced either by a traditional "site built" home or a manufactured home.

"These awards will have a dramatic and positive impact on hundreds of rural Texas households, many of them elderly persons and all of them in serious need of help," said Michael Gerber, TDHCA Executive Director. "These are among our state's most vulnerable residents; they don't have the funds to make the necessary repairs themselves, and rural communities so often don't have the resources to help. We are extremely pleased to make this funding commitment to small town Texas."

(AUSTIN) — The Texas Department of Housing and Community Affairs (TDHCA) today awarded \$300,000 in needed home repair funds each to the cities of Gainesville and Palmer through its HOME Investment Partnerships (HOME) Program. The funds represent a share of \$14.8 million awarded statewide by TDHCA which will significantly help rural Texas improve its stock of existing housing for low income residents.

The two cities will use the funds to repair or replace a total of 10 deteriorating homes owned and lived in by individuals and families earning no more than 80 percent of the area median family income. State housing agency sending \$6.9 million to Northeast Texas to bolster single family housing

(AUSTIN) — The Texas Department of Housing and Community Affairs (TDHCA) today awarded \$6.9 million in housing funds to 25 rural cities and counties in Northeast Texas through its HOME Investment Partnerships (HOME) Program. The funds represent a share of \$14.8 million awarded statewide by TDHCA which will significantly help rural Texas improve its stock of existing housing for low income residents.

All but one award recipient will use the funds to repair or replace 113 deteriorating homes owned and lived in by individuals and families earning no more than 80 percent of the area median family income. Home repair assistance may include roof repair or replacement, as well as repairs to the electrical and plumbing systems. If a home has deteriorated to the point it no longer is cost effective to repair, it may be demolished and replaced either by a traditional "site built" home or a manufactured home.

The city of Queen City will use its HOME Program award to assist an estimated 12 qualifying first time homebuyers.
