Trends in Cases Added, Disposed, and Pending per District Court Fiscal Years 2002 through 2006

Population Served per Court

In fiscal year 2006, the average population served per district court in Texas was 52,916 citizens. With more than 92,000 citizens per court, Fort Bend and Denton counties topped the list in terms of highest average population served per court, approximately 75 percent more than the statewide average.

From 2002 to 2006, the statewide average population served per court grew 7.2 percent, despite the creation of seven new district courts during this period. The

Dallas area experienced the greatest growth in population served per court. Rockwall County's population per court rose by one-third, Fort Bend and Collin counties' by more than 20 percent, and Denton and Kaufman counties' by nearly 20 percent. Other areas of significant growth centered around Houston and the San Antonio-Austin area.




While the state's population increased by an average of 1.8 percent per year from fiscal years 2002 through 2006, the number of civil, criminal and juvenile cases

added per district court in Texas increased at a greater rate—an average of 4.2 percent per year—despite the creation of seven new district courts during the same period.

On average, 2,059 cases were added per court per year over the five-year period. In fiscal year 2006, an average of 2,231 cases were added per court.

Harris County had the highest average number of cases added per court per year over the past five years (3,065 cases, 48.9 percent higher than the statewide average),¹ while King County had the lowest (5 cases). Four of the 10 counties with the highest average population per court also ranked in the top 10 for the highest average number of cases added per court per year (Bexar, Bell, Denton, and Harrison counties).

Statewide, the number of civil cases added per court increased by an average of 4.7 percent per year from fiscal year 2002 (1.253 cases) to 2006 (1.363 cases). Harris and E

Criminal Cases

The number of criminal cases added per court increased an average of 2.9 percent per year over the past five years (from 554 cases in 2002 to cases 634 in 2006). Brazos County had the highest average number of criminal cases added per court (1,270 cases) per year over the five-year period.

Juvenile Cases

The number of juvenile cases added per court increased an average of 2.4 percent per year during the five-year period (from 89 cases in 2002 to 94 cases in 2006). Harris County had the


Cases Disposed per Court and Clearance Rates

Overall

The number of cases disposed per court increased by 3.2 percent per year over the past five years. On average, each court disposed of 1,905 cases per year. Bexar County had the highest number of cases disposed per court per year (2,731 cases, 43.4 percent higher than the statewide average), and Loving County had the lowest number (4 cases).

From 2002 to 2006, the overall for clearance rate civil. criminal and juvenile cases averaged 93.6 percent. However, the clearance rate dropped substantially from 95.3 percent in 2004 to 87.7 percent in 2006—the lowest rate seen since 1980 (87.3 percent)—as the number of cases added to the courts' dockets outpaced dispositions and despite the creation of new district courts during the period.



Only 35 percent of counties reported a clearance rate of 100 percent or higher in 2006. Thus, pending caseloads were growing in nearly two-thirds of counties in the state.



2002 to 2006. Statewide, the average clearance rate was 92.7 percent during the five-year period. Camp County had the lowest average clearance rate, with only 66.5 percent cases disposed of per year.

In all of the 10 most populous counties, clearance rates averaged less than 100 percent per year. Tarrant County had the highest average clearance rate at 97.9 percent, while Harris County had the lowest (81.0 percent).



Civil Cases

Statewide, the number of civil cases disposed of per court increased by an average of 2.8 percent per year from 2002 (1,174 cases) to 2006 (1,268 cases). On average, each court disposed of 1,238 civil cases per year. Harrison and Bexar counties had the highest average number of civil cases disposed of per court (2,037 and 2,035 cases, respectively) per year during this period.

Despite the increase in dispositions, the civil case clearance rate dropped substantially from 2002 (93.7 percent) to 2006 (84.3 percent). Kent County had the largest reduction in

civil clearance rates, with an average decrease of 32.4 percent per year.

Half of the 10 largest counties had a positive change in civil clearance rates. Travis County had the greatest average increase (5.8 percent per year), while Harris County had the greatest average decrease (10.5 percent per year).

Criminal Cases

The number of criminal cases disposed of per court increased by an average of 4.3 percent per year from 2002 (526 cases) to 2006 (600 cases). On average,

Hardeman County experienced the largest decrease in criminal clearance rates—an average of 21.3 percent per year.

Among the 10 largest counties, Travis County had the largest average increase in criminal clearance rates (6.8 percent per year), while Hidalgo County had the greatest average decrease (2.6 percent per year).

Juvenile Cases

The number of juvenile cases disposed of per court increased an average of 1.3 percent per year over the past five years (from 87 in 2002 to 88 in 2006). On average, each court disposed of 89 cases per year. Harris County had the highest

average number of juvenile cases disposed of per court (213 cases) per year.

Despite the increase in juvenile dispositions per year, the juvenile case clearance rate decreased 0.8 percent per year since 2002.

Falls County experienced the largest decrease in juvenile clearance rates, with an average decrease of 17.7 percent per year.



Only one of the 10 largest counties had a positive change in juvenile clearance rates.² El Paso County had the largest average increase in juvenile clearance rates (33.0 percent per year), while Travis County had the largest average decrease (5.8 percent per year).

Cases Pending per Court

Overall

From 2002 to 2006, the number of cases pending per court statewide grew an average of 4.8 percent per year. However, in 2006, the number of cases pending per court dropped to 2,116 cases, down from 2,151 pending the previous year.



Van Zandt County had the highest average number of cases pending per court over the fiveyear period, with an average of 4,075 cases pending per vear—nearly double the statewide average. Loving County, on the other hand, had the lowest number of cases pending (5 cases).

Three of the 10 most populous counties had pending caseloads larger than the statewide average.³ Hidalgo County reported the highest number of cases pending per court during the period (3,489 cases – 64.9 percent higher than the statewide average), while Denton County reported the lowest (1,027 cases – 51.5 percent lower than the statewide average). Harris County, however, experienced the fastest growth in its pending caseload, with an average increase of 15.2 percent per year over the past five years.

² No juvenile activity was reported for district courts in Denton and Fort Bend counties for FYs 2002 to 2006.

³ Travis County was not included due to inaccurate data reported for FY 2005.

Civil Cases

Statewide, the number of civil cases pending per court increased an average of 5.0 percent per year from 2002 (1,438 cases) to 2006 (1,691 cases). Van Zandt County had the highest average number of civil cases pending per court per year – 119.0 percent above the statewide average.

King County experienced the largest increase in civil cases pending per court, with an average increase of 13.0 percent per year. The number of cases pending in King County, however, was very small (approximately 5 cases).

Among the 10 most populous counties, El Paso County had the largest increase in its pending caseload (an average of 19.2 percent per year), while Dallas County had the largest decrease (an average of 5.4 percent per year).

Criminal Cases

The number of criminal cases pending per court increased an average of 4.3 percent per year over the five-year period (from 487 cases in 2002 to 557 cases in 2006). Stephens County had the largest average number of criminal cases pending per court per year – 239.1 percent above the statewide average.

Atascosa County experienced the largest increase in criminal cases pending per court, with an average increase of 53.0 percent per year.

Among the 10 most populous counties, Fort Bend County had the largest increase in its pending caseload (an average of 10.7 percent per year), while Hidalgo County had the largest decrease (an average of 3.7 percent per year).

Juvenile Cases

Statewide, the number of juvenile cases pending per court increased an average of 1.4 percent per year over the past five years. Dallas County had the highest average number of juvenile cases pending per court per year—176 cases, 274.5 percent above the statewide average.

Comal County experienced the greatest increase in juvenile cases pending per court, with an average increase of 564.4 percent per year (due to a large increase from fiscal year 2003 (15 cases) to 2004 (133 cases) in cases pending at the end of the fiscal year).

Of the 10 most populous counties, only two counties reported a decrease in their pending caseloads. Hidalgo County had the largest increase in its pending caseload (an average of 16.9 percent per year), while Harris County had the largest decrease (an average of 12.7 percent per year).
