#### INSTRUCTIONS FOR FILING A PETITION FOR TELECOMMUNICATIONS SERVICE IN UNCERTIFICATED AREAS

A petition consists of five parts: (1) Cover page and contact information; (2) Petitioner(s) information; (3) Affidavit (if fewer than 5 petitioners); (4) Description and location of premises; and (5) Carrier nominations. Questions about filing the petition should be directed to Central Records. Questions about the contents of the petition should be directed to the Telecommunications Division at (512) 936-7320. All petitions must be filed in accordance with the Commission's Procedural Rules, which can be found on the Commission's web site at www.puc.state.tx.us. A copy of the Rules may also be obtained by contacting Central Records.

The Public Utility Regulatory Act (PURA), Texas Utilities Code Annotated (Vernon 1998, Supp. 2002) §§ 56.001, 56.021, and 56.023 and PUC Substantive Rules § 26.421 and §26.422 require that the petitioner(s):

- not be members of the same household;
- reside in the permanent residential premises or are the owners of the permanent residential or business premises for which service is sought;<sup>1</sup>
- desire service to those premises;
- commit to pay the aid to construction charges for service to those premises as determined by the commission; and
- commit to enter into an assignable agreement for subscription to basic local service to the premises for a period of time determined by the commission.

The petitioner(s) must answer all of the questions on the petition in a truthful manner, and must promptly notify the Commission of any substantive changes in the information by filing an original and six copies of any changes with the Commission's Filing Clerk and referencing the docket number assigned to the petition.

This petition is a format, not a form. You may add or drop lines as necessary to meet the petitioning requirements. Failure to provide complete, truthful, or responsive answers to all requested questions may result in denial or delay in the processing of the petition. An answer of "Not Applicable" or "N/A" is considered non-responsive and must be avoided. Do not file the instructions with the petition.

### PART FOUR – DESCRIPTION AND LOCATION OF PREMISES

1.	Identify and describe each premises as one of the following: Permanent Resident (PR); Business Premises (BP); Owner Only (does not reside or conduct business at premises) (OO); or Renter Only (RO).

4.	Provide an explanation why the petitioner(s) believes that the premises are within reasonable proximity to one another for the establishment of a community of interest.

The nominated telecommunications providers must serve territory that is next to the locations of the permanent residential or business premises. No more than five potential telecommunications providers may be nominated.
