PGA	The above rates do not include gas costs. This clause shall apply to all customers. Gas costs are added to the monthly customer charge with the commodity charges. Gas costs shall be calculated and multiplying that number by each customer's consumption for each billing period. D&H Gas Company shall compute the total amount paid for gas and the total amount of gas cost received from customers each quarter. If the amount received from customers is higher than the amount paid to the supplier, the company shall refund the difference over the next three months. If the amount of gas cost collected is lower than the amount paid to the supplier, the company shall collect the difference through a surcharge over the next three months. D&H Gas Company shall calibrate its check meter annually and submit reports of that calibration to the Commission. Rate Case Surcharge	A .30 cents per MCF surcharge shall be added to each monthly bill until approved rate case expenses totaling \$4.333 have been recovered. D&H Gas Company shall report quarterly the amount collected under this surcharge. This surcharge shall apply to all customers.
Surcharges	An additional .10 cents per MCF surcharge, plug interest at 6%, shall be added to each monthly bill to make the above rates effective October 28, 1998. D&H Gas Company shall calculate the total amount due to establish the total revenue to be collected by D&H Gas Company through this surcharge, including interest at 6%. D&H Gas Company shall report quarterly the amounts charged and collected under this surcharge along with the Purchased Gas Adjustment quarterly reports. D&H Gas Company shall submit quarterly reports detailing the amount to be collected, the volumes sold to its customers, the amount of interest at 6% per annum charged in this surcharge account, the amount passed through to its customers, and the revenues to be collected. This surcharge shall apply to all customers.
Prompt Payment Prov.	The net charges stated above shall be applicable if the bill is paid within the ten (10) days after the bill is mailed. For bills paid after ten (10) days, the the gross charges will apply.
