The \$.45 mcf gathering fee is based on the condition that gatherer will receive 14.5 bcf into its system within five years from the date of first deliveries into the system. Progress towards such five year benchmark of 14.5 bcf will be measured every six months against the rate of 1.45 bcf per six month period. If the aggregate quantity of gas received into the system from all sources during any successive six month period (commencing with the first complete month in which deliveries of gas commenced) is less than 1.45 bcf, the initial gathering fee shall be proportionately increased for the next succeeding six month period by the amount required to make up the monetary short fall in the previous six months benchmark; provided, however, in no event will the gathering fee be increased beyond \$.90 per mcf and further, the gathering fee shall be or not be decreased below \$.45 per mcf until the earlier of (1) or (2) mentioned herein occurs.
