#### The following rule changes were effective March 1, 2008.

#### **Inclusive Care**

The purpose of this change is to support the inclusive care of children with special needs in child-care operations. The changes modify the health statement required for a child at admission, ensure directors training requirements include serving children with special needs, and require permit holders to report substantiated Department of Justice (DOJ) complaints related to Americans with Disabilities Act (ADA)

§746.1311. How many clock hours of training must my child-care center director obtain each year?

### **Pest Control**

§746.3427 is amended to add a reference the Texas Department of Agriculture, because the Texas Structural Pest Control Board has been transferred to the Texas Department of Agriculture, as required by House Bill 2458 of the 80th Legislature. Appendix IX is revised for the same reason, and to update the statutory citation of the Texas Structural Pest Control Act.

§746.3427. Must I use a licensed exterminator to treat my child-care center for insects, rodents, and other pests?

# The following rule changes were effective June 1, 2008.

# **Background Checks**

Appendix IV, Background Checks, is revised to reflect rule changes that:

- implement new fingerprint-based criminal history checks against the Department of Public Safety (DPS) and Federal Bureau of Investigation (FBI) databases for children in child care, including new fingerprint-based criminal history checks required by amendments to §42.056, Human Resources Code, that were enacted in Senate Bill 758, 80th Legislative Session, and new fingerprint-based criminal history checks required by the federal "Adam Walsh Child Protection and Safety Act of 2006" (the Adam Walsh Act);
- expand the list of criminal convictions that may be used to prevent a person from having access to children in care; and
- clarify terminology and amend certain procedures relating to the background check and risk evaluation processes;

The changes will not only bring Child Care Licensing (CCL) rules in compliance with state and federal law, but will significantly enhance protections for children in child care by identifying certain persons with criminal histories or child abuse or neglect findings that are not identified under the current background check process and ensuring that such persons do not pose a risk to children in care. In addition, these changes, which will necessitate the use of fingerprint-based criminal history checks, will reduce the incidence of "false positive" matches, that sometimes result from name-based criminal history checks, and cause delays in hiring qualified applicants in child-care operations.
