## **Cosmetology Instructor Exam Application Instructions**

To be eligible for an examination, you must submit the following:

- 1. Application License Fee of \$70
- 2. Completed Application
- 3. Copy of current License
- 4. Certified Transcript of hours from state in which the current license was issued

Note: You must contact the state in which your current license was issued and request that they send the certified transcript of hours either to you, or to the Texas Department of Licensing and Regulation.

To expedite the process, contact the reciprocal state for a certified transcript of hours and have them mail the transcript to your address. Once you receive the transcript, submit all of this information (along with your completed application) to the Department in one envelope. NOTE: The certified transcript of hours MUST remain in the sealed envelope from the other state.

Always keep your mailing address current with the Texas Department of Licensing and Regulation. A license renewal notice will be mailed to your address of record prior to the date that your license will expire.

#### Note:

The Department will add your email address to the Cosmetology email notification list, which automatically provides information from the Department on matters affecting cosmetology. Your email address is confidential pursuant to the Texas Public Information Act and the Department will not share it with the public.
