## SUMMARY OF REPORTED ACTIVITY FOR YEAR ENDED AUGUST 31, 2003

The Alternative Dispute Resolution Centers of Texas were reauthorized and expanded in scope in 1987 by the 70<sup>th</sup> Legislature "to encourage the peaceable resolution of disputes, with special consideration given to disputes involving the parent-child relationship, and the early settlement of pending litigation through voluntary settlement procedures." (Acts 1987, 70<sup>th</sup> Legislature, Chapter 1121, Section 1.) Alternative Dispute Resolution Centers provide an opportunity to resolve conflicts creatively and effectively outside the courtroom using a variety of mechanisms including mediation, arbitration, negotiation, and moderated settlement conferences.

Eleven of the 14 centers submitted reports for the period of September 1, 2002 through August 31, 2003. (Note: This summary does not include data from judges, court clerks, private groups, and other organizations that actively employ alternative dispute resolution procedures, but do not formally report associated statistics.)
