



CHILD SUPPORT EVADER KURT LINDNER

your help locating Child Support Evader Kurt Lindner, one of the Most Wanted Child Support Evaders in Texas.

Lindner, who was added to the Child Support Evader's list in December 2005, owes \$34,309 for the care of a daughter from Abilene.

In March 1993, Lindner was ordered to pay \$250 a month in child support. By the next year, he had fallen more than \$3,000 behind on his payments. A Taylor county judge found Lindner in contempt of court and gave him a jail sentence that was immediately suspended because Lindner agreed to work and begin making regular child support payments.

Lindner did not honor his agreement to start providing for his young daughter. After being given many opportunities to pay what he owed, Lindner's driver's license was suspended. Even

that drastic action failed to force his compliance, and by October 2000, Lindner owed more than \$7,000. An arrest warrant was issued after Lindner failed to appear at a February 2002 court hearing.

Kurt Lindner has not made a single child support payment in eight years. By refusing to provide the financial resources his daughter needs, Lindner has turned his back on her and violated the law. A combination of missed payments and interest that accrues on unpaid child support adds up to more than \$34,000 Lindner now owes.

Investigators from the Office of the Attorney General have searched the state for Lindner, whose last known address was in Abilene. He could be working for cash to avoid garnishment of wages to pay child support. Incarceration is the only option for parents who flagrantly ignore a court's order to pay child support. POINTS TO REMEMBER



MOST WANTED EVADERS

For a parent to be named as a Most Wanted Child Support Evader:

- Court-ordered delinquent support must be in excess of \$5,000
- Arrest warrant must have been issued for non-support
- Location of noncustodial parent is unknown
- Parent has not made any payments in the last six months
- Noncustodial parent must not be involved in bankruptcy proceedings
- Noncustodial parent must not be receiving welfare benefits

In order to make child support information public, the custodial parent must sign a confidentiality waiver.
