Accident Prevention Services

Conducts inspections to determine adequacy of insurance companies' accident prevention services

- Evaluates plans of insurance companies seeking initial license to write workers' compensation insurance
- Conducts policyholder job-site visits

Safety Violations Hotline

Allows employees to report workplace safety violations to 24-hour toll-free line

- Accepts calls in English or Spanish (se habla Espanol)
- Accepts anonymous calls
- Investigates alleged violations to eliminate possible hazards
- Prohibits employers by law from taking action against callers

- Conducts the following Bureau of Labor Statistics Programs:
 - Annual Survey of Occupational Injuries and Illnesses
 - Census of Fatal Occupational Injuries (CFOI)
- Administers Job Safety Information Systems (JSIS)
- Conducts claims-based data analysis
- Collects data for the OSHA Data Initiative
