CHAPTER 381

H.B. No. 1235

An Act relating to the conveyance of the state's reversionary interest in certain real property in Bexar County.

Be it enacted by the Legislature of the State of Texas:

SECTION 1. The board of regents of The University of Texas System may sell and convey to the city of San Antonio, for a consideration the board considers appropriate, the reversionary interest of the state in two tracts of land described in Section 2 of this Act. The city of San Antonio will be bound by any deed restrictions of record placed on the land by the original donors of the land.

SECTION 2. The two tracts of land that are subject to the reversionary interest the board of regents may sell and convey by authority of Section 1 of this Act are described as follows: TRACT 1:

A tract of land out of Brackenridge Park, part of San Antonio Water Works Company deed to City of San Antonio. Volume 185 - Page 183 (November 20, 1899) San Antonio, Texas, Bexar County, consisting of 113.609 acres, more or less, surveyed as described below:

From an iron pin being the southest corner of Lions Field, NCB 6297, north 57 deg. 07 min. 00 sec. west a distance of 250 feet to the point of beginning of the boundary line of Brackenridge Golf Course;

- THENCE along a northerly line as follows: (a) north 34 deg. 36 min. 31 sec. east a distance of 33.91 feet,
- (b) north 34 deg. 00 min. 11 sec. east a distance of 121.88 feet to the PLACE OF BEGINNING.

TRACT 2:

A tract of land out of Mahncke Park Property, San Antonio Texas, recorded in Volume 238 -Page 191, Bexar County, consisting of 31.96 acres, more or less, surveyed as described below: From the northeast corner of NCB 7186 bearing north 11 deg. 55 min. east a distance of 51.10 feet to the point of BEGINNING at the southeast corner of said park property;

THENCE along a northerly line as follows:

SECTION 3.
