CHAPTER 729

H.B. No. 1585

An Act relating to the review and abolition of certain state agencies under the Texas Sunset Act.

Be it enacted by the Legislature of the State of Texas:

SECTION 1. Chapter 45, Human Resources Code, is amended by adding Section 45.027 to read as follows:

Sec. 45.027. APPLICATION OF SUNSET ACT. The office of administrator of the Interstate Compact on the Placement of Children is subject to the Texas Sunset Act (Article 5429k, Vernon's Texas Civil Statutes). Unless continued in existence as provided by that Act, the office is abolished and this subchapter expires September 1, 1987.

SECTION 2. Chapter 181, Natural Resources Code, is amended by adding Section 181.020 to read as follows:

Sec. 181.020. APPLICATION OF SUNSET ACT. The Texas Conservation Foundation is subject to the Texas Sunset Act (Article 5429k, Vernon's Texas Civil Statutes). Unless continued in existence as provided by that Act, the foundation is abolished and this chapter expires September 1. 1987.

SECTION 3. Section 75.029, Human Resources Code, is amended to read as follows:

- (5) Section 1a, Chapter 324, Acts of the 51st Legislature, Regular Session, 1949 (Article 5429b, Vernon's Texas Civil Statutes);
- (6) Section 1a, Chapter 487, Acts of the 51st Legislature, Regular Session, 1949 (Article 5429c, Vernon's Texas Civil Statutes);
- (7) Section 2a, Chapter 55, Acts of the 61st Legislature, Regular Session, 1969 (Article 5444a, Vernon's Texas Civil Statutes);
- (8) Section 1a, Chapter 807, Acts of the 61st Legislature, Regular Session, 1969 (Article 6145-7, Vernon's Texas Civil Statutes).
- SECTION 55. If H.B. 2091, 69th Legislature, Regular Session, 1985, does not become law, Section 1.03, Article 4414b, Revised Statutes, is amended to read as follows:
- Sec. 1.03. APPLICATION OF SUNSET ACT. The Texas Board of Health and the Texas Department of Health are subject to the Texas Sunset Act [; as amended] (Article 5429k, Vernon's Texas Civil Statutes). *Unless* [; and unless] continued in existence as provided by that Act, the board and the department are abolished [effective] September 1, 1987 [1985].
- SECTION 56. Subsection (d), Section 4, Private Investigators and Private Security Agencies Act (Article 4413(29bb), Vernon's Texas Civil Statutes), is amended to read as follows:
- (d) The Texas Board of Private Investigators and Private Security Agencies is subject to the Texas Sunset Act, as amended (Article 5429k, Vernon's Texas Civil Statutes); and unless continued in existence as provided by that Act the board is abolished, and this Act expires [effective] September 1, 1987 [1903].
- SECTION 57. Subsection (n), Section 50.004, Human Resources Code, is amended to read as follows:
- (n) The council is subject to the Texas Sunset Act, as amended (Article 5429k, Vernon's Texas Civil Statutes). Unless continued in existence as provided by that Act, the council is abolished and this section expires effective September 1, 1989 [1087]. If the council is continued in existence beyond that date, subsequent sunset provisions should be made to conform with those of the Texas Department of Human Resources.

SECTION 58. This Act takes effect September 1, 1985.

SECTION 59. The importance of this legislation and the crowded condition of the calendars in both houses create an emergency and an imperative public necessity that the constitutional rule requiring bills to be read on three several days in each house be suspended, and this rule is hereby suspended.
