All units to which these decals are to be affixed must meet the requirements of the mandatory state codes and standards in effect at the time of manufacture. The manufacturer is responsible for placing the assigned decal number on a module of the proper size, i.e., square feet. Only certified manufacturers may purchase decals. Decals may not be transferred from one Texas registered and certified manufacturer to another Texas registered and certified manufacturer without prior written approval from the Department.
