If you want decals shipped overnight, please include a COMPLETED return air bill with your order. The return air bill shall be completed with your account number and the name and address of the TPIA or TPI to receive the decals. Your order will be shipped overnight at your expense.					
Alteration and recertification of the units to which these decals are to be affixed must be in compliance with the requirements of the mandatory building codes and standards in effect at the time the alterations are completed. Only registered industrialized builders may purchase alteration decals. Decals will be released only to the third party inspection agency/third party inspector responsible for inspecting the alteration construction. The third party inspector is responsible for placing the assigned decal on each module upon completion of the construction and successful completion of all required inspections.					
Please indicate the name and registration # of the TPIA responsible for completing the alteration inspections. The decals will be released only to the TPIA or to a TPI employed by the TPIA. The decals will be released only to the mailing address of the TPIA or TPI on file with the Department.
