H.B. No. 1719

AN ACT

making appropriations for and directing payment of certain miscellaneous claims and judgments out of funds designated herein; requiring approval of the claims in the manner specified in this Act before payment is made.

SECTION 21. It is specifically provided that before any claim or judgment shall be paid from funds hereby appropriated, the same shall be verified and substantiated by the administrator of the special fund or account against which the claim is to be charged, and have the approval of the attorney general and the comptroller of public accounts. It is further provided that any claim or judgment itemized in this bill which has not been verified and substantiated by the administrator of the special fund or account and approved by the attorney general and the comptroller of public accounts by August 31, 1994, shall not be paid from funds appropriated. It is further provided that each claim must contain such information as required by the comptroller, but at a minimum must contain the specific reason for the claim. If the claim is for a void warrant, the claim must include a specific identification of the goods, services, refund, or other item for which the warrant was originally issued. In addition, it must include the original payee's or its successor, heirs, or assigns certification that the debt is still outstanding. If the claim is for unpaid goods or services, it must be accompanied by an invoice or other acceptable documentation of the unpaid account and any other information that may be required by the comptroller.

SECTION 22. Subject to the conditions and restrictions in this Act and provisions stated in the judgments, the comptroller is hereby authorized and directed to issue a warrant or warrants on the state treasury, as soon as possible following the effective date of this Act, in the favor of each of the said persons, firms, or corporations named herein, in an amount not to exceed the amount set opposite their respective names and shall mail or deliver to each of the said persons, firms, or corporations warrant or warrants in payment of the said claim or claims.

SECTION 23. This Act shall take effect September 1, 1993.

SECTION 24. The importance of this legislation and the crowded condition of the calendars in both houses create an emergency and an imperative public necessity that the constitutional rule requiring bills to be read on three several days in each house be suspended, and this rule is hereby suspended.

Passed by the House on May 7, 1993, by a non-record vote; the House refused to concur in Senate amendments on May 28, 1993, and requested the appointment of a conference committee to consider the differences between the two houses; the House adopted the conference committee report on May 30, 1993, by a non-record vote; passed subject to the provisions of Article III, Section 49a, of the Constitution of the State of Texas; passed by the Senate, with amendments, on May 26, 1993, by a viva-voce vote; at the request of the House, the Senate appointed a conference committee to consider the differences between the two houses; the Senate adopted the conference committee report on May 30, 1993, by a viva-voce vote; passed subject to the provisions of Article III, Section 49a, of the Constitution of the State of Texas.
