

CHAPTER 1124

S.B. No. 1517

AN ACT

relating to the administration of certain judicial districts.

*Be it enacted by the Legislature of the State of Texas:*

SECTION 1. Subchapter C, Chapter 24, Government Code, is amended by adding Section 24.506 to read as follows:

*Sec. 24.506. 361ST JUDICIAL DISTRICT (BRAZOS COUNTY). (a) The 361st Judicial District is composed of Brazos County.*

*(b) The terms of the 361st District Court begin on the first Mondays in April and October.*

SECTION 2. Subsection (c), Section 32.021, Government Code, is amended to read as follows:

(c) The Commissioners Court of Brazos County shall pay the *judges* [judge] of the 272nd and 361st judicial districts [Judicial District] a supplemental salary in an amount equal to the supplement paid by the county to the other district judge in the county.

SECTION 3. Section 24.188, Government Code, is amended to read as follows:

*Sec. 24.188. 86TH JUDICIAL DISTRICT (KAUFMAN COUNTY [AND ROCKWALL COUNTIES]). (a) The 86th Judicial District is composed of Kaufman County [and Rockwall counties].*

*(b) The terms of the 86th District Court begin[:*

*[1] in Kaufman County] on the first Mondays in February and July[; and*

*[2] in Rockwall County on the first Mondays in April and October].*

SECTION 4. Section 24.500, Government Code, is amended to read as follows:

Sec. 24.500. 354TH JUDICIAL DISTRICT (HUNT, [~~AND~~] RAINS, AND ROCKWALL COUNTIES). (a) The 354th Judicial District is composed of Hunt, [~~and~~] Rains, and Rockwall counties.

(b) Section 24.108, relating to the 8th District Court, contains provisions applicable to both that court and the 354th District Court.

SECTION 5. Section 3.155, Judicial Districts Act of 1969 (Article 199a, Vernon's Texas Civil Statutes), as added by Section 1, Chapter 957, Acts of the 69th Legislature, Regular Session, 1985, is repealed.

SECTION 6. The importance of this legislation and the crowded condition of the calendars in both houses create an emergency and an imperative public necessity that the constitutional rule requiring bills to be read on three several days in each house be suspended, and this rule is hereby suspended, and that this Act take effect and be in force from and after its passage, and it is so enacted.

Passed the Senate on May 21, 1987, by the following vote: Yeas 30, Nays 0; and that the Senate concurred in House amendment on June 1, 1987, by the following vote: Yeas 31, Nays 0. Passed the House, with amendment, on May 29, 1987, by the following vote: Yeas 138, Nays 0, two present not voting.
