

CHAPTER 1070

S.B. No. 784

AN ACT

relating to changing the name of North Texas State University to University of North Texas.

Be it enacted by the Legislature of the State of Texas:

SECTION 1. The name of North Texas State University is changed to University of North Texas. All references to and appropriations for North Texas State University apply to University of North Texas.

SECTION 2. Section 51.001, Education Code, as amended, is amended to read as follows:

Sec. 51.001. INSTITUTIONS TO WHICH APPLICABLE. Subject to Section 51.008 of this code, the provisions of this subchapter apply to:

- (1) each institution and branch of The University of Texas System;
- (2) each institution, agency, and service of The Texas A&M University System;
- (3) Texas A&I University;
- (4) Texas Tech University;
- (5) East Texas State University;
- (6) *University of North Texas* [~~State University~~];
- (7) Sam Houston State University;
- (8) Stephen F. Austin State University;
- (9) Southwest Texas State University;
- (10) Sul Ross State University;
- (11) West Texas State University;
- (12) Texas Eastern University; and
- (13) each public junior college to the extent possible.

SECTION 3. Subdivision (3), Section 59.01, Education Code, as amended, is amended to read as follows:

(3) "Board" means the board of regents of The University of Texas System, the board of regents of The Texas A&M University System, the board of regents of Texas Tech University, or the board of regents of *the University of North Texas* [~~State University~~].

SECTION 4. Subdivision (3), Section 61.003, Education Code, as amended, is amended to read as follows:

(3) "General academic teaching institution" means The University of Texas at Austin; The University of Texas at El Paso; The University of Texas of the Permian Basin; The University of Texas at Dallas; The University of Texas at San Antonio; Texas A&M University, Main University; The University of Texas at Arlington; Tarleton State College; Prairie View Agricultural and Mechanical College; Texas Maritime

Academy; Texas Tech University; *University of North Texas* [~~State University~~]; Lamar University; Texas A&I University; Texas Woman's University; Texas Southern University; Midwestern University; University of Houston; Pan American University; East Texas State University; Sam Houston State University; Southwest Texas State University; West Texas State University; Stephen F. Austin State University; Sul Ross State University; Angelo State University; Tyler State College; and any other college, university, or institution so classified as provided in this chapter or created and so classified, expressly or impliedly, by law.

SECTION 5. Subsection (a), Section 62.021, Education Code, is amended to read as follows:

(a) Each fiscal year, an eligible institution is entitled to receive an amount allocated in accordance with this section from funds appropriated by Article VII, Section 17(a), of the Constitution of Texas. The comptroller of public accounts shall distribute funds allocated under this subsection only on presentation of a claim and issuance of a warrant in accordance with Article 4357, Revised Statutes. The comptroller may not issue a warrant from any funds allocated under this subsection before the delivery of goods or services described in Section 17, Article VII, Texas Constitution, except for the payment of principal or interest on bonds or notes. The allocation of funds under this subsection is made in accordance with an equitable formula consisting of the following elements: space deficit, facilities condition, institutional complexity, separate allocation for medical units, and additional allocation for compliance with the Texas Desegregation Plan. The amounts allocated by such formula are as follows:

\$ 3,603,059	University System of South Texas System Administration and the following component institutions: Corpus Christi State University; Laredo State University; Texas A&I University; and
\$ 2,263,930	West Texas State University.

SECTION 6. Section 70.05, Education Code, is amended to read as follows:

Sec. 70.05. PROGRAMS AT OTHER UNIVERSITIES. It is the intent of the legislature that existing programs leading to undergraduate and graduate degrees at *the University of North Texas* [~~State University~~], Texas Woman's University, East Texas State University, and The University of Texas at Arlington shall never be placed at a disadvantage, curtailed, or restricted from orderly and proper expansion for any cause attributable to the establishment of, or the curricular objectives for, The University of Texas at Dallas; and that these universities shall not, as a result of the establishment of The University of Texas at Dallas, be handicapped in realizing their full potentials in quantity or quality for developing additional undergraduate and graduate programs which may from time to time be authorized by the coordinating board.

SECTION 7. The title to Chapter 105, Education Code, is amended to read as follows:

CHAPTER 105. *UNIVERSITY OF NORTH TEXAS* [~~STATE UNIVERSITY~~]

SECTION 8. Section 105.01, Education Code, is amended to read as follows:

Sec. 105.01. *UNIVERSITY OF NORTH TEXAS* [~~STATE UNIVERSITY~~]. *The University of North Texas* [~~State University~~] is a coeducational institution of higher education located in the city of Denton.

SECTION 9. Subsections (b) and (c), Section 105.43, Education Code, are amended to read as follows:

(b) The activities of the student union financed in whole or in part by the student union fee shall be limited to those activities in which the entire student body is eligible to participate and in no event may any of the activities so financed be held outside of the territorial limits of the campus of *the University of North Texas* [~~State University~~].

(c) The fiscal officer of *the University of North Texas* [~~State University~~] shall collect the fees provided for in Subsection (a) of this section and shall credit the money received from those fees to an account known as the student union fee account.

SECTION 10. Section 105.61, Education Code, is amended to read as follows:

Sec. 105.61. DESIGNATION. The historical collection of the university, consisting of books, documents, stamps, coins, firearms, implements of warfare, relics, heirlooms, and other items of historical importance, is designated a State Historical Collection, to be known as "The State Historical Collection of *the University of North Texas* [~~State University~~]."

SECTION 11. Section 105.71, Education Code, is amended to read as follows:

Sec. 105.71. ESTABLISHMENT OF COLLEGE OF OSTEOPATHIC MEDICINE. (a) There is hereby created a college of osteopathic medicine in the city of Fort Worth to be known as the Texas College of Osteopathic Medicine, a separate institution and not a department, school, or branch of *the University of North Texas* [~~State University~~], but under the direction, management, and control of the Board of Regents of *the University of North Texas* [~~State University~~].

(b) The board shall have the same powers of direction, management, and control over the college of osteopathic medicine that it exercises over *the University of North Texas* [~~State University~~], but the board shall act separately and independently on all matters affecting the college of osteopathic medicine as a separate institution.

SECTION 12. Section 105.74, Education Code, as amended, is amended to read as follows:

Sec. 105.74. CHIEF EXECUTIVE OFFICERS. The board of regents of *the University of North Texas* [~~State University~~] may appoint a chancellor who shall serve as chief executive officer of *the University of North Texas* [~~State University~~] and the Texas College of Osteopathic Medicine. The board of regents shall appoint a president of *the University of North Texas* [~~State University~~] and a president of the Texas College of Osteopathic Medicine who shall serve as chief operating officers of each institution, respectively. The president of the Texas College of Osteopathic Medicine shall be a

SECTION 13. This Act takes effect May 15, 1988.

SECTION 14. The importance of this legislation and the crowded condition of the
